## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
KBS, Inc. Profit Sharing Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of KBS, Inc. Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Notes to Financial Statements

**1. Description of Plan:**

The following description of the KBS, Inc. Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of KBS, Inc. (the "Company") who have worked at least three months and are age eighteen or older. An employee may participate in the Plan on the first day of the next Plan quarter following the date the employee met the eligibility requirements to make elective deferrals and one year for the employer matching and profit-sharing contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pretax and after-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company matches 100 percent up to a 3 percent deferral and 50 percent between 3 and 10% percent. Participants direct all contributions into various investment options offered by the Plan.

Participants of qualifying age may make additional "catch-up" contributions, subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and the Company safe harbor match plus actual earnings thereon. Vesting in the Company's discretionary contributions, plus actual earnings thereon, is based on years of continuous service. A participant is vested in the Company's contributions 20% after two years, 40% after three years, 60% after four years, 80% after five years and 100% after six years of credited service.

**Investment Options:** Participants may direct Empower Trust Company, LLC for the period from October 1, 2022 through February 28, 2023, Fidelity Workplace Services LLC, a subservice organization of Fidelity Management Trust Company from February 28, 2023 to September 30, 2024, and Ohio National Life Insurance Company, for the period October 1, 2022 through February 28, 2023, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The notes receivable are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants that the Plan administrator considers to be in default, are classified as distributions based upon the terms of the plan document.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by a third-party administrator. Two Company employees serve as the co-trustees and are not compensated by the Plan for these services.

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment or installments over a period not more than the assumed life expectancy equal to the vested value of his or her account.

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions or pay administrative expenses. Increases to Plan forfeitures were \$6,859 for 2024 and \$90,806 for 2023. Forfeitures of \$18,794 were used to offset employer matching contributions in 2024. In 2024, \$20,563 of forfeitures was refunded to the prior recordkeeper. No forfeitures were used to offset employer matching contributions in 2023. Forfeitures of \$19,262 and \$64,456 were used to pay Plan expenses in 2024 and 2023, respectively. Forfeited balances available at September 30, 2024 and 2023 totaled \$32,824 and \$84,584, respectively.

**2. Summary of Significant Accounting Policies:**

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Guaranteed Investment Contract:** Investment contract held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**2. Summary of Significant Accounting Policies, Continued:**

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through June 4, 2025, the date the financial statements were available to be issued, and has determined there are no subsequent events to be reported in the accompanying financial statements.

**3. Fair Value Measurements:**

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**3. Fair Value Measurements, Continued:**

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value:

**Money market:** Valued at the cash balance, which approximates fair value.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trust:** Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no assets or liabilities whose fair value was determined using Level 2 or Level 3 inputs at September 30, 2024 and 2023.

**4. Group Annuity Investment Contract with Insurance Company:**

The Plan was invested into a group annuity contract with Ohio National Life Insurance Company. Effective February 28, 2023, the Ohio National Life investment was transferred to the Lincoln Stable Value Account, a group fixed annuity issued by the Lincoln National Life Insurance Company. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting interest rate was 1% and 3% in 2024 and 2023 respectively. The group annuity investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Ohio national Life Insurance Company and the Lincoln National Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**4. Group Annuity Investment Contract with Insurance Company, Continued:**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

**5. Administrative Expenses:**

The Plan paid administrative fees in the amount of \$114,152, which represented \$19,262 of Plan forfeitures applied to Plan expenses during 2024. The Plan paid administrative fees in the amount of \$64,456, which represented \$64,456 of Plan forfeitures applied to Plan expenses during 2023. A forfeiture credit was applied to offset Plan expenses during 2023. Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Company.

**6. Related-Party Transactions:**

Plan investments were managed by Empower Trust Company, LLC from October 1, 2022 through February 23, 2023, and Ohio National Life Insurance Company from October 1, 2022 through February 23, 2023. Effective February 23, 2023, Plan investments are managed by Fidelity Workplace Services, LLC, an affiliate organization of Fidelity Management Trust Company. These are related-party transactions and are identified as a parties-in-interest in the accompanying schedule of assets (held at year end) for investment purposes. The Plan investments have internal expenses that compensate each party.

**7. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**8. Tax Status:**

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at September 30, 2024 and 2023. The Plan is not currently under any audit by any tax jurisdiction.

**9. Risks and Uncertainties:**

The Plan provides for various investments in mutual funds, a common/collective trust and a group annuity contract. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

**10. Financial Information Certified by a Qualified Institution:**

Empower Trust Company, LLC, custodian of the Plan for the period from October 1, 2022 through February 28, 2023, Ohio National Life Insurance Company, custodian of the Plan for the period October 1, 2022 through February 28, 2023, and Fidelity Management Trust Company, custodian of the Plan from February 28, 2023 to September 30, 2024 have certified that the following information is complete and accurate:
