- A. **EFFECTIVE DATE** -January 1, 1973. The Plan was last amended effective January 1, 2012.
- B. **ELIGIBILITY** - Employee participates on the first of the month following attainment of age 21 and the completion of one year of service.
- C. **NORMAL RETIREMENT** - First day of the month coincident with or next following the 65<sup>th</sup> birthday. Annual pension is the sum of a part for part service and a part for future service. The past service part is 1 1/2% of the annual rate of pay on January 1, 1973 multiplied by service before January 1, 1973. The future service part is 1.45 % of AFC multiplied by service after January 1, 1973.  
Average Final Compensation (AFC): the average annual total compensation for the highest five consecutive years of service in the last 10 years of service.  
Plan benefits were frozen as of April 1, 2007.
- D. **EARLY RETIREMENT** - After age 60 with 10 years of vesting service. The benefit is the normal retirement benefit, but based on AFC and service at the date of early retirement. Benefit is reduced by 1/2% for each month by which the starting date precedes age 65.
- E. **DISABILITY** - After age 45 with 10 years of vesting service. The benefit is the normal retirement benefit, but based on AFC and service at the date of disability.

F. **TERMINATION** - 100% vested right after 5 years of vesting service. The benefit is the normal benefit, but based on AFC and service at the date of vested termination.

G. **DEATH BENEFITS** -

- (i) *Before Retirement* - If the participant has a vested right but has not attained age 60, the spouse receives pension for life commencing at the employee's 60th birthday equal to one-half the amount the participant would have received if he terminated on his date of death, survived until age 60, retired at age 60 with the joint and 50% survivor option in effect. If the participant has attained age 60, the spouse receives a pension for life equal to one-half the amount the participant would have received if he retired early on his date of death and elected a joint and 50% survivor option.
- (ii) *After Retirement* - Normal form is life annuity, but if the employee has a spouse, this standard benefit is automatically converted to a reduced joint and 50% survivor option unless the employee elects not to have such conversion take place.
