**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Systel Business Equipment Co., Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. #### NOTE A – PLAN DESCRIPTION

The following description of the Systel Business Equipment Co., Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information concerning the operation of the Plan. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Systel Business Equipment Co., Inc. (the “Company”). The Plan allows employees who are age eighteen or older and have completed ninety (90) days of service to enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Contributions from employees are based on elective salary reductions determined by the employee and may not exceed the maximum amount authorized by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a matching percentage based on each participant’s contributions. The match is based on elective deferrals up to 5% of wages and is computed at 25% of these elective deferrals. Matching contributions were \$137,132 and 124,447 for 2024 and 2023, respectively. The Company may elect to make a discretionary profit-sharing contribution to the Plan. Discretionary profit-sharing contributions are allocated to participants based on eligible compensation as defined in the plan document. There were no discretionary profit-sharing contributions made in 2024 or 2023.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution, including any rollover amounts from qualified plans, and allocations of (a) the Company’s matching and profit sharing contributions and (b) Plan earnings (losses) and an allocation of expenses (if applicable). Allocations are based on participant earnings or account balances, as defined.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contributions plus actual earnings thereon is based on years of continuous service as follows:

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan transactions are secured by the participant's vested interest in their account and bear interest at a reasonable rate as determined by the Plan administrator. In 2024, interest rates ranged from 4.25% - 9.5%. Principal and interest are paid ratably through biweekly payroll deductions.

#### **Payments of Benefits**

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. The Plan will distribute in a lump-sum any vested balance after a specified time period following a participant's separation from service as soon as administratively feasible. Under certain circumstances, participants may elect to receive in-service distributions. In addition, distributions will be paid automatically of any vested balance not exceeding \$5,000 without requirement of consent. Distributions and withdrawals are subject to the applicable provisions of the Plan agreement.

#### **Forfeitures**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents forfeiture. Forfeited non-vested accounts can be used to reduce employer discretionary contributions or administrative expense of the Plan. Forfeitures of \$8,332 and \$12,159 were used to reduce employer matching contributions during the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, there were \$7,518 and \$8,332 of forfeited non-vested accounts, respectively.

### **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no

allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### **Risks and Uncertainties**

Investment securities in general are subject to various risks, such as interest rate, credit and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Certain investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Subsequent Events**

The Company has evaluated subsequent events through June 3, 2025, which is the date the financial statements were available to be issued.

### NOTE D – FAIR VALUE MEASUREMENT

#### Fair Value Measurement

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

#### *Mutual Funds*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

#### *Self-Directed Brokerage Accounts*

The self-directed brokerage accounts include investments in common stock and a money market fund. These investments are valued at quoted market prices.

#### *Fixed Annuities*

These investments are valued based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. The individual holdings within the fixed annuities are valued using observable inputs that are readily available.

#### *Collective Trust Funds*

Collective trust funds are valued at their net asset values (“NAV”) per share as of the close of business on the valuation date. Net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Redemption for collective trust funds is permitted daily with no other restrictions or notice periods and there are no unfunded commitments. This valuation method would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

#### **NOTE E – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **NOTE F – TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit-sharing plan sponsored by Qualified Retirement Plan Services, Inc. which received a favourable opinion letter from the Internal Revenue Service dated June 30, 2020. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of December 31, 2024. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2021, 2022, and 2023. There are currently no audits for any periods in progress.

#### **NOTE G – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are in Empower Trust Company, LLC’s mutual funds and trust accounts. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$64,882 and \$45,515 for the years ended December 31, 2024 and 2023, respectively.
