## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Windsor Door Union Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of February 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended February 1, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of February 1, 2024 and December 31, 2023, and for the period ended February 1, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audits.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF THE PLAN

Windsor Door, LTD. (the “Company”) sponsors the Windsor Door Union Retirement Savings Plan (the “Plan”) for the benefit of its employees. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Effective January 1, 2024, participants of the Plan were enrolled and began contributing to the Windsor America 401(k) Plan. Participant balances in this Plan were transferred to the Windsor America 401(k) Plan effective February 1, 2024.

Description and Eligibility

The Plan is a defined contribution, 401(k) plan covering employees of the Company who are covered by a collective bargaining agreement and have completed at least ninety days of service, as defined. Days of service need not be contiguous, but there can be no more than a one-year break in service. Plan entrance is available on the first day of the month after the employee becomes eligible. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provision of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offering and for monitoring investment performance.

Contributions

Employees who are eligible to participate in the Plan may elect to have up to 70% of their compensation deducted from payroll and contribute up to the maximum amount allowed by Internal Revenue Service (“IRS”). If a participant reaches age 50 during the calendar year and is making the maximum Plan or IRS pre-tax contribution, they may make an additional “catch-up” contribution each pay period, up to the annual IRS dollar limit. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 2% of eligible compensation. Contributions are automatically invested in a designated balance fund until changed by the participant. All participant contributions are invested according to the allocations as determined by each individual Plan participant. Participants are allowed to stop their elective deferrals to the Plan and may change their elective deferral amounts on a semi-monthly basis.

The Plan document allows the Company to make discretionary contributions to the Plan. There were no discretionary contributions made for the period ended February 1, 2024.

Participant Accounts and Investment Options

Separate accounts are maintained in the name of each participant. Participants direct their contributions to be invested in one or a combination of available investment accounts. Participants may change their investment directive at any time during the year directly through the Trustee. Each participant's account is credited with the participant's contributions and an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all of their accounts in the Plan and actual earning thereon, except for the Plan Sponsor matching contributions, which will vest based on the following schedule: 34% after 1 year, 67% after 2 years, and 100% after 3 years.

Notes Receivable from Participants

The Plan allows participants to apply for and obtain notes in an amount defined in the Plan (no less than \$1,000 and limited to 50% of the participant's vested account balance provided such notes do not exceed \$50,000), from the balance of the participant's account. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate that is based on the federal prime rate at the time the notes are issued. Repayment terms for notes receivable are five (5) years or less and thirty (30) years for personal residence related loans. Payments of principal and interest are paid through semi-monthly payroll deductions and credited to the participant's account. Upon termination of employment, outstanding note balances are treated as distributions and are subject to applicable federal and state income taxes, and penalties, if applicable, if they are not paid in full by the end of the quarter following the quarter in which the participant terminated employment. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 1, 2024 and December 31, 2023.

Payment of Benefits

Upon termination of service, participants may receive their vested interest either in a lump sum amount, partial withdrawals, or installment payments under a systematic withdrawal plan. Participants may also withdraw amounts from their accounts under certain defined conditions. The Plan allows participants who are 59 ½ or older to take in-service distributions. The benefit to participants is limited to the value of the participants' vested interest in their accounts. Participants who have reached age 72, must take the required minimum distributions as required by the IRS.

Hardship Withdrawals

The Plan allows hardship withdrawals subject to account balance limits and applicable law.

Forfeitures

There were no forfeitures for the period ended February 1, 2024.

Administrative Expenses

Administrative and recordkeeping fees are shared by the Plan participants and are allocated on a pro-rata basis to participant accounts. The Company absorbs other administrative costs of the Plan, such as audit and legal fees associated with the Plan.

Plan Termination

Although the Plan is intended to be permanent, the Company reserves the right to terminate the Plan at any time. Upon termination of the Plan, all contributions become fully vested and non-forfeitable. If the Plan is terminated, all amounts credited to a participant's account will be paid to such participant.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. The accounting records of the Plan are accrual basis.

Use of Estimates

In preparing the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America, the Plan Sponsor is required to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities and the reported increases and reductions of Plan assets during the reporting period. Actual results could differ from these estimates.

Fair Value Measurements

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Valuation of Investments and Investment Income

The Plan's investments are stated at fair value at December 31, 2023.

Investment income consists of dividend and interest income. The net appreciation of investments consists of realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at the unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed.

Plan Expenses

Certain general and administrative expenses incurred in the administration of the Plan are paid by the Company. Expenses paid from Plan assets are reflected in the Statement of Changes in Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through May 6, 2025, the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified by Reliance Trust Company, the Trustee of the Plan, except to compare such information to the information included in the accompanying financial statements and schedule. Information certified by the Trustee includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at February 1, 2024 and December 31, 2023, and investment income items and interest on notes receivable from participants included in the Statement of Changes in Net Assets Available for Benefits for the period ended February 1, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 1, 2024 and December 31, 2023.

- The fair value of mutual funds are based on prices in public exchanges of the securities held by the Plan at year-end.
- The fair value of the common collective trusts are based on Net Asset Value (“NAV”), which represents fair value because NAV is the value at which the Plan transacts in this actively traded investment. NAV is used as a practical expedient to estimate fair value.

NOTE 5 – TAX STATUS

The IRS has determined and informed the Trustee by opinion letter dated October 6, 2020, that the Volume Submitter Defined Contribution Plan which was adopted by the Plan is a qualified plan under Section 401 of the IRC and is exempt from tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Volume Submitter Plan has been amended since receiving the opinion letter. The Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 1, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan files the United States Federal Form 5500 annually.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 – RELATED-PARTY TRANSACTIONS

Fees paid by the Plan for the investment management services are included as a reduction of the return on each fund. There are also indirect fees deducted directly from the investment earnings of the Plan.
