NOTE 1 - PLAN DESCRIPTION

The following description of the C. Stein, Inc. Retirement Plan (“Plan”) provides only general information. Participants should refer to the actual Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, established January 1, 2004 and amended effective February 17, 2022 by C. Stein, Inc. DBA CSB (the “Company” and “Sponsor”), covering all eligible employees of the Company. The Plan provides for contributions pursuant to Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Termination

The Plan Sponsor has the right under the Plan document to terminate the Plan subject to the provisions of ERISA. On November 7, 2023, the Plan Sponsor adopted a resolution to terminate the Plan, with an effective date of January 31, 2024.

A Notice of Intent to Terminate was provided to the Plan’s participants on November 7, 2023. The Plan termination accelerated vesting for any affected Participant to 100% as of the effective date January 31, 2024. Contributions under this Plan ceased as of December 31, 2023 and active employees became eligible to participate in the plan of the plan sponsor’s parent company at that time.

Contributions received in 2024 were for contribution receivables recorded as of December 31, 2023. All participant account balances were distributed in 2024 and there are no assets remaining in the Plan as of August 13, 2024.

Prior to Plan termination and liquidation, provisions of the Plan were as follows:

Eligibility

Employees were eligible to participate in the Plan if they were not union employees, 18 years of age or older, and have been an employee for at least two consecutive months. Plan entry dates were the first day of the month coinciding with or next following date subsequent to meeting eligibility requirements.

Contributions

Plan participants could contribute 1% to 65% of eligible compensation, as defined by the Plan, subject to statutory limitations. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans, and Roth elective deferrals. The Company could elect to match employee contributions.

For eligible participants of Division 1 and 2, the Company could make discretionary matching contributions based on a percentage or fixed amount of each participant’s eligible compensation, which was determined annually on a uniform basis. The Company could also make discretionary non-elective contributions based on a percentage or fixed amount determined by the Company. The Company could also make discretionary profit-sharing contributions. Participants were required to be employed the last day of the Plan year and have completed at least 1000 hours of service. Participant elective contributions were not required.

Investment Options

Participants could select one or more predetermined investment options for the investing of contributions and allocated earnings. Contributions were deposited directly into the participant-elected investment vehicles.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Prior to the termination of the Plan, at which point participants became fully vested in all contributions, the Plan featured a six-year vesting schedule for all employer contributions made as follows:

All participants were 100% vested in employee elective contributions upon entering the Plan. Participants were also 100% vested upon death, disability or normal retirement age. Normal retirement age is 65 years of age.

Notes Receivable from Participants

Participants could borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (modified for existing loans) or 50% of the present value of their account balances. Loans were repaid through payroll deductions over periods ranging up to 60 months. The loans were secured by the vested interest in the participants' accounts. Loans used for the purpose of purchasing a participant's personal residence, which were secured by the residence, may be repaid over a 30 year period. At the period ended August 13, 2024, there were no loans within the plan due to plan termination.

Distributions

Distributions under the Plan could be made in a lump sum, substantially equal payments over your life expectancy or partial withdrawals. Annuities were not allowed.

Distributions of elective contributions and vested employer contributions were allowed in the event of: termination of employment; retirement-age 65; financial hardship; and in-service distributions after attainment of age 59½. Distributions in the event of death, total and permanent disability or normal retirement are 100% vested.

Forfeited Accounts

As of August 13, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$7,529, respectively. These accounts may be used to reduce future employer contributions or pay plan expenses. The amount forfeited will be restored to the participants account if they are rehired by the Plan Sponsor before incurring five consecutive one-year breaks in service and any distribution received by the participant must be repaid to the Plan to receive the restored forfeiture. The Company used \$13,059 to pay plan expenses and reduce future employer contributions during the period ended August 13, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the Plan termination described in Note 1, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), Plan financial statements have been prepared on liquidation basis of accounting.

This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of the assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of December 31, 2024, would be fair value. There were no investments held as of August 13, 2024.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator obtained certifications from Reliance Trust Company, the trustee of the Plan, that the following information included in the Plan's financial statements is complete and accurate:

- Investments at fair value, as shown in the statements of net assets available for benefits as of December 31, 2023.
- Notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023.
- Net investment income and interest income from participant notes receivable, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2024 through August 13, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds: Valued based on the daily quoted market value of the fund, which represents the net asset value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets had been distributed by August 13, 2024, and therefore there are no investments presented in a fair value hierarchy table as of August 13, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023:

NOTE 6 - TAX STATUS

For the adoption agreement effective February 17, 2022, the Internal Revenue Service ("IRS") has informed Transamerica Retirement Solutions, LLC by an opinion letter dated June 30, 2020 that the Defined Contribution Volume Submitter Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and Transamerica Retirement Solutions, LLC believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of the period ended August 13, 2024 and the year ended December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
