Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Surterra 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

December 31, 2023, and 2022

Note 1 - Description of plan:

The following description of the Surterra 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established effective January 1, 2018.

General

The Plan sponsor is Surterra Holdings (the Company, Plan Sponsor, or Plan administrator). The Plan is a defined contribution plan covering substantially all employees of the Company's adopting subsidiaries. Employees are permitted to enter the plan quarterly with no age or service requirement restricting participant contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pre-tax or after-tax (roth) compensation, as defined in the Plan, up to limits defined in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan to contribute 4% of their pre-tax compensation, unless they affirmatively elect not to participate in the Plan.

The Company may make discretionary matching and/or profit-sharing contributions. For the plan years ended December 31, 2023, and 2022 the Company did not make any discretionary matching contributions. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. During the years ended December 31, 2023, and 2022 the Company elected not to make any profit-sharing contributions to the Plan. Participants must be at least 18 years of age, be employed on the last day of the plan year, at least 1,000 hours of service during the Applicable Period to be eligible to receive the discretionary matching and profit-sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with their contributions, as well as Company contributions and allocations of Plan earnings, thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contributions and earnings thereon is based on years of continuous service, as follows:

Participants are immediately vested upon termination of the Plan, upon attainment of normal retirement age, or upon disability or death while an employee of the Plan Sponsor.

Forfeitures

Forfeited non-vested accounts totaled \$42,619 and \$87,656 as of December 31, 2023, and 2022, respectively. Forfeitures of terminated participants' non-vested accounts can be used to restore the forfeitures account, reduce Company contributions, or pay Plan expenses. Other expenses of \$45,033 consisted of forfeitures that were used to restore the forfeitures account, reduce Company contributions, and pay Plan expenses in 2023.

Payment of benefits

A participant is entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant may request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship, but the withdrawal is limited to the amount of the participant's pretax contributions and earnings thereon.

Notes receivable from participants

The Plan does not allow participant loans.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments in mutual funds and exchange traded funds are reported at fair value based on quoted market prices of shares held by the Plan at year end. Mutual funds and exchange traded funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and exchange traded funds held by the Plan are considered to be actively traded. Money market funds aim to maintain a NAV of one dollar per share.

The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and PCS Retirement, LLC.

Investment valuation and income recognition - continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

New accounting pronouncements

The plan was restated effective 1/1/2022 are required for the IRS Cycle 3 restatement period. This restatement also included addendums for good faith effort to comply with hardship distribution final regulations, and the requirements of the Further Consolidated Appropriations Act, 2020, including the SECURE Act provisions, the Coronavirus, Aid, Relief and Economic Security (CARES) Act, and the Consolidated Appropriations Act, 2021, (CAA), and corresponding guidance (the "Applicable Law").

The plan was further amended effective 1/1/2024 to allow for participants to modify elective deferrals on a per pay period basis.

Note 3 - Investments and information certified by the custodian:

Advisor Trust holds the Plan's investment assets and executes investment transactions. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2023, 2022 and net appreciation in fair value of investments for the year ended December 31, 2023, 2022 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by PCS Retirement, LLC.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on

the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2023 and 2022.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related-party transactions:

Fees incurred by the Plan for the investment management services are included in net appreciation. The Company pays directly any other expenses related to the Plan's operations. In addition, certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax status:

The underlying volume submitter plan has received an opinion letter from the IRS dated March 31, 2014, stating that the form of the Plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to and has chosen to rely on the current IRS volume submitter plan opinion letter.

Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is taking steps to bring the Plan in compliance with the applicable requirements of the IRC; and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Delinquent participant contributions:

During 2023, the Plan Sponsor remitted to the Plan approximately \$737,538 of participant deferrals that were not within the required time frame as required by DOL regulations. The DOL considers late deposits to be prohibited transactions. The Plan Sponsor will file Form 5330 and pay the applicable excise tax. Additionally, the Company will pay amounts into the Plan for lost earnings resulting from the late deposits. The Company will file Form 5330 and remit the lost earnings related to the 2023 late deposits to the Plan in 2024. The amount of late deposit lost earnings was calculated to be \$4,886, which is included in the employer contributions receivable on the accompanying Statements of Net Assets Available for Benefits.

Note 9 – Subsequent Events:

The Plan has evaluated and determined that the subsequent event has occurred subsequent to the date of the statement of net assets available for benefits through June 9, 2025, the date which the financial statements were available to be issued, which require recording or disclosure in these financial statements. A late deposit of \$4,886 was made on December 18, 2024. No other event has occurred other than what has been disclosed.
