INDEPENDENT AUDITOR'S REPORT

To the Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its

form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 **DESCRIPTION OF PLAN**

The following description of the Ark Contracting Services LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution plan established by Ark Contracting Services LLC (the Company). The Plan qualifies as a profit-sharing plan under the Internal Revenue Code (Code) Section 401(a) and as a cash-or-deferred arrangement under Code Section 401(k).

The Plan is a defined contribution plan that covers all employees of the Company who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan entry dates are the first day of each month.

Employee contributions

Participants are permitted to contribute all or part of their annual compensation to the Plan on a tax-deferred basis, up to the limits of the Code. Transfers (rollovers) from qualified plans are allowed under the provisions of the Plan.

Employer contributions

The Company makes safe harbor matching contributions based on each participant's contributions for each pay period. The matching rate is 100%, limited to matching participant contributions up to 3% of salary and 50% of the next 2% of eligible employee contributions. All 2021 employer contributions were safe harbor matching contributions. All eligible participants receive safe harbor matching contributions.

Administrative expenses

The Company pays most of the Plan's administrative expenses.

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocation of other employer contributions, if any, and an allocation of Plan earnings. Allocations of Plan investment earnings or losses are based on participants' account balances invested in each fund.

Vesting

Participants are fully vested in their deferral, rollover, safe harbor match, and QNEC accounts. Employer contributions are 100% vested at all times.

Note 1 **DESCRIPTION OF PLAN – (continued)**

Notes receivable from participants

Participants may receive a loan from their participant accounts. The minimum amount of a loan is \$1,000; the maximum amount is the lesser of: (1) \$50,000 or (2) 50% of their vested account balance. These loans generally range up to five years in length. Participant loans are secured by the participants' vested balance in the plan. As of December 31, 2021, these loans bore interest at 3.25%, are payable in weekly payments, and mature through July 2026.

Payment of benefits

Upon termination of service, participants with vested balances of \$5,000 or less receive a distribution of their vested balances. If the amount to be distributed is between \$1,000 and \$5,000 and the participant does not affirmatively elect to have the distribution rolled into a qualified plan or paid to them (net of tax withholding), the balance is transferred into an individual retirement account set up for their benefit. Otherwise, terminated participants receive a lump-sum amount equal to the value of their vested interest in their account when they elect a distribution of their account balance.

In-service withdrawals of certain vested balances are available to participants in cases of hardship, attainment of age 59 ½, or disability. Also, contributions that were transferred into the Plan from another qualified plan may be transferred out of the Plan to an individual retirement account or another qualified plan.

Forfeitures

Forfeitures may be used to reduce future employer contributions. These were immaterial at December 31, 2021 and 2020.

Other plan provisions

Other plan provisions including investment options are described in the Plan Document.

Note 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting. This method differs from accounting principles generally accepted in the United States of America since revenues are recorded when received rather than when earned, and expenses are recorded when paid rather than when incurred.

Investment valuation and income recognition

All investments are participant-directed, and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Participant loans are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income on participant loans is recorded when received.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through October 5, 2022, the date which the financial statements were available to be issued.

Note 3 **TAX STATUS**

Effective January 1, 2021, the Plan adopted the Great-West Trust Company Defined Contribution Pre-Approved Plan. The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in

compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. was in compliance with the applicable requirements of the Code. Therefore, no provisions for income taxes are included in the accompanying financial statements.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2018.

Note 4 **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan's sponsor has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a full or partial plan termination, affected participants will become fully vested in their accounts.

Note 5 **INFORMATION CERTIFIED**

The December 31, 2021 and 2020 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the year ended December 31, 2021, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$1,494,362 and \$ 1,032,060 at December 31, 2021 and 2020, and related investment earnings of \$112,805 for the year ended December 31, 2021.

Note 6 FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets or liabilities. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2

The fair value of the stable value account/guaranteed income fund is stated at contract value reported by Great West Life and Annuity Insurance Company. See also Note 10. This is a level 2 fair value measurement.

Note 7 PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC. Note 10 **INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2021, the Plan entered into a fully-benefit-responsive investment contract with Great West. This company maintains the contributions in a general account. The account is credited with earnings at the crediting interest rate and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified guaranteed floor interest rate that is guaranteed to the Plan.

Because the investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Great West, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2021 was \$6,742. The contract value approximates the fair value of the investment contract at December 31, 2021.
