### Note A – Description of Plan

The following description of Mid-Florida Hematology & Oncology Centers, PA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a safe harbor defined contribution plan that was established effective June 1, 1996, and most recently restated effective January 1, 2022. All employees of Mid-Florida Hematology & Oncology Centers, PA (the “Company” or the “Employer”) are eligible to participate after attaining the age of 21 and upon completion of one year of service. Employees may enroll in the Plan semi-annually on the first day of the first month and seventh month of the Plan year coinciding with or next following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective July 1, 2024, the Plan was merged into OneOncology, LLC OneRewards Retirement Plan. As a result, Mid-Florida Hematology & Oncology Centers PA 401(k) Plan was amended to remove safe harbor effective June 30, 2024. The Plan had a black out period from August 13, 2024 and all Plan assets were transferred out to the surviving plan by August 20, 2024.

#### Administration

The accounting records are maintained by the Company. The Plan’s assets for the year were held and managed by Voya Retirement Insurance and Annuity Company (the “Trustee”). Contributions are held by Voya Retirement Insurance and Annuity Company, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. Participants may also make post-tax Roth deferral contributions to the Plan. The maximum participant deferral for the year ended December 31, 2024, was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to IRS limitations of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans. Contributions received from participants are net of excess deferral contributions refunded, as required to satisfy the relevant nondiscrimination provisions of the Plan.

The Employer makes safe harbor non-elective contributions of 3% of the participant’s eligible compensation for the Plan year. Each Plan year, the Company may also elect to make discretionary matching and profit sharing contributions to the Plan. The total amount of any discretionary matching contribution may not exceed 4% of Plan Compensation. To be eligible to share in any Employer profit sharing contributions, the participant must be employed on the last day of the Plan Year and have completed at least 1,000 hours of service during the Plan year. For the period from January 1, 2024 to August 20, 2024, the Company did not make a discretionary matching or profit sharing contribution.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and any Employer contributions, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

### Note A – Description of Plan (continued)

#### Vesting

Participants are vested immediately in their elective deferral contributions plus actual earnings or losses thereon. Participants are also immediately vested in safe harbor contributions. Vesting in Employer discretionary matching and profit sharing contributions is based on years of continuous service. A participant is 100% vested upon death, disability, retirement age, or after five years of credited service as follows:

#### Notes Receivable from Participants

Participant loans are not permitted.

#### Distribution of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annuity distributions or installments paid over various periods, as defined in the Plan agreement, less any applicable taxes. Participants may request in-service distributions from their accounts attributable to discretionary Employer matching and profit sharing contributions upon attaining age 50. Participants may request in-service distributions from their accounts attributable to salary deferral contributions upon attaining age 59 ½. Participants may request a hardship withdrawal for qualifying expenses from their accounts excluding the portion attributable to Employer safe harbor balances.

#### Forfeitures

Forfeitures occur when a participant terminates employment and has not vested in a portion of the Employer's contribution amount. Forfeitures may be applied to reduce Employer contributions and Plan expenses. For the period ended August 20, 2024 and the year ended December 31, 2023, forfeited non-vested accounts totaled approximately \$0 and \$1,000, respectively. For the period ended August 20, 2024, approximately \$8,000 of forfeitures were used to offset Employer matching contributions.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as described in Note G. Quoted market prices are used to value investments. Shares of pooled separate accounts are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

<i>Level 1</i>	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
<i>Level 2</i>	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<i>Level 3</i>	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 20, 2024, and December 31, 2023.

*Money market fund:* These are open-ended money market mutual funds valued at a \$1.00 stable NAV for reporting purposes, and transact at \$1.00 for subscription and redemption activity. However, on a daily basis the funds NAV is calculated using the amortized cost (not market value) of the securities held in the fund.

*Pooled separate accounts:* Valued at the net asset value (“NAV”) provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at August 20, 2024 and December 31, 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

*Separately managed accounts:* Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note C – Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at August 20, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends from the period of January 1, 2024 to August 20, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution. As of August 20, 2024 and December 31, 2023 and from the period of January 1, 2024 to August 20, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Voya Retirement Insurance and Annuity Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code and, therefore, the related trust is exempt from taxation under Section 401 of the Internal Revenue Code. The Plan Administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2022.

### Note E – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of August 20, 2024 and December 31, 2023, and for the period ended August 20, 2024, were in investment funds managed by the Trustee; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$22,000 during the period ended August 20, 2024.

### Note F – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of August 20, 2024 and December 31, 2023, the Plan is invested in guaranteed interest accounts (Voya Fixed Account, "the Fund") provided through a group annuity contract. Under the Fund, a crediting rate is established and is credited with contributions and charged for participant withdrawals and administrative expenses charged by the Trustee of the Fund. The guaranteed interest account issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed interest account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note H – Subsequent Events

Subsequent events have been evaluated through May 29, 2025, which is the date the financial statements were available to be issued.


