Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of OK 4 Masters Holdco, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 10, 2024 (in Liquidation) and December 31, 2023 (Ongoing), the related statements of changes in net assets available for benefit for the period from January 1, 2024 to October 10, 2024 (in Liquidation) and the year ended December 31, 2023 (Ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 10, 2024 and 2023, and for the period from January 1, 2024 to October 10, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the financial statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the board of directors of OK 4 Masters Holdco, LLC, the Plan's sponsor, voted on May 21, 2024 to terminate the Plan and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit Section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

Note 1. Description of the Plan

The following description of the OK 4 Masters Holdco, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan whereby eligible employees of OK 4 Masters Holdco, LLC and its affiliates (the Company) are permitted to make pretax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (IRC). The Plan was established effective July 1, 2013. The Plan is intended to satisfy the requirements for a qualified retirement plan under the appropriate provisions of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

In May 2024, the Sponsor's Board of Directors adopted a resolution to terminate the Plan effective October 10, 2024. The Plan was fully funded as of December 31, 2023. As a result, management determined that liquidation was imminent. The Plan's liquidation process was completed as of October 10, 2024.

Eligibility

Employees are eligible to participate upon attaining the age of 20.5 and completing six months of service. Plan entry is on the first day of the plan year coinciding with or next following the date eligibility requirements are met.

Contributions

Participants may contribute up to a maximum amount of pre-tax compensation, as defined in the Plan document, not to exceed \$23,000 in 2024 in accordance with Internal Revenue Service (IRS) regulations. Roth deferrals subject to federal income taxes in the year of deferral are also allowed. In addition, those participants, who are over age 50 or turning age 50 on or before December 31, 2023, are eligible for an additional catch-up contribution of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

Under the Plan, each participant's account is credited with the participant's voluntary contributions, employer contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Participants are immediately vested in the Company's safe harbor matching contributions. Vesting in the Company's non-safe harbor contributions plus actual earnings or losses thereon is based on years of service. Participants vest 20% per year after two years of service and are 100% vested after six years.

of service. As a result of the decision to terminate the Plan during 2024, all participants became fully vested in their account balances.

Benefits paid to participants

The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance. Upon death, disability, financial hardship, or retirement, a participant is entitled to receive a single lump-sum payment from the Plan. Upon termination of employment, participants with account balances less than \$1,000 receive a lump sum payment which does not require consent from the participant. If the participant's account balance is between \$1,000 and \$5,000 and no election is made by the participant to receive a lump sum payment or roll over the balance to another qualified retirement plan, the Plan will automatically roll over the account balance to an individual retirement rollover account for the benefit of the participant which does not require consent from the participant. If a participant's account balance exceeds \$5,000, they may elect to receive a lump-sum distribution for all or a portion of the account balance, stay in the Plan, or roll over to another qualified retirement plan.

Forfeitures

Forfeited, nonvested accounts are retained in the Plan and may be used to restore forfeitures to participants, reduce Company contributions or to pay Plan expenses. At October 10, 2024 and 2023, there were \$0, and \$7,407 of unused nonvested employer contributions, respectively. During the period from January 1, 2024 to October 10, 2024, \$5,088 of forfeitures were used to reduce Company contributions.

Note 2. Summary of significant accounting policies

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of Presentation:

Due to the decision to terminate the Plan during 2024, management determined that liquidation of the Plan is imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared as a going concern on the accrual basis of accounting.

Investment valuation and income recognition

All investments in the 2023 Statement of Net Assets Available for Benefits are reported at fair value. There were no investments remaining in the Plan as of October 10, 2024. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, or depreciation, includes the Plan's gains and losses on investments purchased and sold as well as those held during the year.

Note 2. Summary of significant accounting policies, continued

Administrative expenses

All significant expenses of maintaining the Plan are paid by the Company. Certain Plan expenses, such as fees related to the administration of notes receivable from participants or related to distributions from the Plan, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits

Benefit payments to participants are recorded when paid.

Subsequent events

The Plan Administrator has evaluated subsequent events through June 9, 2025, the date the financial statements were available to be issued.

Note 3. Certified investments

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2023, and net appreciation in fair value of investments for the period from January 1, 2024 to October 10, 2024, and for the year ended December 31, 2023 were obtained or derived from information provided to Plan management and certified as complete and accurate by Matrix Trust Company (the Custodian).

Note 4. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification 820 (ASC 820) are described below:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

Note 4. Fair value measurements, continued

In instances where the determination of fair value measurement is based on inputs from the different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The methods used to value investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Money market funds and mutual funds: Valued at the daily closing price as reported by the fund. The money market funds and mutual funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Money market funds and mutual funds are valued at the daily closing price as reported by the fund.

Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits. The NAV based assets are generally redeemable on a daily basis with a one day notice with no restrictions and there are no unfunded commitments.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 5. Related-party transactions and party-in-interest transactions

Plan assets are held and managed by the custodian. The custodian invests cash received, interest and dividend income as directed by the participants of the Plan. The custodian also makes distributions to participants.

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the employer and certain others. As such, transactions conducted with the Company and the custodian of the Plan qualify as party-in-interest transactions.

Certain administrative functions are performed by employees of the Company. However, no such employees receive compensation from the Plan. The Company and the Plan share in administrative expenses for the Plan.

Note 6. Tax status

Effective January 1, 2018, the Plan adopted a volume submitter profit sharing plan (the "Volume Submitter Plan") originated by the Plan's third party administrator. The IRS has issued an opinion letter in relation to the Volume Submitter Plan dated March 31, 2014, stating that the form of the Volume Submitter Plan was acceptable under section 401(a) of the IRC for use by employers for the benefit of their employees. The Company believes the Plan and related trust are currently designed and being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles general accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and uncertainties

The Plan may invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


