Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of General Plug & Manufacturing Co. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

General – The Plan was established on September 1, 1966 to provide retirement benefits for substantially all employees of General Plug & Manufacturing Co. and related companies (the "Company") who are not leased employees, non-resident aliens, or covered by a collective bargaining agreement. Employees become eligible to participate in the Plan following three months of service with the Company and attaining age twenty-one or older, as defined in the Plan agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The management team oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings.

Contributions – Participants may make contributions in any amount up to certain limits imposed by the Internal Revenue Service ("IRS"), on a pretax or Roth basis. The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company may make a discretionary matching contribution equal to a uniform percentage of a participant's salary deferrals. However, any salary deferrals that are "catch-up contributions" will not be matched. Each year, the Company will determine the amount of the discretionary percentage. For 2024, across the related companies, the Company authorized a discretionary matching contribution of 50% of the first 4% of eligible compensation contributed by participants. Additional non-elective amounts may be contributed at the discretion of the Company's board of directors, subject to certain limitations. Discretionary non-elective contributions are allocated to participants who are employed on the last day of the Plan year or who have completed at least 1,000 hours of service during the Plan year. Non-elective contributions in the amount of \$5,619 were made in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution or profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant vests 20% per year and is 100% vested after five years of credited service. Participants become fully vested upon death or disability.

Note 1. Description of Plan (Continued)

Notes Receivable From Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – Amounts credited to an individual participant's account are distributed at termination of services due to death, disability or retirement as a lump sum. Distributions may be deferred until the participant reaches the age 70½ (if born before July 1, 1949) or age 72 (if born after June 30, 1949) if the value of the distribution is not less than \$5,000.

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. The Plan also provides for in-service distributions at age 59 ½.

Forfeitures – Any forfeited non-vested accounts may be used to pay administrative fees, reduce employer contributions, or be allocated to eligible participants as additional employer contributions. At August 31, 2024 and 2023, there were \$5,269 and \$8,210, respectively, of forfeited non-vested accounts. For the year ended August 31, 2024, there were \$5,619 of forfeitures used to reduce employer contributions.

Note 2. Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments – Benefits are recorded when paid.

Note 2. Summary of Accounting Policies (Continued)

Operating Expenses – All administrative fees of the Plan are paid by the Plan or by the Company at the option of the Company, except fees related to participant loans, which are paid by the affected participants.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. No allowance for credit losses has been recorded at August 31, 2024 and 2023.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Evaluation of Subsequent Events – The Company has evaluated subsequent events through June 9, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- Registered investment companies: Valued based on their quoted closing market prices in active markets for identical investments and are classified as Level 1.
- Cash: Interest bearing cash is classified as Level 1.
- Common stock: Valued at the closing price reported in the active market in which the individual securities are traded and is classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Unaudited Information

Accordingly, the Trustee has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the statements of net assets available for benefits at August 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at August 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended August 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer contributions.

Note 6. Income Tax Status

The IRS has determined and informed the sponsor of the volume submitter document adopted by the Plan by a letter dated June 30, 2020 that the document is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the volume submitter document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of August 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the Plan's investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Party-in-Interest Transactions

Included in administrative expenses is \$40,595 in fees paid to the Trustee for the year ended August 31, 2024. Newport Trust Company is Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.
