### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the financial statements of the Associated Hardwoods, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and March 31, 2024, and the related statement of changes in net assets available for benefits for the period ended December 31, 2024, and the related notes to the financial statements ("financial statements").

## Notes to Financial Statements

### 1. Description of Plan

The following description of the Associated Hardwoods, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

During 2024, the Plan changed its year end from March 31<sup>st</sup> to December 31<sup>st</sup>.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Associated Hardwoods, Inc. (the "Company"). To be eligible to participate in the Plan, an employee must have attained age 21 and completed one year of service. Employees may begin participation as of January 1, April 1, July 1 or October 1, or coinciding with or following the date on which they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### **Contributions**

Participants may elect to contribute up to 100% of their pre-tax and/or after-tax compensation, as defined by the Plan not to exceed the limits set by the Internal Revenue Service ("IRS"). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers").

The Company makes a safe harbor matching contribution of 100% of the first 3% plus 50% of the next 2% of compensation contributed by participants to the Plan. The Company may also make a discretionary contribution to be determined annually by the Board of Directors. The discretionary contribution is allocated to eligible participants based upon the percentage of their compensation to total compensation for all eligible participants, as defined by the Plan. However, no discretionary contribution was made for the period ended December 31, 2024.

Upon enrollment in the Plan, a participant may direct contributions into any of the investment options offered through the Plan. Participants may change their investment options at any time and deferral percentages as of the first day of each month.

#### **Participant Accounts**

Each participant's account is credited with the participant's and Company's contributions and an allocation of the Plan's net earnings and administrative expenses. Allocations are based on participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions plus actual earnings thereon.

Vesting in the Company's discretionary contributions is based on years of continuous service according to the following schedule:

### 1. Description of Plan (Concluded)

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant or beneficiary may elect to receive the value of the vested interest in his or her account in a lump-sum payment. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of hardship, as specified by the Plan.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have only one outstanding note at any given time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the plan administrator based on prevailing market rates. The maximum term of a note is generally five years, except for those used in the purchase of a primary residence. Principal and interest are repaid ratably through payroll deductions.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as for recordkeeping and investment advisory services, are permitted to be paid from the Plan's assets. Distribution and loan fees are paid from the affected participant's account.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and March 31, 2024. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

### 2. Summary of Accounting Policies (Concluded)

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through June 10, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and March 31, 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by FMR LLC ("FMR"). The IRS has determined and informed FMR by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and a common collective trust fund managed by Fidelity. Fees paid by the Plan to Fidelity for administrative services were \$1,100 during the period ended December 31, 2024. Fidelity is the trustee and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Fees paid by the Plan to Omni Star Financial Group for investment advisory services were \$49,262 during the period ended December 31, 2024.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and March 31, 2024.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using the estimated fair value of the underlying assets, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
