



SUMMARY ANNUAL REPORT

For CENTRO DE RADIOTERAPIA AUXILIO MUTUO RETIREMENT PLAN

This is a summary of the annual report Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for CENTRO DE RADIOTERAPIA AUXILIO MUTUO RETIREMENT PLAN, EIN 66-0612302, Plan No. 001, for period January 1, 2024 through December 31, 2024. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Plan expenses were \$2,937. These expenses included \$1,250 in benefits paid to participants and beneficiaries, and \$1,687 in other expenses. A total of 34 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$315,766 as of December 31, 2024, compared to \$224,932 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$90,834. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$93,771, including employer contributions of \$15,719, employee contributions of \$47,657, and earnings from investments of \$30,395 .

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

You also have the legally protected right to examine the annual report at the main office of the plan (CENTRO DE RADIOTERAPIA AUXILIO MUTUO, INC, PO BOX 191227, SAN JUAN, PR 00919) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
