To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of JB Doors Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JB Doors Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Reliance Trust Company, a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of JB Doors Company 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the JB Doors Company 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established on September 1, 1997 and covers all employees of Jamison Door Company, HCR, Inc., BMP-USA, LLC, and Jamotuf, LLC, subsidiaries of Jamison Door Company (collectively the "Company"). Employees are eligible to participate after they complete six months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan holds and invests contributions as directed by the participants. The plan sponsor, who is also the plan administrator, has appointed Reliance Trust Company to be the trustee of the Plan's assets.

Contributions

Participants are allowed to contribute a portion of their annual compensation, as defined by the Plan, not to exceed the maximum amount allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a money market fund and various mutual funds as investment options offered by the Plan.

The Plan includes an automatic deferral arrangement in which all new participants and existing participants who elected a deferral less than the auto-enrollment deferral rate of 6% at the time of restatement, would have 6% of their compensation automatically withheld unless they opt out.

The Company contributes a safe harbor non-elective contribution equal to 3% of the participant's eligible compensation.

Additional profit sharing amounts may be contributed by the Company at the option of the Company's Board of Directors. For the plan year ended August 31, 2023, the Company contributed a discretionary profit sharing contribution equal to 3% of the participant's eligible compensation.

Both the safe harbor non-elective contribution and the discretionary profit sharing contribution contributed for the plan year ended August 31, 2024 were funded from the profit sharing discretionary forfeiture account. See Note 9 related to the discretionary profit sharing forfeiture account.

Contributions are subject to certain IRS limitations.

Notes to Financial Statements

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant's Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor non-elective contributions, as well as allocations of the Company profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative Budget Account

An expense budget account has been established under the Plan and funded by T. Rowe Price. The funds held in the unallocated account may only be disbursed at the direction of the Plan or its named fiduciaries to pay the reasonable expenses of administering the Plan. The balance of the account is held in money market funds. During the plan year ended August 31, 2024, \$12,157 was received by the Plan to pay future plan expenses and \$10,455 was used from the account to pay plan expenses. At August 31, 2024 and 2023, there was \$13,894 and \$11,430, respectively, in this account available to pay plan expenses.

Vesting

Participants are immediately vested in their contributions, the company safe harbor non-elective contribution and company discretionary profit sharing contribution, plus actual earnings thereon.

Notes Receivable from Participants

Participants may not borrow funds from their retirement accounts.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a single lump-sum amount equal to the value of the participant's vested interest in his or her account or installments over a period of not more than the participant's life expectancy or assumed life expectancies of the participant and their beneficiary. If a participant's vested account balance is less than \$5,000, then the vested account balance may only be distributed to the participant in a single lump-sum payment. In addition, hardship distributions are permitted if certain criteria are met.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

As of August 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,713 and \$1,628, respectively. These accounts will be used to reduce future company contributions, pay administrative expenses and any remaining forfeitures will be allocated in the same proportion that the participant's compensation bears to the total compensation of all participants. During the year ended August 31, 2024, no forfeitures were used to reduce company contributions or pay administrative expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and (losses) on investments purchased and sold as well as held during the year.

Contributions

Contributions from Plan participants and company safe harbor non-elective and company discretionary profit sharing contributions are recorded in the year in which the employee contributions are withheld from compensation and on compensation paid during the year.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The financial statements as of August 31, 2024 and 2023 and for the year ended August 31, 2024 were prepared from information provided by Reliance Trust Company, the trustee of the Plan, which were certified to be complete and accurate to the best of their knowledge. Following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that was prepared by the trustee of the Plan and furnished to the Plan Administrator.

NOTE 5 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Money Market Funds and Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their company contributions.

NOTE 7 TAX STATUS

The sponsor company adopted the DST Retirement Solutions, LLC Non-Standardized Pre-Approved Profit Sharing Plan as the base for the JB Doors Company 401(k) Plan. A letter dated June 30, 2020, has been obtained for this plan, to incorporate technical changes in pension law provisions to remain in compliance with applicable requirements of the Internal Revenue Code. The current version of the Plan has been amended to conform to the most recent requirements of the tax laws. The Plan administrator and the Plan's management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt at the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

NOTE 8 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. T. Rowe Price, the third party administrator also qualifies as a party-in-interest. Fees incurred and paid directly by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. For the year ended August 31, 2024, the Plan directly paid \$2,800 to the third party administrator and \$9,955 to the plan's legal counsel, which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE 9 PROFIT SHARING DISCRETIONARY FORFEITURE ACCOUNT

Effective June 30, 2021, the Jamison Door Company Pension Plan terminated. Excess assets totaling \$2,320,093 that remained after purchasing annuities for the plan participants and paying plan expenses during the termination process were transferred to the JB Doors Company 401(k) Plan in March 2022. These funds, along with investment earnings, are held in the Plan's profit sharing discretionary forfeiture account and will be used for future nonelective company contributions to eligible participants in the JB Doors Company 401(k) Plan as determined by Jamison Door Company over the next several years based on required minimum contributions. As of August 31, 2024 and 2023, the balance in the profit sharing discretionary forfeiture account totaled \$976,520 and \$1,622,682, respectively.

During the plan year ended August 31, 2024, a safe harbor non-elective contribution totaling \$367,807 and a discretionary profit sharing contribution totaling \$367,807 was funded from the profit sharing discretionary forfeiture account.

NOTE 10 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
