REPORT OF INDEPENDENT AUDITORS

To the Benefit Plan Committee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cumberland County Hospital 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. DESCRIPTION OF PLAN

The following description of the Cumberland County Hospital 403(b) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Cumberland County Hospital Association, Inc. ("Employer") for the benefit of its employees. Effective December 1, 2023, employees regardless of hours worked in a week, can participate in the Employer matching contribution component of the Plan after attaining one year of participation. Prior to December 1, 2023, employees who normally work less than 20 hours per week were excluded. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Empower Annuity Insurance Company of America ("EAIC"), Modern Woodmen of America ("Modern Woodmen") and Metropolitan Life Insurance Company ("Met Life") serve as Plan custodians.

Contributions

The Plan permits eligible employees through a salary reduction deferral election to make annual contributions up to the current Internal Revenue Service (IRS) deferral limits. The Employer may elect to make discretionary matching contributions. In 2024, the Employer elected to match 100% of the first 3% contributed of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and allocation of: (a) Plan earnings and (b) administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants can direct investments in their account into several investment options and are allowed to change investment selections on a daily basis.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The note term may not exceed five years unless such note is for the purpose of the participant's primary residence. The notes are secured by the balance in the participant's account and bear interest at fixed rates that range from 5.25 percent to 10.50 percent which at the time of the note are based on the prime rate plus 2 percent. Maturity dates of the notes range from 2025 to 2029. Principal and interest are paid through payments made directly to EAIC from the participant. Participants may not have more than one outstanding note at the same time.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount or certain annuity options equal to the value of the participant's account balance.

Vesting

Participants are 100% vested at all times in all accounts.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based upon the terms of the Plan document.

Valuation of Investments

EAIC, Modern Woodmen and Met Life maintain the Plan's investment funds. Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The Plan's interest in the pooled separate accounts are valued at the net asset value (NAV) of the units of the pooled separate accounts as reported to the Plan by the custodians based on the quoted market prices of the underlying mutual funds.

Fully benefit responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate less participant withdrawals and administrative expenses.

The fair value of investment contracts that are not fully benefit responsive are calculated by discounting the related cash flows based on current yields of similar instruments with comparable deviations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Employer pays significant administrative costs of the Plan.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is June 4, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, EAIC, Modern Woodmen, and Met Life, the custodians, have certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled separate accounts:* Investments in pooled separate accounts are valued based upon the NAV of the funds multiplied by the units held by the Plan at year-end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The underlying investments of the pooled separate accounts consist solely of mutual funds and the investment strategy of the respective pooled separate accounts aligns directly with the investment strategy of the underlying mutual fund investments.
- *Investment contracts:* The fair values of the investment contracts are determined by the insurance companies, which are third parties, using proprietary pricing models for which the underlying inputs are not provided to the Plan administrator. The Plan administrator does not make any adjustments to those values. The insurance companies have determined that the fair values of the investment contracts approximate the contract values of such contracts.

5. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a traditional investment contract with Talcott Resolution Life Insurance Company ("Talcott") (administered by EAIC) that is fully benefit responsive. Talcott maintains the contributions in their general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The Plan also has entered into investment contracts with Modern Woodmen and MetLife that are not fully benefit-responsive and fair value is the relevant measurement. See Note 4.

The investment contract with Talcott is fully benefit responsive. Therefore, contract value is the relevant measurement, as reported to the Plan by Talcott, and represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to a plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under

the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

6. INCOME TAX STATUS

The Plan is based on a pre-approved plan which has received a favorable opinion letter from the Internal Revenue Service (IRS) that the plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for an opinion letter from the IRS. However, the plan administrator believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, as of the date the financial statements were available to be issued, there were no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for years prior to 2022.

7. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Professional fees and the majority of other administrative expenses of the Plan were paid by the Employer.

Investment management fees paid to EAIC, Talcott, Modern Woodmen and Met Life are included as a reduction of plan investment earnings. Third party administrator fees paid to Empower Retirement, LLC are included as a reduction of plan investment earnings. Morgan Stanley is the investment advisor for the Plan and receives payment from the Plan. Blue & Co., LLC is the independent auditor of the Plan and receives payment from the Employer for this service.
