## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Joe Daniels Construction Company, Inc. Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Joe Daniels Construction Company, Inc. Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - Joe Daniels Construction Company, Inc. Retirement Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through May 21, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Joe Daniels Construction Company, Inc. is the plan administrator, plan sponsor and employer. Matrix Trust Company ("Matrix") is the trustee of the plan that holds custody of the plan's investment assets. OneAmerica Retirement Services LLC ("OneAmerica") is the investment advisor, third party administrator that maintains participant investment records and performs various required compliance tests.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the fund. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

**Common/collective trust fund** - The plan invests in the OneAmerica Company Stable Value Z Fund Collective Investment Trust. The fund is a direct filing entity valued at the NAV based on the underlying unit value as reported by the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

### 2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

**General** - The plan was established as a defined contribution plan on May 4, 1987. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees over the age of eighteen, who are no longer in high school, are eligible to participate in the plan and receive employer contributions after one hour of service is completed.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (employee elective deferral contributions). In addition, participants age 50 or over can make catch-up contributions. The plan also permits Roth elective deferrals.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. The plan sponsor contributes \$4 per compensation hour to the plan for each participant.

**Participant accounts** - Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, and an allocation of employer contributions. Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage on the first day of each payroll period.

**Vesting** - Participants are 100% vested in all contributions and earnings thereon.

**Payment of benefits** - Benefit payments are recorded when paid and may commence upon termination of employment, death, disability or normal retirement age (60). Distributions may be in the form of a single lump sum or installment payments. In addition, hardship withdrawals are permitted under certain circumstances and in-service withdrawals can commence upon attaining the age of 59 1/2.

**Administrative expenses** - Certain administrative fees of the plan are paid by the plan sponsor. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Administrative expenses paid by the plan consist of participant directed charges for distribution and loan processing and non-participant directed fees for administrative and investment management services. Nonparticipant directed fees are allocated to the participants on an account value basis.

**Notes receivable from participants** - Participants may take out loans against their account. The minimum loan amount is \$1,000 and total outstanding loans cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. Participants can have up to two outstanding loans at any given time. The repayment term generally cannot exceed 5 years unless used for the purchase of a principal residence. As of December 31, 2024, loans outstanding had various repayment schedules through August 2029, with interest rates ranging from 2.88% to 8.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

**Excess contributions payable** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. The plan had excess contribution payable of \$4,964 and \$27,080 as of December 31, 2024 and 2023. The plan distributed the excess contributions to the applicable participants prior to March 15, 2025 and 2024.

### 3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by OneAmerica; therefore these transactions qualify as party-in-interest transactions. Direct fees paid by the plan to OneAmerica were \$39,169 in 2024 and \$41,240 in 2023. In addition, Matrix receives revenue from mutual fund service providers for services Matrix provides to the funds ("indirect compensation"). This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan to Matrix for its administrative services provided to the plan.

Notes receivable from participants transactions also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA.

### 5. INCOME TAX STATUS

The plan adopted a revised OneAmerica volume submitter plan that received a favorable opinion letter dated August 19, 2020. The opinion letter received from the Internal Revenue Service stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and OneAmerica believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

### 6. INFORMATION CERTIFIED BY TRUSTEE

Management has obtained certifications from Matrix, the trustee of the plan and a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held for the plan and the fair values of such and the notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividends and capital gain distributions from investments and net appreciation (depreciation) in fair value of investments and interest income on notes receivable during 2024 and 2023;
- c. Purchases and sales of investments during 2024 and 2023; and
- d. Contributions to, investment income credited to, benefits paid from and transfers between investment accounts during 2024 and 2023.
