To the Plan Administrator of
Guido's Quality Fruit & Produce 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Guido's Quality Fruit & Produce 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Guido's Quality Fruit & Produce 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section---

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of the Guido's Quality Fruit & Produce 401(k) Savings Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Guido's Quality Fruit & Produce 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



Note 1 - Description of Plan

The following description of the Guido's Quality Fruit & Produce 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan trust agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective December 1, 1985 and covers substantially all employees of the Guido's Quality Fruit & Produce (the "Company") who meet certain eligibility requirements. The Plan contains a safe harbor provision. Employees who are age twenty-one and have completed one year of service, as defined in the Plan, may contribute pre-tax or post-tax (as of May 1, 2021) deferrals of their wages into the Plan and will also share in the Company's matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer up to one-hundred percent (100%) of their compensation subject to Internal Revenue Code (IRC) limitations. Under the safe harbor provision, the Company contributes an employer match to the Plan equal to 100% of the participant's elective deferrals on the first 3% of compensation of the participant and 50% of the participant's elective deferrals between 3% and 5%. In addition, the Company may make an additional discretionary contribution to the Plan. There were no such discretionary contributions for the years ended November 30, 2024 or 2023. All contributions are invested as the participant directs.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution; (b) the Company's matching contribution; (c) Plan earnings; (d) forfeitures of terminated participants' non-vested accounts and (e) charged with an allocation of administration expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participant Loans

Participants may borrow from the Plan subject to certain limitations. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the participant's loan account. Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Loans are for a period not exceeding five years (thirty years if for the purchase of a principal residence) and bear interest based on prevailing market rates. Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans ranged from 4.25% to 9.5% at November 30, 2024 and 2023. There were \$90,485 and \$79,311 in outstanding loans as of November 30, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their deferred contributions, the safe harbor employer match and all actual earnings thereon. Vesting in the Company's discretionary contribution (if any) is based on the following schedule:

Note 2 - Summaries of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. In accordance with the policy of stating investments at fair value, net appreciation or depreciation for the year is reflected in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in the fair value of its investments consists of realized gains or losses and unrealized appreciation (depreciation) on those investments. Pooled separate accounts are valued at fair value which represent the net asset value of shares held by the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest and other investment income are recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income on notes receivable from participants is recorded on the accrual basis.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America and DOL rules and regulations for reporting and disclosure under ERISA require the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Administrative Expenses

The Company absorbs substantially all administrative costs related to the operation of the Plan at no charge to the Plan. Certain investment fees are paid by the Plan.

Forfeitures

As of the end of each Plan year, forfeitures which have become available during the Plan year shall be used first to restore forfeitures for any participants who have been rehired, then to pay plan expenses and lastly to reduce the safe harbor employer match. There were no forfeitures held by the Plan at November 30, 2024 or 2023.

Note 2 - continued

Payment of Benefits and Withdrawals

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or installments over an agreed upon period of time. Participants may withdraw their voluntary contributions at any time. They may withdraw the vested portion of any company contributions subject to restrictions or penalties as defined in the Plan trust agreement. Benefits are recorded when paid.

Note 3 - **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides a definition of fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access. The Plan has no Level 1 investments.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan has investments in pooled separate accounts which are considered Level 2 investments.

Level 3: Inputs that are unobservable for the asset or liability. The Plan has no Level 3 investments.

The fair value of the pooled separate accounts is determined based on the underlying mutual funds quoted net asset values of the shares as reported by the fund. The underlying mutual funds are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds must publish their daily net asset value and transact at that price.

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party Transactions and Party in Interest Transactions

Plan investments are shares of pooled separate accounts held by John Hancock. John Hancock serves as the custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to John Hancock amounted to \$51,835 and \$44,367 for the years ended November 30, 2024 and 2023, respectively.

Additionally, BEON Retirement provided third party administrator services to the plan, including preparing the Form 5500 annual return. Fees paid by the Plan to BEON Retirement, for the years ended November 30, 2024 and 2023, were \$2,000 and \$1,900, respectively.

Creative Planning LLC provides investment advisory services to the Plan. Total fees paid to this company for investment advisory services were \$40,560 and \$5,850 for the years ended November 30, 2024 and 2023, respectively. Kistler-Tiffany Advisors previously provided investment advisory services to the Plan. Total fees paid to this company for investment advisory services were \$28,851 for the year ended November 30, 2023.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8 - Subsequent Events

The Plan has evaluated subsequent events through June 4, 2025, the date on which the financial statements were available to be issued.
