## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of  
the AMA Transportation Co., Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of AMA Transportation Co., Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 5, 2024 and December 31, 2023, the related statements of changes in net assets available for benefits for the period January 1, 2024 through August 5, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 5, 2024 and December 31, 2023, and for the period January 1, 2024 through August 5, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the Financial Statements**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter**

As discussed in Note 1 to the financial statements, the Plan Committee approved the merger of the Plan into the Wadhams Enterprises, Inc. Employee Retirement Savings Plan. The merger was effective August 1, 2024, and all plan assets were transferred to the Wadhams Enterprises, Inc. Employee Retirement Savings Plan on August 5, 2024. Our opinion has not been modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the AMA Transportation Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of AMA Transportation Co., Inc. and AMA Warehousing and Distribution LLC (collectively, the Company) who are age 21 or older. Non-resident aliens are not eligible to participate in the Plan. All eligible employees are able to participate in the Plan on the first day of the month following the day the age requirement is met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

On August 1, 2024 the Plan Committee resolved to merge the Plan into the Wadhams Enterprises, Inc. Employee Retirement Savings Plan. As a result, net assets including notes receivable from participants, of \$6,876,675 were transferred to the control of Wadhams Enterprises, Inc. Employee Retirement Savings Plan effective August 5, 2024. The merger does not impact participant benefits as the benefit provisions were incorporated in the Wadhams Enterprises, Inc. Employee Retirement Savings Plan.

The Plan Committee approved the merger of the Plan into the Wadhams Enterprises, Inc. Employee Retirement Savings Plan. The merger was effective August 1, 2024, and all plan assets were transferred to the Wadhams Enterprises, Inc. Employee Retirement Savings Plan on August 5, 2024.

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Eligible participants may elect to designate their deferral contributions as Roth contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation. The deferral percentages are automatically increased by 1% annually, not to exceed 6%. Contributions are invested in accordance with the default investment option established by the Plan, unless the participants direct otherwise. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may make a discretionary matching contribution as determined each year by the Board of Directors. During the period January 1, 2024 through August 5, 2024 and the year ended December 31, 2023, the Company made a discretionary matching contribution equal to 25% of each participants' elective contribution up to a maximum of 1.5% of compensation.

The Company may also make a profit-sharing discretionary contribution each year, in an amount determined by the Company. In order for a participant to receive the non-elective contribution, the employee must have completed a minimum of 500 hours of service as defined in the plan agreement. There were no profit-sharing contributions made by the Company during the period January 1, 2024 through August 5, 2024 and the year ended December 31, 2023.

**Participant Accounts:** Each participant's account is credited with the participant's contribution, Company discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions vest through a six-year graded formula, as defined by the plan agreement. In the event of death, disability, or termination of the Plan, participants' accounts become fully vested.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is based on the prime rate of interest as of the date of the loan, plus 1 percent as defined in the plan agreement. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits:** On termination of service due to death, disability, retirement, or when a participant ceases to be an employee of the Company, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, in-service distributions, without penalty, may be made upon the attainment of age 59 ½. The Plan also allows hardship distributions under certain circumstances.

**Forfeitures:** Forfeitures of non-vested employer contributions are used to pay Plan expenses or reduce employer contributions. As of August 5, 2024, there were no unallocated forfeitures (\$605 - 2023). During the period January 1, 2024 through August 5, 2024, the Plan used \$605 of forfeitures (\$7,710 - 2023).

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan agreement.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Payment of Benefits:** Benefit payments are recorded when paid.

**Subsequent Events:** These financial statements have not been updated for subsequent events occurring after June 10, 2025, which is the date these financial statements were available to be issued.

#### NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820: *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of August 5, 2024 and December 31, 2023.

**Mutual funds:** Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is the closing price reported on the active market on which the securities are traded. Mutual funds are classified as Level 1 investments.

**Common collective trusts:** Valued at the NAV of units of the common collective trusts. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**Money market funds:** Valued at cost plus interest, which approximates fair value.

**NOTE 4. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity Personal Trust Company, FSB (Fidelity). Fidelity is the trustee as defined by the Plan and, therefore, transactions with Fidelity qualify as party-in-interest. As of December 31, 2023 the Plan also held notes receivable representing participant loans which qualify as party-in-interest transactions.

**NOTE 5. TAX STATUS**

Effective January 1, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by Sentinel Benefits Group, Inc. The pre-approved plan has received an opinion letter from the IRS dated November 30, 2020 regarding the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. Although this Plan has been amended, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 7. FINANCIAL CERTIFICATION

The following financial information regarding the Plan's assets as of August 5, 2024 and December 31, 2023, as well as income and transactions for the period January 1, 2024 through August 5, 2024 and the year ended December 31, 2023, has been furnished by the Plan Administrator and certified as complete and accurate by the custodian, Fidelity. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent accountants.
