Scope and Nature of the ERISA Section 103(a)(3)(C)

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Virginia Panel Corporation Profit Sharing and 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of August 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the Virginia Panel Corporation Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Virginia Panel Corporation (the “Company”) who have completed six months of service. Union, nonresident alien, and leased employees are excluded from participation, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees may contribute up to 90% of their annual compensation as pre-tax or Roth deferrals, as defined by the Plan, not to exceed the maximum allowable under the *Internal Revenue Code (IRC)*. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may also contribute a discretionary matching contribution. The Company matched 200% of the first \$400 of employee deferrals and 25% of the next \$2,000 of employee deferrals for the years ended August 31, 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company also has the option to make a discretionary profit-sharing contribution. The profit-sharing contribution was \$1,140,995 and \$1,047,452 for the years ended August 31, 2024 and 2023, respectively. In order to receive the Company’s discretionary profit-sharing contribution, the participants must have worked a minimum of 1,000 hours during the current Plan year and be employed with the Company on the last day of the Plan year, as defined. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching and discretionary profit-sharing contributions, an allocation of the Plan earnings, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions, plus actual earnings thereon. Vesting in the Company’s matching and discretionary profit-sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in matching contributions after three years of credited service.

Payment of Benefits

A participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, a partial withdrawal, or annual installments not exceeding the life expectancy of the participant. If the participant’s balance is under \$5,000 upon termination, the participant’s vested interest in his or her account will be automatically distributed. In-service withdrawals are generally limited to participants age 59½ or older.

Administrative Fees

Administrative fees incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis. Certain expenses of maintaining the Plan are paid directly by the Company. Administrative expenses and investment fees were paid by the Plan for the year ended August 31, 2024.

Notes from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless used for the purchase of a principal residence. Only one loan per participant may be outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at market rates as determined by the Plan Administrator. At August 31, 2024, the interest rate on loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

As of August 31, 2024 and 2023, there were \$46,759 and \$34,788, respectively, in forfeited non-vested accounts. Forfeitures are first used to reduce Plan administrative expenses or employer contributions, and then the remaining balance is allocated to participants who have worked a minimum of 1,000 hours during the current Plan year and are employed with the Company on the last day of the Plan's year, as defined. Forfeitures of \$24,384 and \$12,268 were used to reduce employer contributions for the years ended August 31, 2024 and 2023, respectively. No forfeitures were allocated to participants for the years ended August 31, 2024 and 2023.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Evaluation of subsequent events was considered through June 9, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 4 – Investment Contracts

As of August 31, 2024 and 2023, the Plan had investments in the Galliard Stable Return Fund Class C, which reports on the calendar year. Included in this fund are traditional investment contracts and certain wrapper contracts. These contracts are considered to be benefit responsive and are required to be stated at fair value. The average yield for the fund was approximately 4.92% and 4.94% for the calendar year ended December 31, 2023 and 2022, respectively. The objective of the fund is to provide a moderate level of stable income without principal volatility. The percentage of contributions allocated to this fund is determined by the participants.

Note 5 – Related Party Transactions and Party-In-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. The employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments in funds issued and managed by the Plan Trustee. Investments in funds issued by the Plan Trustee are considered related party transactions. The Plan uses LPL Financial as an investment advisor. Fees paid by the Plan to related parties amounted to \$70,196 for the year ended August 31, 2024.

ADP provides certain administrative services to the Plan pursuant to an Administrative Services Agreement between the Company and ADP. ADP is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Revenue credits generally represent the return of excess revenue generated by the Plan based upon the terms of the Administrative Services Agreement. Revenue credits are deposited into the Plan's ERISA Budget Account and may be used to pay reasonable and necessary Plan expenses. The Plan Sponsor may make a payment to ADP for administrative expenses not covered by revenue credits. In addition, the Plan may receive other Plan servicing credits which can be used to offset Plan servicing fees, as defined. Administrative expenses are presented net of \$70,196 credits received during the year ended August 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Company does terminate the Plan, the participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan adopted a non-standardized prototype plan sponsored by the ADP, LLC and has not requested a determination letter but rather has relied upon the Internal Revenue Service opinion letter dated October 6, 2020 issued on the prototype plan stating the Plan is designed in accordance with applicable sections of the *IRC*. The Company believes the Plan is currently being operated in compliance with the applicable requirements of the *IRC* and therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8 – Certification
