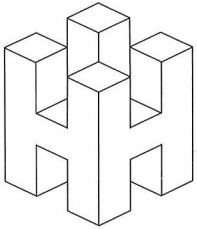

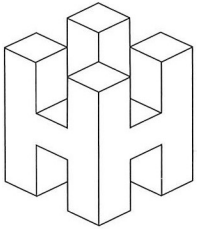

Opinion

We have audited the accompanying financial statements of WILSON TRAILER COMPANY HEALTH CARE PLAN FOR S EMPLOYEES, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Wilson Trailer Company Health Care Plan For S Employees as of August 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

AUGUST 31, 2024 AND 2023

Note 1 - PLAN DESCRIPTION

The following description of the Wilson Trailer Company Health Care Plan for S Employees (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health and short-term disability benefits for certain eligible employees and covered dependents as specified in the Plan agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health and short-term disability benefits to full-time employees (working at least 30 hours per week) upon the completion of 60 calendar days following the date of employment. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-Insured Benefits

All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor. The claims processors pay claims directly to or on behalf of the participants and are then reimbursed by the Plan's trust.

Stop Loss Coverage

Health benefits in excess of \$300,000 per participant are reimbursed by a stop loss coverage obtained from a reinsurance carrier.

Contributions

Contribution amounts for the participant are established by the sponsor and deducted from the participant's pay. These funds are remitted, along with the employer's contribution, to a trust fund.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Benefits Payable

Claim payments are recorded when paid by the third-party claims processor. Amounts due to the claims processor that have not been reimbursed by the Plan are recorded as claims payable in the accompanying statements of net assets available for benefits and benefit obligations.

Stop Loss

Premiums for stop loss insurance are included in reinsurance premiums, and stop loss refunds are included in reinsurance reimbursement in the accompanying statement of changes in net assets available for benefits and benefit obligations.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Rebates

Rebates due from the Plan's pharmacy benefit manager are recorded when earned.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Note 3 - RELATED PARTY RECEIVABLES AND PAYABLES

Premiums Receivable from the Sponsor were \$259,017 and \$271,458 at August 31, 2024 and 2023, respectively.

The Sponsor has advanced funds to the Plan for certain expenses during the year. The advances bear no interest. Amounts due to the Sponsor from the Plan were \$56,536 and \$33,932 at August 31, 2024 and 2023, respectively.

The Plan also has several arrangements with service providers as described in Notes 1 and 5. These transactions are party in interest transactions under ERISA.

Note 4 - CLAIMS INCURRED BUT NOT REPORTED

Liabilities for claims incurred but not reported, as of August 31, 2024 and 2023, were \$240,000 and \$220,000, respectively. These amounts were estimated based on actual claims paid during the year and historical percentages of claims paid in the year after the date of the claim. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Note 5 - ADMINISTRATIVE EXPENSES AND PROFESSIONAL FEES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. Professional fees consist of audit fees and consulting fees paid to third-parties. These expenses are reported on the statement of changes in net assets available for benefits and benefit obligations.

The above costs are considered to be parties in interest transactions.

Note 6 - TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 7 - RISKS AND UNCERTAINTIES

At times during the year, the Plan's cash and equivalents balances may exceed amounts insured by the Federal Deposit Insurance Corporation. The Plan does not believe it is exposed to any significant credit risk on cash and equivalents.

The value of claims incurred not reported are based on certain assumptions which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8 - INCOME TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)9 of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable determination letter from the Internal Revenue Service, and the Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. As such, income earned in the performance of its exempt purpose is not subject to income tax and accordingly, the financial statements do not reflect a provision for income taxes.

Management has concluded that any uncertain tax positions would be immaterial to the financial statements taken as a whole. Accordingly, the accompanying financial statements do not include any provision for uncertain tax positions, and no related interest or penalties have been recorded.

Note 9 - SUBSEQUENT EVENTS

In preparing the financial statements, the Plan has evaluated all subsequent events, for potential recognition or disclosure, through, June 11, 2025, the date the financial statements were available to be issued.
