## Independent Auditors' Report

The Trustees

Cooper Steel Employee Savings and Retirement Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Cooper Steel Employee Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

### (1) Description of plan

The following description of the Cooper Steel Employee Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for all employees of Cooper Steel Fabricators, Inc., Cooper Steel of Virginia, LLC, Cooper Steel South, LLC, and Veloture Development Group, LLC (collectively, the "Plan Sponsor"), who are age 21 or older and have completed one year of service ("participants"). Effective September 1, 2024, the Plan was amended to lower the age requirement to participate in the Plan to 18 years old while retaining all other eligibility requirements. Union employees, nonresident aliens, interns and students are excluded from participating in the Plan. Once eligibility requirements are met, employees may enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. In order to participate, employees must make a minimum contribution of 1% of compensation. Participant contributions are permitted up to 100% of compensation subject to certain IRC limitations. Participants who have attained age 50, may defer an additional "catch-up" contribution.

The Plan provides that the Plan Sponsor may make discretionary matching contributions equal to a percentage as determined by the Plan Sponsor. The Plan Sponsor elected to make a 6% match for 2024 and 2023. Plan Sponsor contributions may not exceed the maximum amount deductible for federal income tax purposes.

Effective September 1, 2024 the Plan was amended in which the Plan Sponsor replaced the discretionary matching contributions with safe harbor matching contributions equal to 100% of each eligible participant's elective deferrals that do not exceed 6% of the participant's compensation. Plan Sponsor contributions may not exceed the maximum amount deductible for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's and Plan Sponsor's matching contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's matching contributions are based on years of continuous service (20% after 2 years and then 20% annually thereafter). Participants are fully vested after six years of credited service. Effective September 1, 2024, the Plan was amended in which the Plan Sponsor replaced discretionary matching contributions with safe harbor matching contributions. Participants are immediately vested in Plan Sponsor safe harbor matching contributions plus actual earnings or losses thereon.

(e) Notes receivable from participants

Participants may borrow from their account balances at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their nonforfeitable account balance. The notes are secured by the balances in the respective participants' accounts and bear interest at a fixed rate equal to 1% above the prime rate (4.25% - 9.50%). Principal and interest are paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution. Participants become fully vested upon death or total disability. Prior to December 31, 2023, if the participant's account is less than \$5,000, the total vested balance is distributed as an automatic lump-sum payment in cash. Effective for distributions made after December 31, 2023, under the SECURE 2.0 Act of 2022, if the participant's account is less than \$7,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures are utilized to reduce Plan expenses or reduce the Plan Sponsor's contributions to the Plan. At August 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,471 and \$3,074, respectively. Forfeitures of \$51,775 and \$39,610 were used in 2024 and 2023, respectively.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if a participant is younger than age 59½. Hardship withdrawals are available from all of a participant's account.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment advisory fees, recordkeeping fees and fees related to the processing of loans and distributions are included in administrative expenses and charged directly to the applicable participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value or contract value as report by CMFG Life Insurance Company ("CMFG") and Matrix Trust Company ("Matrix"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by CMFG and Matrix. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after the reporting date

The Plan Sponsor has evaluated events and transactions that occurred between August 31, 2024 and June 11, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Information related to investments reported and disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and contract value and notes receivable from participants at August 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by CMFG and Matrix as of August 31, 2024 and 2023 respectively.

(4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

- (i) *Money market fund*: Valued at the net asset value of shares held by the Plan at year end. The money market fund is redeemable daily and there are no restrictions on redemptions.
- (ii) *Mutual funds*: Valued based on the funds' reported closing net asset values of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Investment contract with insurance company

The Plan has entered into a guaranteed investment account agreement with an insurance company, CMFG Life Insurance Company. The contract is a fixed, deferred group annuity available to qualified retirement plans. It provides guaranteed protection of principal with a set rate of return. The fund seeks a high level of current income consistent with preservation of capital by investing primarily in corporate bonds, mortgage-backed securities, collateralized mortgage obligations, high quality commercial mortgage loans, municipal bonds and other high-grade fixed income securities.

As of August 31, 2024 and 2023, the contract value of the investment in the guaranteed account was \$224,949 and \$1,217,420 respectively.

#### (6) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 30, 2020, which stated that the Plan is designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) Related party and party-in-interest transactions**

Certain Plan investments are shares of a guaranteed investment account managed by CMFG for the years ended August 31, 2024 and 2023 and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers, and holds notes receivable from participants, which also qualify as party-in-interest transactions.

**(8) Risks and uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
