To the Trustees of

Opinion

We have audited the accompanying financial statements of Hub City Ford, Inc. Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF PLAN

The following description of Hub City Ford, Inc. Employee Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a) General
The Plan is a defined contribution plan covering employees who have attained six months of service and age twenty and a half. This plan excludes certain employees covered by a collective bargaining agreement and non-resident aliens with no U.S. income. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b) Contributions – Participants
A participant may make contributions to the Plan of any amount up to the maximum percentage of compensation and dollar amount allowed by law with certain limitations adjusted annually for inflation.
- c) Contributions – Employer
Employer contributions to the Plan are at the discretion of the Company's management. For the years ended August 31, 2024 and 2023, the Company made contributions of \$186,980 and \$172,894, respectively.
- Participant Accounts
- d) Each participant's account is credited with the participant's and employer's contributions and allocation of Plan earnings. Allocations are based on participant account balances.
- Vesting
- e) Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as shown below:

f) Payment of Benefits

Distributions as a result of death, disability, or retirement may be made as soon as administratively feasible. All other termination distributions will be made as soon as administratively feasible after the close of the plan year. Participants may elect to receive a lump-sum amount or installment payments equal to the value of his or her vested account.

g) Forfeited Accounts

As of August 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,477 and \$4,386, respectively. These accounts will be used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$4,211 and \$0 from the forfeited non-vested accounts, respectively.

h) Investment Options

Participant and employer contributions in various investment options are non-participant directed. The Board of Trustees for the Plan is responsible for all investment decisions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for insurance contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to insurance contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for discussion of fair value measurements. See Note 5 for discussion of insurance information.

Interest income is recorded on the accrual basis.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Cash Equivalents

The Plan considers all highly liquid investments purchased with a maturity of three months or less to be cash equivalents.

Credit Risk

Financial instruments which potentially subject the Plan to concentrations of credit risk include cash investments. The Plan maintains a cash account at a local commercial bank. The bank account is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At August 31, 2024, the balance was fully insured.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid directly by the plan sponsor and are excluded from the financial statements.

Prior Year Reclassification

Certain amounts in the prior year financial statements have been reclassified to conform with the current year presentation. Such reclassifications had no effect on net assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through May 13, 2025, which is the date the Financial Statements were available to be issued.

NOTE 3: TAX STATUS

The prototype plan document used by the third-party administrator obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 3: TAX STATUS *(continued)*

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

NOTE 4: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5: INVESTMENTS WITH INSURANCE COMPANIES

The following annuity contracts mature at the earlier of the annuity starting dates as indicated below or upon the death of D. E. Citron, III or Todd G. Citron, trustees of the Plan. The accounts are credited with actual earnings on the underlying investments and charged for any applicable premium taxes.

On January 27, 2021, the Plan entered into an additional single premium deferred annuity contract (#70023414) with American National Insurance Company, maturing on January 27, 2067. The current interest rate is 2.45%. The earliest surrender date without penalty is January 27, 2027. On June 26, 2023, the Plan entered into a single premium deferred annuity contract (#70036384) with American National Insurance Company, maturing on June 26, 2066. The current interest rate is 5.45%. The earliest surrender date without penalty is June 26, 2030. On August 17, 2023, the Plan entered into a single premium deferred annuity contract (#70037181) with American National Insurance Company, maturing on August 17, 2066. The current interest rate is 5.45%. The earliest surrender date without penalty is August 17, 2030. On April 11, 2024 the Plan entered into an additional single premium deferred annuity contract (#1A000519) with American National Insurance Company, maturing on April 11, 2067. The current interest rate is 5.55%. The earliest surrender date without penalty is April 11, 2035.

On January 21, 2021, the Plan entered into an additional single premium deferred annuity contract (#ATMIP08660) with Reliance Standard Life Insurance Company, maturing on January 21, 2052. The current interest rate is 2.10%. The earliest surrender date without penalty is January 21, 2026.

On November 10, 2021, the Plan entered into a single premium deferred annuity contract (#HV00026572) with Oceanview Life and Annuity Company, maturing on January 1, 2061. The current interest rate is 2.60%. The earliest surrender date without penalty is November 10, 2026.

On November 1, 2022, the Plan entered into a single premium deferred annuity contract (#016423620) with Nationwide Life Insurance Company, maturing on May 15, 2061. The current interest rate is 5.15%. The earliest surrender date without penalty is November 1, 2027. On November 10, 2022, the Plan entered into a single premium deferred annuity contract (#016423623) with Nationwide Life Insurance Company, maturing on May 15, 2061. The current interest rate is 5.15%. The earliest surrender date without penalty is November 10, 2027.

On December 2, 2022, the Plan entered into a single premium deferred annuity contract (#1410136X) with Life Insurance Company of the Southwest, maturing on December 2, 2065. The current interest rate is 5.25%. The earliest surrender date without penalty is December 2, 2027. On June 12, 2023, the Plan entered into a single premium deferred annuity contract (#1442621X) with Life Insurance Company of the Southwest, maturing on June 12, 2065. The current interest rate is 5.25%. The earliest surrender date without penalty is June 12, 2027.

NOTE 6: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Corporate debt instrument. Valued using pricing models maximizing the use of observable inputs for the security. This includes basing values on interest rates currently available through Ford Credit pricing supplements to their prospectus.

NOTE 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan provisions to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, any surrender charges will be allocated to plan participants in the same manner as earnings and participants will become 100 percent vested in their accounts.

NOTE 10: PLAN AMENDMENTS

During 2022, the SECURE 2.0 Act was passed, which expanded on provisions passed in the SECURE Act of 2019 and included new provisions that made improvements to retirement savings options. During 2023, the Plan implemented the required provisions of the SECURE 2.0 Act, which includes reducing required minimum distribution penalties and increasing the age for required minimum distributions to age 73. Formal amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable laws and IRS guidance.
