Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Southern HVAC Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF PLAN

The following description of the Southern HVAC Corporation 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the official Plan document for complete information.

General

The Plan was established in January 2022 by Southern HVAC Corporation through the transfer of eligible participants' balances from another qualified plan. The Plan is a defined contribution employee benefit plan that provides for tax-deferred savings contributions from participants as well as matching contributions from Southern HVAC Corporation and any adopting employers (collectively referred to as the Company or Employer). All employees of the Company are eligible to participate in the Plan, except for employees covered by a collective bargaining agreement, leased employees and nonresident aliens with no U.S. income.

Eligibility

Eligible employees of the Company are eligible to participate in the Plan upon completion of one year of service and attainment of age 18 effective September 2023. Prior to September 2023, the attainment of age 21 was required for participation in the Plan. Employer matching contributions begin concurrently with employee contributions.

Contributions

Participants may elect to make contributions of their eligible earnings under the savings feature of the Plan, subject to Internal Revenue Code (IRC) limitations. The Company provides a safe harbor match of 100% of the first 3% plus 50% between 3% and 5% of compensation deferred. The Company may also make discretionary nonelective contributions to the Plan. For the year ended December 31, 2024, there were no discretionary contributions made to the Plan.

The Plan includes a Roth 401(k) feature. Participants may direct their contributions to accounts as pre-tax or the Roth 401(k) terms or both.

This agreement will remain in effect until it is revoked by the participant or Plan administrator.

Participant Accounts

Individual accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and an allocation of fees. Investment income is allocated to participants based upon relative balances of the individual accounts at the prior valuation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant's interest in Company safe harbor matching contributions to his or her account is always 100% vested. All other Company contributions will be 100% vested ratable at 20% a year after year two and 100% after completion of six years of service. Each participant's interest in all other accounts is at all times fully vested and nonforfeitable. There were no forfeited nonvested accounts as of December 31, 2024 and 2023.

Withdrawals and Distributions

Generally, a participant's vested account balance is payable by lump-sum distribution, between ages 59½ and 72, upon his/her retirement or disability. Upon termination of employment, the vested portion of the participant's account may be withdrawn in a lump sum.

Plan Administration

Delaware Charter and Guarantee Trust Company (d/b/a Principal Trust Company) and Principal Life Insurance Company serve as custodians of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount generally equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable transactions are treated as transfers between the participants' fund balance and the loan fund. Notes must be repaid, through payroll deductions, within five years unless such note is used to acquire a primary residence, in which case the note is for a reasonable term as defined by the Plan.

Administrative Expenses

Expenses incurred in the reasonable administration of the Plan shall be paid from the Plan unless otherwise paid by the Employer.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of

investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as held at year-end. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. In addition, certain fees related to participant-directed transactions such as distribution processing fees, hardship withdrawal service fees and enhanced qualified domestic relations order review fees and processing fees are charged directly to the participant's account and are included in administrative expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Defaulted notes receivable are treated as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

3. FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: These investments are valued at the net asset value (NAV) of shares held by the Plan at year-end. The NAV is a quoted price in an active market and these funds are classified within Level 1 of the valuation hierarchy.

Pooled separate account (PSA): The Plan's interest in this investment is valued at the NAV provided by the fund's trustee or custodian as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSA can be redeemed daily and there are no associated unfunded commitments related to these investments.

Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments or redemption restrictions for participants in the Plan who invest in these accounts.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION CERTIFIED BY THE CUSTODIANS

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodians of the Plan.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts managed by the custodians. The Plan paid fees to the recordkeeper as well as investment advisor and third party administrator which are reflected in administrative fees for the year ended December 31, 2024 and 2023. These are considered exempt party-in-interest transactions with respect to the Plan. These transactions are not considered "prohibited transactions" under the IRC or ERISA. In addition, in 2024, the Plan entered into revenue sharing agreement with Principal whereby the revenue sharing will be utilized to set up an ERISA budget account to pay fees of the Plan. As of December 31, 2024, the ERISA budget amount was approximately \$14,000.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

7. TAX STATUS

The Plan has adopted a prototype document sponsored by Florida Retirement Consultants (FRC). The Internal Revenue Service (IRS) has determined and informed the FRC by an opinion letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. The prototype plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through April 29, 2025, which is the date the financial statements were available to be issued and have determined that there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
