## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Stein Garden Centers, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### NOTE 1 - DESCRIPTION OF PLAN

---

Stein Garden Centers, Inc. 401(k) Plan (the Plan) is a defined contribution plan sponsored by Stein Garden Centers, Inc. (the Company). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that covers substantially all employees of the Company who have reached twenty-one years of age and have completed a minimum of 1,000 service hours in one year, starting on the employee's date of hire. If 1,000 hours were not attained during the one year period, the employee will have completed a year of service at the end of any following plan year in which the employee was credited with 1,000 hours of service. Employees can join the Plan on the 1<sup>st</sup> of the quarter coinciding with or next following the attainment of these requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

The Plan provides for voluntary pre-tax and ROTH employee contributions of 1% to 100% of compensation, up to the maximum amount allowed by law. The Plan allows for catch-up contributions for those participants age fifty or older. Contributions are subject to certain limitations as established by the Internal Revenue Code (IRC). During 2024 and 2023, the Company made a safe harbor matching contribution equal to 100% up to 3% and 50% of the next 2% of the participant's contribution. The Plan allows discretionary Company nonelective contributions. The discretionary Company nonelective contribution is allowed for all eligible participants employed on the last day of the Plan year who have completed 1,000 hours of service in the Plan year. The Company did not make a discretionary Company nonelective contribution for the years ended December 31, 2024 and 2023. Contributions from Plan participants and the related matching contribution from the employer are recorded in the year in which participant compensation is earned.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings, and charged with the withdrawals and an allocation of Plan losses and expenses. Allocations are based on Plan earnings or participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant directed.

#### **Investment Options**

Participants may direct employee and employer contributions in any of several investment options. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant Directed Account Arrangement.

#### **Vesting**

Participants are immediately fully vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the discretionary Company nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A year of service is a vesting service period in which a participant has at least 1,000 hours of service. Participants become fully vested in their account balances upon retirement, death, or disability, as defined by the Plan.

Company discretionary nonelective contributions are vested on a six-year schedule as follows:

### ***Plan Expenses***

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Recordkeeping fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are not included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum amount, direct rollover equal to the value of his or her account, or elect to receive a partial distribution of a portion of the vested account balance. For account balances over \$1,000, the vested benefit is automatically rolled over to an IRA. For account balances \$7,000 or less, participant consent is not required and the entire vested benefit is distributed in a lump-sum as soon as administratively feasible following the participant's termination of service unless the participant elects an alternative form of distribution. Participants with vested account balances available for distribution exceeding \$7,000 can choose to receive their distribution as a lump-sum distribution. In-service distributions are allowed under certain circumstances as described in the Plan agreement.

### ***Notes Receivable from Participants***

The Plan allows for participants to borrow a minimum of \$1,000 from their account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate, plus 1%. Once the participant loan rate is established, that rate of interest will be fixed for the life of the loan. Principal and interest are paid ratably through payroll deductions.

### ***Forfeitures***

Forfeitures may be used to reduce employer contributions, allocated as an additional discretionary employer contribution, or pay for plan expenses. During 2024 and 2023, forfeitures used to reduce employer contributions were \$417 and \$2,604. There were outstanding forfeitures of \$22 and \$438 as of December 31, 2024 and 2023, respectively.

---

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### ***Risks and Uncertainties***

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

### ***Valuation of Investments and Income Recognition***

The Plan's investments are reported at their fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Realized gains (losses) and unrealized appreciation (depreciation) are recorded in the accompanying financial statements as net appreciation in fair value of investments. Realized gains (losses) on investment transactions are recorded as the difference between proceeds received and the carrying value of the investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### ***Notes Receivable from Participants***

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the delinquent participant note receivable is recorded on the Form 5500 as a benefit payment based on the terms of the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

---

### **NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)**

---

The Plan administrator has elected the method of annual reporting compliance allowed by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian with information included in the Plan's financial statements and supplemental schedule:

- a) Investments as disclosed in the Statements of Net Assets Available for Benefits.
- b) Interest and dividend income and the net appreciation in the fair value of investments as disclosed in the Statements of Changes in Net Assets Available for Benefits.
- c) The Schedule of Assets (Held at End of Year).

The Plan's independent auditors performed limited auditing procedures with respect to this information, including comparing such information to the related information included in the financial statements and supplemental schedule.

---

**NOTE 4 - FAIR VALUE MEASUREMENTS**

---

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of unobservable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses the appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available.

***Level 1 Fair Value Measurements***

The fair values of mutual funds are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

There were no significant transfers between level 1 and level 2 investments during the year ended December 31, 2024.

In accordance with Subtopic 820-10, certain investments that are measured at net asset value per share have not been classified in the fair value hierarchy. These investments are presented at fair value but do not fall within any levels established in the fair value hierarchy.

#### **NOTE 5 - PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

---

#### **NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

---

The Plan participates in an investment contract with Transamerica Life Insurance Company (Transamerica). Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The effective annual rate of interest is established every January 1 and July 1. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six month period. There is no stated minimum or maximum interest rate.

Certain events limit the Plan's ability to transact with Transamerica. Such events include the following: (a) the Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code, (b) the establishment of a defined contribution plan that competes with the Plan for employee contributions, (c) any substantive modification of the portfolio or the administration of the portfolio that is not consented to by the wrap issuer, (d) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on the portfolio's cash flow, (e) any communication given to participants by the plan sponsor, any other plan fiduciary, or Transamerica that is designed to influence participants not to invest in the portfolio or to transfer assets out of the portfolio, or (f) any transfer of assets from the portfolio directly to a competing investment option. The Plan administrator does not believe that any of the events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

---

**NOTE 7 - TAX STATUS**

---

The Plan, which is a non-standardized pre-approved profit sharing/money purchase/CODA plan, obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan is qualified and tax-exempt at the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

---

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

---

Certain plan investments are managed by Transamerica, an affiliate of Reliance Trust Company, the custodian, and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

---

**NOTE 9 - SECURE ACT 2.0**

---

SECURE Act 2.0 includes provisions that are both mandatory and voluntary. The Plan adopted certain provisions of the SECURE Act 2.0 and has until 2026 to formally amend the Plan with these provisions.

---

**NOTE 10 - SUBSEQUENT EVENTS**

---

Management has evaluated subsequent events through May 28, 2025, the date on which the financial statements were available to be issued.
