- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

Other Matters

Note 1. Description of the Plan

The following description of PAP Technologies, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan that is available to all eligible employees of PAP Technologies, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended and restated effective June 1, 2023. Union eligible employees are not eligible for this plan but are eligible for the union plan.

Eligibility: Employees are eligible to participate in the Plan on their date of hire. Effective April 1, 2023, eligible employees may enter the Plan immediately following the completion of eligibility requirements. Prior to April 1, 2023, eligible employees could enter the Plan on the first day of the month after the date the eligibility requirements are satisfied. Employees are eligible to receive employer matching contributions immediately upon entering the plan. A participant must complete 1,000 hours of service throughout the year and be employed on the last day of the Plan year to be eligible for the employer's profit sharing contribution, with the exception of death, permanent disability and retirement.

Contributions: Each year, participants may contribute up to 85% of compensation, subject to annual dollar limitations imposed by the Internal Revenue Code. The Plan has an automatic enrollment provision whereby participants will automatically have 1% of their pre-tax compensation deferred into the Plan, unless they elect otherwise.

Participants may make two types of elective deferrals, regular 401(k) deferrals which reduce taxable income, or Roth 401(k) deferrals, which are subject to federal income taxes in the year of deferral. Participants aged fifty or over may elect to defer additional (catch-up) amounts. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Employer matching and profit-sharing contributions are discretionary and determined annually by the Company's Board of Directors. Currently, the Company will match twenty-five cents (\$.25) for each dollar (\$1) of contributions by each eligible participant that does not exceed 4% of compensation for each payroll period. Beginning on December 1, 2021, the total amount of employer matching contributions allocated to a participant in any plan year will be limited to 1.00% of plan compensation. Allocation of any profit-sharing contribution among eligible participants, who must be employed on the last day of the Plan year, is determined by the Plan Sponsor. Contributions are subject to certain limitations.

Participant Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment allocations at any time.

Accounts: Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of Plan earnings or losses and administrative expenses. Plan earnings or losses are allocated according to the participant's relative account balance in the various investment options. Participants' accounts are valued daily and adjusted to reflect market gains or losses, as appropriate. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Note 1. Description of the Plan (Continued)

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions are based on years of service. After two years of service, a participant is vested at twenty percent (20%). Vesting increases twenty percent (20%) per year thereafter until fully vested after six years of service. Participant accounts become fully vested upon retirement at age 65, permanent disability or death.

Participant Loans: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have no more than two loans outstanding at any time, and only one loan outstanding for any new loan requests. Loan terms may not exceed sixty months, but a longer term (up to ten years) is permitted if used for the purchase of a principal residence. Interest is computed based on the prime interest rate plus one percentage point determined at the date of the loan request. While an employee, the loan must be repaid via payroll withholdings. Various default and curative provisions are contained within the written loan policy of the Plan.

Payment of Benefits: Upon termination of service due to death, disability or normal retirement at age 65, a participant or their beneficiary may elect to receive vested benefits in a lump sum or in annual installments. Participants with vested account balances of less than \$5,000 are eligible to receive a lump sum distribution. Participants with vested account balances between \$1,000 and \$5,000 who do not consent to a distribution are automatically rolled over into an IRA selected by the Plan administrator. In-service distributions are available to participants after reaching the age of 59 ½, if the participant is fully vested in the source from which the withdrawal is taken. Hardship withdrawals are also permitted subject to limitations as to amounts and types of contributions that may be withdrawn.

Forfeited Accounts: Forfeitures represent unallocated employer contributions resulting from the termination of participants with less than fully vested benefits under the Plan. Forfeitures may be used to pay administrative expenses, allocated as additional employer contributions or used to reduce employer contributions. Forfeited non-vested accounts at November 30, 2024 and 2023, totaled \$9,772 and \$3,852, respectively. During 2024, forfeitures in the amount of \$4,386 were used to offset the employer profit sharing contribution.

Administrative Expenses: All significant costs to administer the Plan are paid by the Plan if not paid by the Company.

Note 2. Summary of Significant Accounting Policies

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid for transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through June 6, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Trustee/Custodian

Certain information related to investments is disclosed in the accompanying financial statements, including investments held at November 30, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended November 30, 2024, was obtained by management and agreed to information certified by Mid Atlantic Trust Company (MATC), (the Plan's current Trustee).

Certain information related to notes receivable from participants is disclosed in the accompanying financial statements, held at November 30, 2024 and 2023, and interest income on notes receivable from participants for the year ended November 30, 2024, was obtained by management and agreed to information certified by Mutual of America Life Insurance Company.

Note 4. Investments and Fair Value Measurements

The Plan measures, on a recurring basis, its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

Following is a description of the valuation methodologies used for plan assets at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

Registered investment companies: Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: The Plan invests in an investment contract through a collective investment trust (CIT), Invesco Stable Value Trust Portfolio Class A1 Fund. The collective investment trust is valued based upon the net asset value (NAV) per unit times the number of units held by the Plan at year-end. Net asset value is used as a practical expedient to estimate fair value of collective trusts because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value.

Invesco Trust Company offers a stable value option with the CIT. Investments are valued at market close on the last calendar day of the period. It is the policy of the Portfolio to maintain a stable net asset value (NAV) of \$1.00 per unit, although there is no guarantee that the Portfolio will be able to maintain this value. In accordance with valuation policies and procedures approved by the Trustee, the Portfolio attempts to obtain prices from one or more third party pricing vendors or brokers to value its investments. When current market prices or quotations are not readily available or reliable, securities will be fair valued in good faith by the FMTC Fair Value Committee (the Committee), in accordance with procedures adopted by the Trustee.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

The Plan's common collective trust was invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including fixed income style funds.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6. Related Party and Party-in-Interest Transactions

Plan investments held at November 30, 2024, include shares of mutual funds and a collective investment trust managed by Mid Atlantic Trust Company. Mid Atlantic Trust Company is the current Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 7. Tax Status

Effective October 1, 2022, the Plan adopted a profit-sharing plan with cash or deferred arrangement (a non-standardized pre-approved plan) sponsored by Mutual of America Financial Group. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated November 30, 2020, that the pre-approved plan as then designed, was in compliance with the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended subsequently, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
