***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Foundation for Educational Services Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Foundation for Educational Services Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Foundation for Educational Services Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of the Foundation for Educational Services Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan, which became effective January 1, 1985, and was most recently restated on July 1, 2022, is a defined contribution plan covering certain groups of employees of Foundation for Educational Services, Inc. (Plan Sponsor) who have completed 90 days of continuous employment with at least 1 hour of service and have attained 19 years of age. Entry is available on the first day of each quarter subsequent to the employee's completion of the participation requirements. Related employers who also participate in the Plan include Nebraska Student Loan Program, Inc., EducationQuest Foundation, Inc., Collegiate Financial Services, Inc., Foundation for Educational Funding II, Inc., FES, LLC, and Inceptia. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Elective Contributions.** Each year eligible employees may make pre-tax salary and Roth reduction contributions to the Plan of up to 85% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed Internal Revenue Code limitations. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 18 mutual funds, ten common trusts, and a self-directed brokerage account as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 5% of eligible compensation and increase by 1% annually until a deferral rate of 10% is reached unless participants designate otherwise.

**Employer Contributions.** The Plan Sponsor may make a discretionary matching contribution to the Plan on behalf of each eligible participant. Discretionary matching contributions are made on a per payroll period basis. Any discretionary matching contributions made are on behalf of all participants who have attained 19 years of age and with at least six continuous months of employment with at least 1,000 hours of service. During the Plan year ended December 31, 2024, the discretionary matching contribution was \$1,614,757.

Additional nonelective profit sharing employer contributions may be contributed at the discretion of the Plan Sponsor's management. Participants must have attained 19 years of age, have at least six continuous months of employment with at least 1,000 hours of service, and be employed on the last day of the plan year. Any profit-sharing contributions made to the Plan will be divided among eligible participants based on certain designated groups based on years of service under the Plan. Profit sharing contributions are made on the basis of a participant's defined compensation for the Plan year. For the Plan year ended December 31, 2024, the nonelective profit sharing contribution was \$449,887.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions, as well as allocations of the Plan Sponsor's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN - CONTINUED**

**Vesting.** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contribution portion of their accounts is based on years of continuous service. For the employer matching portion, a participant is 25% vested after two years of service, 50% after three years, 75% vested after four years, and 100% vested after five years. For the nonelective profit sharing contribution, a participant is 20% vested after two years of service, 40% vested after three years, 60% vested after four years, 80% vested after five years, and 100% vested after six years.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the plan. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time of the loan, is based on the prime rate plus one percent. Principal and interest is paid ratably through monthly payroll deductions.

**Payment of Benefits.** On separation of service due to death, disability, retirement, termination or attainment of age 65, a participant may elect to receive (a) a single sum payment or (b) the minimum required distributions. Distributions may be made to a participant who has not separated from service upon reaching age 59½. Distributions may be made as soon as administratively feasible at the participant's election.

Termination of employment prior to normal retirement age requires a distribution if the account balance does not exceed \$7,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If no election is made, the benefit will be rolled over to an IRA. If the account balance is less than \$1,000, the distribution will be paid in cash. If the account is greater than \$5,000, the participant may defer distribution until normal retirement age or further defer to age 73.

Hardship withdrawals are permitted for purposes specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that are fully vested.

**Forfeited Accounts.** Forfeiture accounts may be used at the discretion of the Plan Sponsor. At December 31, 2024 and 2023, these accounts totaled \$17,993 and \$37,597, respectively. Forfeiture account balances used to reduce the Company's discretionary matching contributions and nonelective profit sharing employer contributions during 2024 totaled \$49,597.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee.

NOTES TO FINANCIAL STATEMENTS

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Investment Valuation and Income Recognition - Continued.** The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Investments measured at net asset value (NAV) per share (or its equivalent using the practical expedient in FASB's fair value measurement guidance) are not required to be categorized in the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Contribution Receivable.** Employer contribution receivable is measured at the amount owed to participants by the Plan Sponsor at December 31, 2024 and 2023.

**Payment of Benefits.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. Fees related to administration of the Plan are shown on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

**NOTE C - FAIR MARKET VALUE**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

*Common Trusts:* A common trust fund is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

*Self-directed brokerage account:* The underlying investments, which consist primarily of mutual funds and individual corporate common stocks, are valued at the closing price reported on the open market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTES TO FINANCIAL STATEMENTS

**NOTE E - TAX STATUS**

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing Plan of OneAmerica Financial Partners, Inc., which received a determination letter from the IRS dated August 19, 2020, stating that the Prototype Plan was designed in accordance with provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan’s Federal Returns for 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE G - INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix Trust Company (the trustee of the Plan). Accordingly, Matrix Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate.

The Plan made direct payments to OneAmerica Retirement Services, LLC, the third-party administrator, of \$33,049 for recordkeeping services. The Plan also made direct payments of \$50,106 to Global Retirement Partners, LLC. Certain Plan investments are managed by Matrix Trust Company, the trustee. Indirect fees for trustee services and administration are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note B, the Plan Sponsor pays directly any other fees related to the Plan's operations.
