### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the Sobi, Inc. 401(k) Retirement Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## ***Notes to Financial Statements***

### ***Note 1 - Description of the Plan***

The following description of the Sobi, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution profit sharing plan with a cash deferral 401(k) arrangement established by Sobi, Inc. (the “Employer”). In accordance with the trust agreement, the Employer administers the Plan. Ascensus, LLC as agent for Ascensus Trust Company (“Ascensus”) is the Plan’s custodian and trustee. All regular employees of Sobi, Inc. over the age of 21 are eligible to join the Plan as a participant after completing one month of service. Leased employees and employees covered by a collective bargaining agreement are not eligible to participate in the Plan. Temporary employees are eligible to join the Plan after completing 1,000 hours of service during the first twelve months from their date of hire or any Plan year thereafter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant-directed.

The Employer’s subsidiary, CTI BioPharma Corp. (“CTI”) (acquired in June 2023), had its own 401(k) Plan, the CTI BioPharma Corp. 401(k) Plan (CTI’s Plan). By a merger agreement effective January 2, 2024, the assets of CTI’s Plan were merged into the Plan, and accordingly, approximately \$18,316,000 of assets (including both investments and participant loans) were received by the Plan in January 2024. Participants of CTI’s Plan had their investments transferred to this Plan based on a fund mapping schedule. Participants of the CTI Plan are fully vested in their account balances.

#### ***Participant Contributions***

Participants may defer a percentage of their eligible annual compensation, as defined by the Plan, subject to dollar limits set by Federal law. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

#### ***Employer Contributions***

##### ***Safe Harbor Matching Contributions***

The Employer will make an enhanced safe harbor matching contribution of 100% of a participant’s contribution to the Plan, up to a maximum of 6% of the participant’s deferral percentage. The Employer has the right to change or suspend the matching contribution at any time. For the Plan year ended December 31, 2024, the Employer’s matching contribution amounted to \$4,837,769 which is net of \$19,521 of forfeitures being utilized.

## ***Notes to Financial Statements***

### ***Note 1 - Description of the Plan (Continued)***

#### ***Employer Contributions (Continued)***

##### ***Discretionary Profit Sharing Contribution***

The Employer, at the discretion of its Board of Directors, may also elect an amount to be contributed as a profit sharing contribution to eligible participants, as defined in the Plan. Discretionary profit sharing contributions are allocated among eligible participants in accordance with the ratio that each such eligible participant's compensation bears to the total compensation of all such eligible participants for the Plan year. In order to receive a profit sharing contribution, a participant must be employed on the last day of the Plan year, unless separated due to death, disability or attainment of normal retirement age. For the Plan year ended December 31, 2024, no such contribution was made.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, Employer matching contribution, and allocations of the Employer's profit sharing contribution, investment earnings or losses adjusted for related advisory fees, self-directed brokerage account fees (if applicable) and administrative expenses. Allocations are based on the participant's compensation, account balance or specific participant transactions, as defined by the Plan. A participant is entitled to the benefit that can be provided from their vested account.

#### ***Vesting***

##### ***Participant Contributions and Employer Safe Harbor Matching Contributions***

A participant is immediately vested in their deferred contributions, rollover contributions, Employer Safe Harbor matching contributions and any related earnings. A participant also becomes fully vested upon death or disability, as defined by the Plan, or upon reaching normal retirement age (65) while employed by the Employer.

##### ***Employer Profit Sharing Contributions***

A participant's vested interest is fully vested after one year of credited service or in the event the participant becomes deceased, disabled (as defined by the Plan), or upon the attainment of normal retirement age (59½) during their service with the Employer.

#### ***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance at the earlier of five consecutive one-year breaks in service or when the participant receives a complete distribution of their vested account. The Plan uses forfeitures to offset a portion of future Employer contributions. For the year ended December 31, 2024, the Plan used \$19,521 of forfeitures to offset a portion of the Employer Safe Harbor matching contributions. The unused forfeiture balance at December 31, 2024 and 2023 was \$17 and \$1,174, respectively. Forfeitures are a result of payroll corrections.

## ***Notes to Financial Statements***

### ***Note 1 - Description of the Plan (Continued)***

#### ***Payment of Benefits***

Participants are entitled to their vested account upon death, disability, retirement or termination of employment. Participants have the discretion to remain in the Plan if their vested account is valued at over \$1,000. In-service withdrawals from a participant's elective deferral and vested Employer matching contributions are permitted upon the attainment of age 59½. Hardship withdrawals are permitted from a participant's deferral and Profit Sharing contribution vested account balance. The amount of hardship distribution cannot exceed the amount needed to meet immediate financial hardship. Vested accounts valued at less than \$5,000 will be distributed in cash by the Plan administrator if the participant does not provide any payment instructions. A participant may elect to receive a lump-sum amount equal to the value of his or her account.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum loan equal to the smaller of \$50,000 or 50% of their elective deferrals and rollover contributions accounts plus any related earnings. Generally, loans are available with terms of up to five years. Longer terms are available for the purpose of purchasing a principal residence. Participants may have up to two loans outstanding at a time. Loans bear interest at a reasonable rate commensurate with the interest rate charged by persons in the business of lending money for loans which would be made under similar circumstances. A loan is secured by the vested balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan may be paid by the Employer at its discretion and may be excluded from the financial statements.

### ***Note 2 - Summary of Significant Accounting Policies***

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

### ***Note 2 - Summary of Significant Accounting Policies (Continued)***

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Subsequent Events***

The Plan administrator has evaluated subsequent events through June 9, 2025, the date that the financial statements were available to be issued. No significant matters were identified during this evaluation.

### ***Note 3 - Information Certified by Trustee and Custodian***

Plan investments are held in mutual fund accounts by Ascensus Trust Company (“Ascensus”), the custodian and trustee. The fair value of investments as of December 31, 2024 and 2023, and all investment transactions for the year ended December 31, 2024, including interest and dividends, and net appreciation in fair values are certified as complete and accurate and reported to the Plan by Ascensus, LLC as agent for Ascensus Trust Company. Information contained in the supplemental schedule and notes receivable from participants is also certified by Ascensus.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. Participants may direct their contributions as well as Employer contributions to any of the Plan’s investment options.

## Notes to Financial Statements

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

*Level I* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level II* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

*Level III* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The mutual fund investments held by the Plan as of December 31, 2024 and 2023 amounted to \$94,092,534 and \$65,174,772, respectively, and based on the fair value hierarchy, have been classified as Level I investments.

## ***Notes to Financial Statements***

### ***Note 5 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 6 - Related-Party Transactions and Party-in-Interest Transactions***

Certain Plan investments are shares of mutual funds held by Ascensus. Ascensus is the trustee and custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to the trustee and custodian totaled \$5,964 for the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

### ***Note 7 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in all of their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 8 - Tax Status***

The Plan adopted the Ascensus, LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA that received a favorable opinion letter dated June 30, 2020. The Employer believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore qualifies under Section 401(a) and is therefore tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Note 9 - Delinquent Participant Contributions***

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets. While the Employer remitted all participant contributions to the Plan, due to an administrative delay caused by a third-party, contributions of \$449,467 were not remitted within the required time period during the year ended December 31, 2024. These have been reflected in the accompanying Schedule of Delinquent Participant Contributions and lost earnings on behalf of all affected participants were corrected in 2024.
