Significant Audit Matters

Employee Health & Welfare Benefit Plan are described in Note B to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the period ending August 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the benefit obligations is based on claims incurred and processed. We evaluated the key factors and assumptions used to develop the benefit obligations in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. There were no misstatements detected as a result of audit procedures.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing

matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

NOTE A - DESCRIPTION OF THE PLAN

The following description of Nutis Press, Inc. (Corporation) Employee Health & Welfare Benefit Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health benefits covering substantially all employees of the Corporation. It is subject to the provision of the Employee Retirement Income and Security Act of 1974 (ERISA).

Benefits

The Plan provides health benefits (hospital, surgical, major medical, dental and prescription) covering full-time employees of the Corporation working 30 hours or more per week.

Contributions

Contributions to the Plan are made by the Corporation and the participating employee. The employee's contribution is a fixed amount per pay period. The Corporation pays the balance of the Plan costs.

Stop Loss Insurance

Eligible medical expenses in excess of \$75,000 per covered person per Plan year are covered by specific excess loss insurance. Amounts necessary to pay the premiums for the specific excess loss insurance are contributed to the plan by the employer. In addition, the plan carries aggregate excess loss insurance coverage to provide benefits when the group's claims exceed the annual aggregate deductible.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Plan Benefits

Plan liabilities for health claims incurred as of August 31, 2024 and 2023 are based upon actual experience of claims incurred prior to August 31, 2024 and 2023. These claims were paid in the subsequent either processed at August 31, 2024 and 2023 but unpaid as of those dates or processed after August 31, 2024 and 2023

Contributions receivable represent amounts due as of August 31, 2024 and 2023, under the terms of the Plan, to cover allowable benefits incurred as of August 31, 2024 and 2023.

NOTE C - INVESTMENTS

The Plan did not hold any investments during the years ended August 31, 2024 and 2023.

NOTE D - TAX STATUS

The Plan is designed to qualify as tax-exempt under the appropriate section of the Internal Revenue Code. There is no determination letter program for Health and Welfare Plans provided by the Internal Revenue Service. Therefore, a determination letter for tax exemption has never been received. The Plan Sponsor and Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan years ending August 31, 2024, 2023 and 2022 are still open for possible examination by the Internal Revenue Service. However, there has been no indication by the IRS that these years will be audited.

NOTE E - SUBSEQUENT EVENTS

Subsequent events have been evaluated through May 30, 2025, the date which the financial statements were available to be issued.

NOTE F - PLAN RESTATEMENT

The Plan was restated effective July 1, 2020 with respect to benefits and plan verbiage.

NOTE G - PARTY-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Administrative expenses paid to BAC, Inc. (TPA) amounted to \$65,994 for the year ended August 31, 2024.

These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.
