## INDEPENDENT AUDITORS' REPORT

### Note 1 – Description of the Plan

The following description of Eastern Roofing Systems, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is administered by the Company. The Plan has been designated as a "safe harbor 401(k) plan".

#### Plan Merger

On August 9, 2024, the Plan assets were transferred to The Standard Pooled Employer Plan and the Eastern Roofing Systems, Inc. 401(k) Plan was terminated. An effort was made to ensure that the value of the assets leaving the old plan was the same value that was received by the new plan.

#### Eligibility and Participation

Employees are eligible to participate if they have reached the age of 21 and have completed one month of service. A year of service requires an employee to be credited with 1,000 hours of service at the end of the employee's first twelve consecutive months of employment. Newly hired employees will be automatically enrolled when they meet the eligibility requirements unless they opt out. The auto enrollment feature includes a 3% auto deferral rate. If employees do not make investment elections, amounts contributed under the automatic enrollment feature of the plan will be invested in the default investment (Target Funds – 100%) until they make an investment election.

#### Participant Contributions

Each year, participants may contribute the maximum allowed by law of pre-tax amounts as well as after tax Roth contributions, as defined in the Plan. For 2024, the maximum elective deferral was \$23,000 with a \$7,500 catch-up contribution for participants aged 50 and over for both pre-tax and after-tax participants. The Plan includes an automatic deferral feature. Accordingly, the employer will automatically withhold a portion of the participant's compensation each pay period and contribute that amount to the plan as a pre-tax deferral unless there is a contrary election. The amount to be automatically withheld will initially be 3% of W-2 compensation set increasing 1% a year up to 5%. If employees do not make investment elections, amounts contributed under the automatic enrollment feature of the plan will be invested in a target date until they make an investment election fund based on their age and estimated retirement. Participants can complete a salary reduction at any time to select an alternative deferral amount or to elect not to defer under the Plan.

### Note 1 – Description of the Plan (continued)

#### **Employer Contributions**

The Company safe harbor match formula is 100% up to 3% of pay and 50% on the next 2%. Anyone that defers 5% or more of their pay receives 4% of their pay in safe harbor match. Anyone that defers 3% or under gets 100% of their deferral in a safe harbor match. If anyone deferred between 3.01% and 4.99% then they should be getting 100% on the first 3% deferred, then 50% on the next 2%.

#### **Participant Accounts**

Each participant's account reflects the total current value of all employer and employee contributions made to the Plan on behalf of the participant. The value of a participant's individual account is determined on the last day of the Plan year.

#### **Vesting**

The participants will be 100% vested immediately in both their contributions and the Company match under the safe harbor plan provisions.

#### **Investment Options**

All contributions made to the participant account are invested in a group mutual fund managed by professional money managers. There are various investment options, and the participant shall specify the manner in which contributions made on his behalf are to be invested. Investments may be changed from time to time pursuant to the terms of the contract and prospectus.

#### **Notes Receivable from Participants**

Loans to participants are permitted. Spousal consent is not required. The minimum amount of any loan will be \$1,000. Loans cannot exceed the lesser of \$50,000 or one-half of the vested portion of the participant account balance. The loans are secured by the balance in the participant's account. The term of the loan cannot be longer than five years. If the loan is for the purchase of a principal residence, a thirty-year repayment period is permitted. The interest is set to the prime rate plus 1%. Principal and interest is paid bi-weekly by the participant through payroll withholdings.

#### **Payment of Benefits**

Upon death, disability, retirement or termination, the participant's vested benefits are paid in a lump sum. Payment of a terminated participant's benefit may be paid out in a lump sum or rolled over to another qualified plan.

#### Forfeitures

If a participant stops working before they are 100% vested, the part of their account that is not vested is forfeited. All forfeitures shall be used to reduce employer contributions otherwise payable for the Plan year in which such forfeitures arise, and for each succeeding Plan year, if necessary, until such forfeitures are exhausted. Forfeitures available to reduce employer contributions for years ending August 9, 2024 (date of Merger) and December 31, 2023, were \$0 and \$25,978, respectively.

### Note 2 – Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements included herein have been prepared on an accrual basis of accounting in accordance with generally accepted accounting principles and are in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 3 for discussion of fair value measurements.

Purchases and sales of shares are made at the net asset values of such shares. Transactions are recorded on a trade date basis. Realized gains and losses on the sales of investments are recognized at the date of sale. The cost basis to calculate the realized gains and losses is determined by recording purchases and subsequent sales on a first-in, first-out basis. Dividends and capital gain distributions from the funds are recorded on the ex-dividend date and reinvested upon receipt.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Plan participants pay any administrative expenses.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which a fair measurement falls is based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 9, 2024 (Date of Merger) and December 31, 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are determined to be actively traded.

Investments in the Mass Mutual Guaranteed Interest Account are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). Also see Note 4 for discussion of the Mass Mutual Guaranteed Interest Account.

### Note 4 – Annuity Contract with Insurance Company

The Mass Mutual Guaranteed Interest Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses as allowed by the Plan. Plan management has determined that contract value approximates fair value. Contract value, as determined by Empower, represents contributions made under the agreement, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The minimum guaranteed interest rate varies by participant and depends on the date the participant established their account. For the year ended August 9, 2024 (Date of Merger), the average rate of return was 1.68%.

Prior to the final transfer of the Plan’s assets to The Standard, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive the total balance in their individual account.

### Note 7 – Delinquent Participant Contributions

As reported on form 5500, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, contributions were not remitted to the Plan within the time frame specified by the Department of Labor’s regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company during the 2024 and 2023 Plan years. Late remittances amounted to \$38,685. The Company is currently in the process of making appropriate filings in accordance with the DOL’s Voluntary Fiduciary Corrective Program.

### Note 9 – Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan, Prototype Non-Standardized Pre-Approved Profit-Sharing Plan with CODA, is designed in accordance with applicable section 401 of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2020.

### Note 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 11 – Certified Investments

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
