The final Form 5500-SF for Plan 001 (401K) for I3T, LLC is being filed contemporaneously with this delivery of this correspondence. It is late simply due to a miscommunication about the contractual obligations of a 3rd-party vendor, Paychex. Paychex was employed by I3T, LLC to handle the filing of mandatory forms for I3T's 401k. We were not advised during the transition to business closeout that Paychex would not be filing the last/final Form 5500-SF; that they anticipated that I3T would file the final Report. Nevertheless, they delivered the document to us, like they always did, so we were led to understand that the document had been filed by Paychex, as it always had been. It was not until we received notice from the I.R.S. that we became aware that the form had not actually been filed by Paychex. That notice from the I.R.S. was not received until we retrieved mail during the evening of June 11, 2025, after normal business hours. We immediately made contact with the EFAST2 Help Line this morning.

I3T had received prior inquiry from the I.R.S. dated September 30, 2024 regarding the status of the Form 5500-SF, to which prompt response was delivered. The I.R.S. had requested details regarding the closing of the Plan. We previously indicated that the Form 5500-SF had been filed on February 8, 2023, as we fully believed that it had been filed on that date based on prior practice with Paychex. Had we become aware at any time prior to today that the document had not actually been previously filed, we would have ensured its filing immediately. As such, we are filing the Form 5500-SF contemporaneously with this correspondence, and we request consideration of the circumstances and waiver of any penalty against I3T, LLC. That company no longer exists - it hasn't for several years - and the Plan for which this Form 5500-SF was required has been terminated and all monies maintained therein have been returned to the employees.
