

1. DESCRIPTION OF THE PLAN

The following description of César Castillo, Inc. Savings and Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering all permanent full-time employees of César Castillo, LLC (the “Plan Sponsor”), who have completed three months of service. The Plan was established effective February 1, 1982 and it is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Sponsor’s Employee Benefit Plan Administrative Committee controls and manages the operation and administration of the Plan. At August 31, 2024 and 2023, Banco Popular de Puerto Rico was the trustee and record keeper for the Plan.

**Contributions** – Each year, participants may contribute up to \$15,000 of pretax annual compensation, as defined in the Plan. Participants who have attained or will attain age 50 before the end of the Plan year and whose pre-tax contributions have reached the applicable limit for the year may also make a pre-tax catch-up contribution of up to \$1,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor discontinued its matching contributions effective September 1, 2009. In April 1, 2024, the Plan Sponsor reestablished discretionary matching contributions to participants of \$0.20 for every dollar contributed by the participant up to 5% of the participant’s compensation for pre-tax contributions.

**Participant Accounts** - Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution and allocations of the Sponsor’s contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments** - Participants direct the investment of their contributions into various investment options offered by the Plan. The matching Sponsor’s contributions are invested proportionally as elected by participants. The Plan currently offers twenty investment options for participants.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor’s contribution portion of their accounts is based on years of continuous service. Participant’s Sponsor’s contribution shall vest in accordance with the following schedule:

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of the loans is 5 years except for home loans in which the term of repayment does not exceed 10 years. The loans are secured by the balance in the participant's account and bear interest at a rate of one percentage point over the current banking prime rate determined on a monthly basis. Principal and interest is paid ratably through biweekly or monthly payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant or his/her beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments for a period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited Accounts** - Forfeitures of non-vested Sponsor's contributions are used to cover Plan's administrative expenses or to reduce future employer contributions. The forfeited non-vested assets at August 31, 2024 and 2023 were \$267 and \$467, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Date of Management's Review of Subsequent Events** - The Plan has evaluated subsequent events through June 4, 2025, the date the financial statements were available to be issued.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2024 and 2023.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade - date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, these management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2, or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### 6. TAX STATUS

The Puerto Rico Treasury Department has determined and informed the Sponsor that the Plan and related trust is designed in accordance with applicable sections of the Puerto Rico Internal Revenue Code of 2011, as amended ("PRIRC"). The Plan is exempt from Puerto Rico income taxes under the provisions of the PRIRC. The Plan is required to operate in conformity with the PRIRC to maintain its qualification. The Sponsor and the plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the PRIRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan participants are not taxed on the income and contributions made to their accounts until such time as the participant or the participant's beneficiary receives distributions from the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 7. RISKS AND UNCERTAINTIES

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that change in risk in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.
