Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Smith & Nephew U.S. Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) and the statements of accumulated plan benefits (in liquidation) as of December 31, 2024, and December 31, 2023, and the related statements of changes in net assets available for benefits (in liquidation) and statements of changes in accumulated plan benefits (in liquidation) for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024, and December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements (in liquidation), other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements (in liquidation) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of Smith & Nephew, Inc., the Plan's Sponsor, voted on July 22, 2022, to terminate the Plan, and the legal transfer of the Plan's obligations was executed on January 4, 2024. As a result, the basis of accounting used in presenting the accompanying financial statements for 2024 and 2023 was the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and Schedule of Reportable Transactions as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosures under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following summary description of the Smith & Nephew U.S. Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General and Participation

The Plan is a noncontributory defined benefit plan that covers substantially all nonunion employees of Smith & Nephew's U.S. affiliates (collectively, the "Company") who were eligible to participate prior to January 1, 2003 and provides for pension and death benefits. Employees became 100 percent vested once they accumulated five years of service with the Company. Benefits are based upon years of service and compensation levels. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective January 1, 2003, no new employees were eligible for participation in the Plan. Eligible participants who were employed by the Company as of December 31, 2002, elected to either remain in the Plan or to cease participation as of April 30, 2003 and instead participate in the Employment Retirement Contributions program in an affiliated plan, the Smith & Nephew U.S. Savings Plan (the "Savings Plan"). Benefits for those employees who ceased participation in the Plan were frozen as of April 30, 2003. Effective March 31, 2014, benefits were frozen for all participants.

Plan Termination and Transfer of Plan Obligations

On July 22, 2022, the Company's Board of Directors adopted resolutions to terminate the Plan effective December 31, 2022 ("Termination Date"). As a result, management determined liquidation was imminent.

In October 2022, a Notice of Interested Parties advising that an application was to be filed was distributed to Plan participants and subsequently, the application for approval of the Plan's termination was filed with the Internal Revenue Service ("IRS"). In addition, in June 2023, a Notice of Plan Benefits was distributed to Plan participants and subsequently, a Standard Termination Notice was filed with the Pension Benefit Guaranty Corporation ("PBGC"). The Notice of Plan Benefits is a statement of a participant's accrued benefit under the Plan, including an estimate of the amount of a single cash payment to which the participant would be entitled following the receipt of Plan termination approval. As a result of the resolution to terminate the Plan, each employee with an accrued benefit under the Plan had the following choices to have the present value of his or her accrued benefit: (a) used to purchase an annuity under the Contract or (b) distributed in a single cash payment either (i) directly to him or her (ii) as a direct rollover by the Plan's trustee into either the Company's 401(k) plan or the participant's rollover Individual Retirement Account.

On January 4, 2024, the Plan's assets were redeemed and funded a single premium non-participating group annuity contract with Fidelity & Guaranty Life Insurance Company of New York ("F&G") for approximately \$244.69 million. This transaction transferred the Plan's obligations for making defined benefit pension plan payments to F&G, thus providing an irrevocable commitment by F&G to make the necessary annuity payments to Plan participants and their beneficiaries in accordance with Plan provisions.

Pension Benefits

Employees were eligible for monthly benefit payments for normal retirement upon reaching age 65. Benefit payments were determined by 1.15 percent of the participant's final average monthly compensation multiplied by the participant's years of benefit service up to but not in excess of 35 years plus 0.65 percent of the portion of the participant's final average monthly compensation that exceeds the participant's covered compensation multiplied by the participant's years of benefit service up to but not in excess of 35 years.

The Plan permitted early retirement at any time after completing 5 years of vesting service and attainment of age 55. Participants normally received the value of their accumulated Plan benefits as a single life annuity payable monthly upon retirement; however, participants could elect to receive their pension benefits in the form of a qualified joint and survivor annuity, 75 percent or 100 percent joint and survivor annuity, or 10-year period certain option.

If a participant's benefit was less than \$5,000, he or she received the benefit as a lump sum distribution. If employees terminated before rendering five years of service, they forfeited the right to receive their accumulated Plan benefits.

Effective September 1, 2014, the Plan was amended to allow certain participants, who terminated employment prior to August 25, 2014, who were fully vested in their benefits under the Plan, and who had not commenced receipt of those benefits, to elect, during the period from September 25, 2014 through November 20, 2014, to receive lump sum payments of those benefits under the Plan. Effective February 1, 2016, the Plan was amended to allow certain participants who terminated employment after August 25, 2014, who were fully vested in their benefits, to receive lump sum payments of those benefits under the Plan.

For Plan participants who had not yet started collecting an annuity, distributions pursuant to the Plan termination would be paid at the participant's election by (a) purchase of a nontransferable annuity contract; (b) cash distribution of the present value of the participant's accrued benefit; or (c) rollover into an IRA or another qualified retirement plan established or maintained by the Company; however, option (a) were not available if the participant's accrued benefit is \$5,000 or less.

Death and Disability Benefits

If a participant died prior to receiving annuity, a qualified joint and survivorship annuity equal to 50 percent of the benefit amount would be paid monthly to the participant's spouse if the participant was married. There is no death benefits payable for participants not married.

A participant shall be eligible for a retirement benefit if his or her service is terminated by reason of disability. A participant must have completed five years of service as of the date he or she terminates service due to disability to be eligible for this disability benefit. The disability shall be payable at the participant's normal retirement date and shall be an amount determined under the provisions of the Plan based on the participant's normal retirement benefit, which is deferred to age 65, based on final average monthly earnings at the date of disability and benefit service to normal retirement date.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan, management determined that liquidation of the Plan is imminent and the financial statements for 2024 and 2023 have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of Plan assets available for benefits and the actuarial present value of accumulated plan benefits as the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses incurred by the Plan are paid from Plan assets to the extent they are not paid by the Company. Administrative expenses paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Note 3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated Plan benefits are those future periodic payments, including lump sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated Plan benefits for active employees are based on their years of service as of the benefit information date.

Benefits payable under all circumstances (i.e., retirement, death, disability and termination of employment) are included to the extent they are deemed attributable to employee service rendered to the valuation date. In that regard, while all participants have accumulated the five years of service with the Company to be vested in their benefits, the vested benefits reflected in the statements of accumulated plan benefits represent only benefits for which a participant has met the eligibility requirements for on the valuation date.

Nonvested benefits represent benefits for which a participant has not met eligibility requirements (i.e., age) on the valuation date but has the opportunity to meet the requirements prior to the commencement of benefits date.

The actuarial present value of accumulated Plan benefits was determined by the Plan's actuary, Mercer Trust Company ("Mercer"), and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money through discounts for interest and probability of payment (by means of decrements such as for death, disability, withdrawals or retirement) between the valuation date and the expected date of payment.

In conjunction with the Plan's termination and management's determination that liquidation was imminent, the consulting actuary calculated the actuarial present value of accumulated plan benefits, under a liquidation assumption at December 31, 2023. The significant actuarial assumptions used in the actuarial valuations, as of December 31, 2023, were as follows:

The computation of the actuarial present value of accumulated Plan benefits for the December 31, 2023 estimate was made as of January 1, 2024. Had the valuation been performed as of December 31, there would be no material difference. Additionally, no actuarial estimate was calculated for the year ended December 31, 2024 as a result of the Plan's wind down by the end of the year.

Note 4. Close-Out of Defined Benefit Liabilities and Transfer of Residual Assets

On January 4, 2024, the Plan purchased a single premium, nonparticipating group annuity contract from Fidelity & Guaranty Life Insurance Company of New York, thereby irrevocably transferring responsibility for future retirement benefit payments to F&G. Under the terms of the annuity contract, F&G assumed the obligation to make all future benefit payments to Plan participants and their beneficiaries in accordance with the provisions of the Plan. Following this transaction, the Plan no longer retained any liability for defined benefit pension obligations.

During the period immediately following the purchase of the annuity contract, the Plan continued to disburse benefit payments directly to participants while F&G completed the administrative processes necessary to assume full operational responsibility for benefit payments. On January 30, 2024 and July 22, 2024, F&G remitted \$1,631,450 and \$54,110, respectively, to the Plan as reimbursement for benefit payments made by the Plan on their behalf during the transition period. This reimbursement was based on actual participant payments made during the interim period.

Prior to December 31, 2024, the Plan transferred its remaining assets to the Smith & Nephew U.S. Savings Plan, a defined contribution savings plan, in accordance with the Plan's governing documents and applicable regulatory guidance. This transfer represented the final distribution of residual Plan assets, completing the wind-down of the Plan.

As of December 31, 2024, the Plan had no remaining defined benefit assets or liabilities.

Note 5. Information Certified by State Street Bank and Trust ("State Street")

Information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by State Street, the trustee of the Plan.

Note 6. Income Tax Status

The Internal Revenue Service ("IRS") determined and informed the Plan by a letter dated September 25, 2015, that the Plan and related trust established under the Plan, are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt as of the date of the financial statements.

Note 7. Related Party Transactions

Certain Plan investments are units of a short-term investment fund that is managed by State Street, the trustee of the Plan. These transactions qualify as exempt party-in-interest transactions.

The Plan incurred administrative fees to State Street and Mercer, the Plan's investment manager, during 2024 and 2023 totaling \$181,914 and \$551,770, respectively. The Plan paid administrative fees to other parties during 2024 and 2023 totaling \$232,249 and \$1,969,939, respectively. Other than the premiums paid to Pension Benefit Guaranty Corporation ("PBGC") during 2024 and 2023, which totaled approximately \$19,905 and \$294,144, respectively, these transactions qualify as exempt party-in-interest transactions.

Note 8. Risks and Uncertainties

The actuarial present value of accumulated Plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 9. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Cash and cash equivalents: Valued based on quoted prices in active market (Level 1).

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
