### Qualitative Aspects of the Plan's Significant Accounting Practices

#### *Significant Accounting Policies*

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the MidSouth Bancorporation 401(k) Profit Sharing Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

#### *Significant Accounting Estimates and Related Disclosures*

Accounting estimates and related disclosures are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments.

The most sensitive accounting estimates affecting the financial statements are the determination of the fair market values of the Plan's investments, which are disclosed in Note 3 to the financial statements. As part of the ERISA Section 103(a)(3)(C) audit described in the second paragraph, we did not evaluate the key factors and assumptions used to develop the estimates certified by the custodian.

#### *Financial Statement Disclosures*

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the MidSouth Bancorporation 401(k) Profit Sharing Plan's financial statements relate to the disclosure of fair market values of investments in Note 3 to the financial statements.

### Significant Unusual Transactions

### Form 5500 Procedures

We identified no material inconsistencies in performing and completing our audit.

None of the matters discussed resulted in a condition to our retention as the MidSouth Bancorporation 401(k) Profit Sharing Plan's auditors.

Other Matters
