## 1. Description of Plan

The following brief description of the Sunflower Bank, N.A. Wealth Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions. Effective January 1, 2025 the Plan's name was changed to Sunflower Bank Wealth Savings Plan.

### **General**

The Plan is a defined contribution plan covering all eligible employees of Sunflower Bank, N.A. (the "Company" or "Employer"). Eligible employees who have worked for three months and are twenty-one years of age or older are eligible to participate in the 401(k) portion of the Plan. Employees who have at least three months of service and are twenty-one years of age or older are also eligible for Employer matching and discretionary contributions from the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective January 1, 2025 the name of the Employer changes to Sunflower Bank.

### **Contributions**

Each year, participants may contribute a portion of their annual compensation on a pre-tax or after-tax (Roth) basis, as defined in the Plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Transfers from qualified plans (rollover contributions) are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically invested in a designated balanced fund until changed by the participant. Unless a participant elects otherwise, the Plan provides for automatic enrollment at a contribution rate of 4% of a participant's eligible compensation.

Each year, the Company contributes a safe-harbor matching contribution to an eligible participant's account equal to 100% of the 401(k)-contribution made by the participant, up to 6% of their eligible compensation.

### **Vesting**

Active participants on January 1, 2023 are 100% vested in all money types at all times. Non-active participants prior to January 1, 2023 vest in the employer discretionary retirement savings contributions in 20% increments starting after two years of credited service and become 100% vested after six years.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0. In 2024, \$3,812 of forfeitures was used to offset Employer contributions and \$61 forfeitures were used to offset administrative expenses.

### 1. Description of Plan (*continued*)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and withdrawals, as applicable, allocations of Company contributions and Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Benefit Payments***

Upon termination of service, participants may elect for payment to be made in a lump sum, or in an amount the participant designates from time to time. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, may not exceed the amount of the participant's immediate and financial need. In-Service withdrawals are allowed at age 59 1/2 .

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net asset value ("NAV") of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

#### ***Notes Receivable from Participants***

Participants may borrow from their account balance a minimum amount of \$1,000 up to a maximum of the lesser of one-half of their vested account balance, excluding discretionary contributions, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. A participant will be granted no more than two loans during any one-year period, and participants may only have two loans outstanding at a time. Principal and interest is paid ratably through bi-weekly payroll deductions over a period not to exceed five years.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the NAV per share as a practical expedient is not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are deemed to be actively traded. These mutual funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payments of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is June 10, 2025.

### 4. Investments

### 5. Common/Collective Trusts

The Plan offers common/collective trusts called the Principal LifeTime Hybrid Funds (“Funds”). These Funds include: the Principal LifeTime Hybrid 2015 CIT Z Fund; the Principal LifeTime Hybrid 2020 CIT Z Fund; the Principal LifeTime Hybrid 2025 CIT Z Fund; the Principal LifeTime Hybrid 2030 CIT Z Fund; the Principal LifeTime Hybrid 2035 CIT Z Fund; the Principal LifeTime Hybrid 2040 CIT Z Fund; the Principal LifeTime Hybrid 2045 CIT Z Fund; the Principal LifeTime Hybrid 2050 CIT Z Fund; the Principal LifeTime Hybrid 2055 CIT Z Fund; the Principal LifeTime Hybrid 2060 CIT Z Fund; the Principal LifeTime Hybrid 2065 CIT Z Fund, Principal LifeTime Hybrid 2070 CIT Z Fund; and the Principal LifeTime Hybrid Income CIT Z Fund. The unit value of each of these Funds is determined on a daily basis. Units are issued and redeemed daily at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. These Funds have no restrictions on withdrawals and have no unfunded commitments.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

### 7. Party-in-Interest Transactions

Certain investments of the Plan are managed by an affiliate of Principal Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 8. Income Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the volume submitter preparer by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
