Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of United Prairie, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. DESCRIPTION OF THE PLAN

The following description of the United Prairie, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which includes a salary reduction feature that meets the requirements of section 401(k) of the Internal Revenue Code ("IRC"), sponsored by United Prairie, LLC ("United Prairie", "Employer" or the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All eligible employees are automatically enrolled in the Plan with a 4% deferral after they have completed six months of service, unless the employee declines to participate, and upon attainment of the age 19. Participants are eligible for the match component of the Plan after they have attained the age of 21 and completed 12 months of service (including at least 1,000 hours). Participants are eligible for the profit-sharing contribution if they are at least 21 years of age, have worked at least 1,000 hours during the plan year and are employed on the last day of the plan year.

Contributions

Participants are permitted to make salary deferral contributions up to the current Internal Revenue Service (IRS) deferral limits, up to a maximum of 90% of the participant's salary. The Employer contributes to the Plan by matching employee deferrals through a safe harbor match, as defined by the Plan. During the years ended August 31, 2024 and 2023, the safe harbor match was 100% of the first 4% contributed of eligible compensation. In addition, the Company may elect to make a discretionary profit-sharing contribution. This contribution may change at any time at the discretion of the Employer. The Company elected to make profit-sharing contributions for the years ended August 31, 2024 and 2023 equal to 1.50% of eligible compensation.

Participants direct the investment of their contributions into various options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contributions, and allocations of plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations of plan earnings are based on the investments selected by the participants in their account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Each participant can borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of the participant's vested account balance or \$50,000. The loan term may not exceed five years unless such loan is for the purpose of the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of Prime plus 1%. Principal and interest are paid during each pay period through payroll deductions. A participant may have one outstanding loan at a time.

Vesting

Participants are vested immediately in salary deferral contributions, employer safe harbor contributions and rollover contributions, as well as income allocations relating to such contributions. Vesting in the Company's profit-sharing contributions, and earnings on those contributions, is based on years of service as follows, or upon death, disablement, or attainment of normal or early retirement age, as defined by the Plan, while an employee:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other eligible reasons, a participant may receive a lump sum or installment amount equal to the value of the participant's vested account balance. Participants may also receive in-service withdrawals upon attaining age 59½, incurring disability or in case of hardship.

Forfeited Accounts

At August 31, 2024 and 2023, forfeited nonvested accounts totaled \$15 and \$10, respectively. These accounts may be used to reduce future Employer contributions. During 2024, forfeitures of \$10,521 were used to reduce Employer contributions.

Administrative Expenses

The Company pays a significant amount of the Plan's administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of the Plan's assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as deemed distributions based on the terms of the plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan provides for investments in various types of investments. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Tax Status

The Plan is based on a preapproved plan document sponsored by ADP, LLC, who has received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020 that the plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for an opinion letter from the IRS. However, the plan administrator believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has concluded that as of August 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is June 11, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance) has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of August 31, 2024 and 2023, the schedule of assets (held at end of year) as of August 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended August 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

- *Common/collective trust:* Valued at the NAV of units of a common/collective trust. The NAV, as provided by the trustee, is based on the contract value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate fair value. The underlying investments of the trust are mostly guaranteed investment contracts or synthetic investment contracts issued by insurance companies. The incremental value of the contract itself is based on issuer ratings as determined by credit ratings, which are published by rating agencies and the present value of the change in each contract's replacement cost.

5. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, United Prairie and certain others. Professional fees and certain other administration expenses of the Plan were paid by United Prairie.

The investment management fees are paid to Reliance, the custodian and trustee. ADP Retirement Services is the recordkeeper and third-party administrator of the Plan and receives payment from the Plan for these services through reduction of plan income. Blue & Co., LLC is the independent auditor of the Plan and receives payment from United Prairie.

6. PLAN TERMINATION

Although the Company has not expressed any intent to discontinue participation in the Plan, it has the right to terminate the Plan. All accounts of the participants shall vest and become nonforfeitable in the event the Plan is terminated, partially terminated, or contributions by the Employer are discontinued. Upon termination, the Employer shall direct the trustee regarding distribution of accounts to participants or their beneficiaries.
