We have performed audits of the accompanying financial statements of The Welch Foods, Inc. a Cooperative and National Grape Co-operative Association, Inc. Savings/Supplemental Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

August 31, 2024

1. Description of Plan

The following description of The Welch Foods, Inc. a Cooperative and National Grape Co-operative Association, Inc. Savings/Supplemental Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description and Plan document for more complete information.

General

The Plan, effective September 1, 1984, and most recently restated September 1, 2021 is a defined contribution plan sponsored by Welch Foods, Inc. and National Grape Co-operative Association, Inc. (the Cooperative or Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All non-union salaried employees of the Cooperatives are eligible to participate in the Plan upon their date of hire.

Employee Contributions

Participants may make pre-tax salary reduction contributions from 1% to 50% of their compensation (10% for certain highly compensated employees) and is limited to the maximum amount prescribed by the Internal Revenue Code (the Code). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides for a 6% automatic deferral election for eligible employees. In addition, these employees will have their deferrals increased by 1% per year, not to exceed 10% of their compensation, unless the employee affirmatively elects not to increase their contributions or updates their account online.

Participants may also contribute up to an additional 1% to 10% of compensation in the form of an after-tax voluntary contribution subject to Code limitations.

1. Description of Plan (continued)

Employee Contributions (continued)

Effective January 1, 2024, the Plan added a Roth 401(k) contribution option. Roth elective deferrals shall be treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not “pre-tax” deferrals as defined in the Code.

Employer Contributions

The mandatory tiered non-safe harbor matching contribution and non elective employer contributions are as follows:

- Grandfathered participants aged 50 and older and employed as of June 30, 2013, will receive a matching contribution of 100% of the first 4% of eligible compensation contributed, 50% of the next 2% of eligible compensation contributed and an additional 3% non-elective annual contribution through August 31, 2023.
- Effective September 1, 2023, all participants receive a matching contribution of 100% of 6% of deferrals.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant determines the investment strategy of their account as provided in the Plan.

Forfeited balances of terminated participants’ non-vested accounts are used to reduce employer contributions. The forfeiture balance was \$67,682 and \$54,976 at August 31, 2024 and 2023, respectively. Forfeitures used to reduce Company contributions during the years ended August 31, 2024 and 2023 amounted to \$168,958 and \$-0-, respectively.

1. Description of Plan (continued)

Vesting

All participants are immediately vested in their entire contributions. Participants vest in their employer contributions plus actual earnings thereon based on years of service. A participant will be 50% vested after one year of service, 75% after two years of service and 100% vested after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans bear interest at the prime rate plus 1%. Loan terms range from one to five years or for periods exceeding five years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants or their beneficiaries are entitled to their entire account balance upon death, disability, or retirement at age 65. Salary reduction contributions may be withdrawn beginning at age 59-1/2. Salary reduction and vested employer matching contributions may also be withdrawn in the event of serious financial hardship, as defined in the Plan document. Voluntary post-tax contributions may also be withdrawn after six months' participation. Distributions are in the form of a lump sum.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid directly by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain other expenses such as participant loan processing fees are deducted directly from participant accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Accounting Policies

Basis of Presentation

The financial statements have been prepared on an accrual basis of accounting.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Expense Reimbursement/Administrative Expenses

Effective September 1, 2022, the Plan changed from a traditional pricing model to a fee leveling model. In connection with this change the Plan established a fee credit account to allocate revenue sharing amounts and subsequently to re-allocate such amounts directly to participant accounts.

The Plan received revenue credits of \$-0- and \$12,500 from T. Rowe Price Trust Company, Inc. (T. Rowe Price) for the years ended August 31, 2024 and 2023, respectively. The Plan Sponsor may direct the recordkeeper to reimburse the Plan Sponsor for fees and expenses associated with services provided to the Plan. The amount available in the revenue credit account at August 31, 2024 and 2023 was \$16,377 and \$74,010, respectively. During the years ended August 31, 2024 and 2023, \$59,832 and \$49,033, respectively, were used from the revenue account to offset plan expenses.

The Plan received fee credits of \$119,066 and \$96,268 from T. Rowe Price for the years ended August 31, 2024 and 2023, respectively. T. Rowe Price calculates an average credit rate and then allocates the fee credit amounts received quarterly directly to participant accounts as soon as administratively feasible. The amounts available in the fee credit account at August 31, 2024 and 2023 were \$32 and \$49, respectively. During the years ended August 31, 2024 and 2023, \$119,251 and \$96,377, respectively, were allocated to participant accounts.

Expense Reimbursement/Administrative Expenses (continued)

Administrative expenses are generally paid by the Plan. Certain expenses such as participant loan processing fees and other miscellaneous expenses are deducted directly from participant accounts. The amounts deducted from participant accounts amounted to \$67,394 and \$45,920 for the years ended August 31, 2024 and 2023, respectively.

The total administrative expense (income), net of revenue and fee credits, at August 31, 2024 and 2023, was \$8,160 and (\$13,815), respectively.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule including investments and notes receivable from participants held at August 31, 2024 and 2023, and net appreciation (depreciation) in fair value of mutual funds, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at August 31, 2024 and 2023.

Mutual funds and ETFs are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Stocks are valued at the closing price reported on the active market on which the individual securities are traded.

The *Common trust fund* includes the T. Rowe Price Stable Value Fund. The fair value of participation units owned by the Plan in this fund is based on the net asset value (NAV) of the fund on the last business day of the plan year. Participant transactions (purchases and sales) may occur daily. There are no unfunded investment commitments.

The Plan, through the T. Rowe Price Stable Value Fund, is invested in a fund of investment contracts. This investment has fully benefit-responsive features. For example, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value on a daily basis. However, withdrawals influenced by Company-initiated events, such as in connection with the sale of a business, may result in a distribution at other than contract value. Withdrawals directed by a Plan Sponsor must be preceded by a twelve-month written notice to the Trustee; provided, however, that the Trustee may, in its discretion, complete any such plan-level withdrawals before the expiration of such twelve-month period. There are no reserves against contract values for credit risk or contract issues or otherwise. The average yield of this fund was approximately 2.51% in 2024 and 2.05% in 2023. The crediting interest rate for these investment contracts is reset annually by the issuer but cannot be less than zero.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common trust fund includes:

- The T. Rowe Price Stable Value Fund is a common trust fund that seeks to preserve the principal investment while earning a level of interest income that is consistent with principal preservation. The yield of the fund will fluctuate.

5. Income Tax Status

The Plan adopted the T. Rowe Price Retirement Plan Services, Inc. volume submitter plan. The volume submitter plan has received an advisory letter from the Internal Revenue Service (IRS) dated August 19, 2020 stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code, and therefore, the related trust is tax exempt. Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Parties-In-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the trustee are considered party-in-interest transactions.

Certain Plan investments are mutual funds managed by T. Rowe Price and the brokerage accounts are managed by Charles Schwab. T. Rowe Price Trust Company is the Plan trustee. These investments and transactions, including those in the brokerage accounts, are considered to be party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

8. Subsequent Events

The Company has evaluated all subsequent events through June 11, 2025, the date the financial statements were available to be issued. During this period, there have been no other material events that would require recognition in the financial statements or disclosures to the financial statements.

9. Delinquent Participant Contributions

During 2024, the Company failed to transmit certain participant contributions to the Plan in the amount of \$37,396 within the time period prescribed by ERISA. Late transmission of participant contributions constitutes a prohibited transaction under ERISA section 406. The Company deposited the late contributions in 2024 and will calculate and fund the participant accounts for missed earnings.
