Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Boone Transportation, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Boone Transportation, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Boone Transportation, Inc. Retirement Plan (the "Plan") provides only general information. Interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan was effectively adopted on September 1, 1994. The Plan is a defined contribution employee benefit plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan covers employees of Boone Transportation, Inc. (the "Company") who have completed three months of service in a twelve month period.

Effective as of September 1, 2022, the Plan was amended to allow for hardship distributions.

Contributions - Participants are neither required nor permitted to contribute to the Plan. This retirement benefit is provided totally at the Company's expense.

Each year, the Company will determine the amount of the discretionary employer contribution, if any, that it will make for all eligible participants. This discretionary employer contribution will be made on behalf of a Classification Group by the Company and shall be allocated to the account of each participant who is a member of such Classification Group. Each participant will be in a separate Classification Group as follows:

- Group A is defined as "Owners"
- Group B is defined as "Office and Shop Employees"
- Group C is defined as "Drivers and Driver Assistants"

If the Company makes a contribution to the Plan on behalf of the eligible Plan participants, the participants are given the option of allocating all or a portion of such contribution to group medical coverage.

For the years ended August 31, 2024 and 2023, the Company made the following contribution on behalf of each Classification Group:

- Group A (Owners) - received an allocation equal to 10.8% and 10.8%, respectively, of base compensation offset by any amounts used for group medical coverage
- Group B (Office and Shop Employees) - received an allocation equal to 10.52% and 10.52%, respectively, of base compensation offset by any amounts used for group medical coverage
- Group C (Drivers and Driver Assistants) - full route drivers received an allocation of \$1,250 and \$1,250, respectively, offset by any amounts used for group medical coverage; half route drivers received an allocation of \$625 and \$625, respectively, offset by any amounts used for group medical coverage

1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts - Each participant's account is credited with the employer's contribution, if any, as well as an allocation of the Plan's earnings and administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from that participant's vested account.

Vesting - Participants are always 100 percent vested in the employer contributions plus actual earnings thereon.

Participant Loans - Loans are not permitted under this Plan.

Payment of Benefits - On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) shall have a nonforfeitable right to receive the full amount available for distribution from their account. Distributions are paid in lump-sum amounts or installment payments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The Plan's investment held in the interest accumulation account at August 31, 2024 and 2023 represents funds held in the general account of Mutual of America Life Insurance Company and is valued at cost, which approximates fair value. The account is comparable to a cash equivalent and is not a fully benefit-responsive investment contract. The account earns interest at a guaranteed rate set annually that cannot be less than 0.15% or more than 3%. The interest rate for 2024 was 2.85% and 1.6% for 2023. There are no adjustments or charges that would affect the value of the account as a result of a withdrawal request. There are no reserves against the account value for credit risk.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. For the years ended August 31, 2024 and 2023, the Plan paid \$1,915 and \$1,080, respectively, in administrative fees.

Risks and Uncertainties - The Plan provides for various investment options in any combination of investment securities based upon participant requests. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - Subsequent events were evaluated through June 9, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at August 31, 2024 and 2023, and investment income for the years ended August 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company (the custodian of the Plan).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

Pooled separate account: The Plan's pooled separate account is stated at fair value and consists solely of investments in mutual funds registered with the U.S. Securities and Exchange Commission and is carried at the net asset value at which the mutual fund shares are actively traded. The funds must publish their daily net asset value and transact at that price.

Interest accumulation account: The Plan's interest accumulation account is comparable to a cash equivalent and is stated at cost, which approximates fair value.

Gains and losses included in changes in net assets available for benefits for the years ended August 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

5. TAX STATUS

The prototype plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter in 2014 in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be entitled to the full amount in their account as of the date of termination.

7. RELATED PARTY TRANSACTIONS

The Plan's investments are held by Mutual of America Life Insurance Company, as custodian; therefore, investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for administrative expenses were \$1,915 and \$1,080 for the years ended August 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment and account management services are a reduction of the return earned and are included in net appreciation in fair value of investments.

Personnel and facilities of Boone Transportation, Inc., which are used by the Plan for its accounting and other activities, have been provided at no charge to the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Independent Auditor's Report

To the Plan Administrator and Management of
the Boone Transportation, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Boone Transportation, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Boone Transportation, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material

respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Boone Transportation, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Boone Transportation, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of August 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of

1. DESCRIPTION OF THE PLAN

The following description of the Boone Transportation, Inc. Retirement Plan (the "Plan") provides only general information. Interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan was effectively adopted on September 1, 1994. The Plan is a defined contribution employee benefit plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan covers employees of Boone Transportation, Inc. (the "Company") who have completed three months of service in a twelve month period.

Effective as of September 1, 2022, the Plan was amended to allow for hardship distributions.

Contributions - Participants are neither required nor permitted to contribute to the Plan. This retirement benefit is provided totally at the Company's expense.

Each year, the Company will determine the amount of the discretionary employer contribution, if any, that it will make for all eligible participants. This discretionary employer contribution will be made on behalf of a Classification Group by the Company and shall be allocated to the account of each participant who is a member of such Classification Group. Each participant will be in a separate Classification Group as follows:

- Group A is defined as "Owners"
- Group B is defined as "Office and Shop Employees"
- Group C is defined as "Drivers and Driver Assistants"

If the Company makes a contribution to the Plan on behalf of the eligible Plan participants, the participants are given the option of allocating all or a portion of such contribution to group medical coverage.

For the years ended August 31, 2024 and 2023, the Company made the following contribution on behalf of each Classification Group:

- Group A (Owners) - received an allocation equal to 10.8% and 10.8%, respectively, of base compensation offset by any amounts used for group medical coverage
- Group B (Office and Shop Employees) - received an allocation equal to 10.52% and 10.52%, respectively, of base compensation offset by any amounts used for group medical coverage
- Group C (Drivers and Driver Assistants) - full route drivers received an allocation of \$1,250 and \$1,250, respectively, offset by any amounts used for group medical coverage; half route drivers received an allocation of \$625 and \$625, respectively, offset by any amounts used for group medical coverage

1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts - Each participant's account is credited with the employer's contribution, if any, as well as an allocation of the Plan's earnings and administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from that participant's vested account.

Vesting - Participants are always 100 percent vested in the employer contributions plus actual earnings thereon.

Participant Loans - Loans are not permitted under this Plan.

Payment of Benefits - On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) shall have a nonforfeitable right to receive the full amount available for distribution from their account. Distributions are paid in lump-sum amounts or installment payments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The Plan's investment held in the interest accumulation account at August 31, 2024 and 2023 represents funds held in the general account of Mutual of America Life Insurance Company and is valued at cost, which approximates fair value. The account is comparable to a cash equivalent and is not a fully benefit-responsive investment contract. The account earns interest at a guaranteed rate set annually that cannot be less than 0.15% or more than 3%. The interest rate for 2024 was 2.85% and 1.6% for 2023. There are no adjustments or charges that would affect the value of the account as a result of a withdrawal request. There are no reserves against the account value for credit risk.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. For the years ended August 31, 2024 and 2023, the Plan paid \$1,915 and \$1,080, respectively, in administrative fees.

Risks and Uncertainties - The Plan provides for various investment options in any combination of investment securities based upon participant requests. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - Subsequent events were evaluated through June 9, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at August 31, 2024 and 2023, and investment income for the years ended August 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company (the custodian of the Plan).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

Pooled separate account: The Plan's pooled separate account is stated at fair value and consists solely of investments in mutual funds registered with the U.S. Securities and Exchange Commission and is carried at the net asset value at which the mutual fund shares are actively traded. The funds must publish their daily net asset value and transact at that price.

Interest accumulation account: The Plan's interest accumulation account is comparable to a cash equivalent and is stated at cost, which approximates fair value.

Gains and losses included in changes in net assets available for benefits for the years ended August 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

5. TAX STATUS

The prototype plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter in 2014 in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be entitled to the full amount in their account as of the date of termination.

7. RELATED PARTY TRANSACTIONS

The Plan's investments are held by Mutual of America Life Insurance Company, as custodian; therefore, investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for administrative expenses were \$1,915 and \$1,080 for the years ended August 31, 2024 and 2023, respectively. Fees paid by the Plan for the investment and account management services are a reduction of the return earned and are included in net appreciation in fair value of investments.

Personnel and facilities of Boone Transportation, Inc., which are used by the Plan for its accounting and other activities, have been provided at no charge to the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
