### **Opinion**

We have audited the accompanying financial statements of Glaziers, Architectural Metal & Glass Workers Local Union #1399 Health & Health Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Glaziers, Architectural Metal & Glass Workers Local Union #1399 Health & Welfare Trust (the "Plan") is a multiemployer defined benefit welfare plan providing medical, vision, prescription drug, dental, vacation and life insurance benefits to eligible participants and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Active participants are eligible for those benefits specified in their collective bargaining agreement. Dependents of eligible active participants are also eligible to receive benefits. Retired participants covered under the eligibility rules for retired participants and their dependents are eligible for limited benefits under the Plan if the requirements set forth for participation are met and upon payment of the substantial portion of the cost of their benefits. The Plan documents include detailed rules for each situation.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting periods. Actual results may differ from those estimates.

**C. Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for the hours worked during the year and participant contributions are for coverage during the year. Employer and participant contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

**E. Investments**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**E. Investments (Continued)**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are generally unobservable and typically reflect management’s estimates and assumptions that market participants would use in pricing the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodologies used for the assets measured at fair value:

Mutual Funds – the closing price reported on the active market on which the mutual funds are traded.

Common Trust Fund – value at net asset value (“NAV”) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment strategy is to seek an investment return that approximates as closely as practicable, before expenses, the performance of a custom index over the long term.

Net appreciation (depreciation) of investments includes net unrealized appreciation (depreciation) of investments and realized gains and losses on sale of investments.

**F. Cash and Cash Equivalents**

Cash and cash equivalents consist of cash on deposit with financial institutions in checking accounts and a money market fund.

**G. Benefits**

Benefits reported on the statements of changes in net assets available for benefits are benefits paid for eligible participants during the year. Benefit obligations are segregated on the statements of benefit obligations based on unpaid benefits as of the end of the year (premiums, claims and vacation benefits payable) and future benefit costs to be incurred based on participants' accumulated eligibility credits (future benefits based on participants' accumulated eligibility). The statements of changes in benefit obligations reports the components of the changes in benefit obligations.

**H. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 3 - ADMINISTRATION - GENERAL**

Pacific Southwest Administrators provided administrative services to the Plan for a monthly fee of \$12.06 per reported participant, with a minimum fee of \$4,223 per month through December 31, 2023. Effective January 1, 2024, the monthly fee increased to \$12.66 per reported participant, with a minimum monthly fee of \$4,434.

**NOTE 4 - RETIREE BENEFITS**

If a participant is covered under the Plan prior to retirement, then the participant will be able to continue benefits upon retirement by making monthly contributions which are set from time to time by the trustees. The only benefit provided to retirees is medical, if the retiree or his or her spouse is under age 65. The current monthly contributions for medical benefits vary depending on level of participation.

Since the retirees are self paying a substantial portion of the cost of benefits provided to them, the postretirement benefit obligation is estimated not to be significant.

**NOTE 5 - PRIORITIES UPON TERMINATION**

Except as may be otherwise provided by law, in the event of termination of Agreement and Declaration of Trust, the Plan provides that any and all monies remaining after payment of all expenses and obligations shall be expended and used for the continuance of purposes of the Plan until such monies are exhausted.

**NOTE 7 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**NOTE 8 - CONCENTRATION OF CREDIT RISK**

During the year ended August 31, 2024, the Plan maintained bank accounts with cash balances in excess of the Federal Deposit Insurance Corporation limit of \$250,000 per bank. The amount in excess of the limit is subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balance.

**NOTE 9 - TRANSACTIONS WITH RELATED PARTIES**

The Plan collects employer contributions for the Plan and other related organizations through a lockbox system. Employer contributions and remittances collected on behalf of the related organizations that were not transferred to the related organizations as of the end of the year are recognized as due to related organizations - net.

The Plan also shares common administrative expenses with related organizations. These common expenses are paid by the Plan and allocated to the other organizations based on predetermined allocation formulas periodically approved by the Board of Trustees.

**NOTE 10 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through June 10, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
