INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of ChannelAdvisor Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of August 31, 2024, and the related statement of changes in net assets available for benefits for the eight-month period then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all

material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter

As discussed in Note A to the financial statements, during the eight-month period ended August 31, 2024, all assets and participant account balances of the Plan were transferred to the Rithum Corporation 401(k) Plan. As a result, the Plan had no assets or participants as of August 31, 2024 and has ceased operations as a separate entity. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Auditor's Report on the 2023 Financial Statements

The financial statements of the Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 2, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles

generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules related to assets held for investment for which the certified investment information were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A--DESCRIPTION OF THE PLAN

The ChannelAdvisor Corporation 401(K) Profit Sharing Plan (the "Plan") was formed on July 1, 2001.

The following description of the Plan provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all United States-based employees of ChannelAdvisor Corporation and its wholly owned subsidiaries (collectively, the "Company" or "Plan Sponsor"). In November 2022, the Company was acquired by CommerceHub, Inc. and in December 2023 changed its name to Rithum Corporation. Employees are eligible to participate in the Plan on the first day of the first month following their hire dates, unless that day falls on the first day of the month, in which case they are eligible on their dates of hire, as long as they have attained age 21. The Plan was managed by the Plan Committee. Empower Trust Company, LLC served as the Plan's trustee (the "Trustee") and Empower Annuity Insurance Company of America served as the Plan's custodian (the "Custodian"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Merger

Effective January 1, 2024, the Plan Committee of the Plan approved the merger of the Plan into the Rithum Corporation 401(k) Plan (formerly CommerceHub 401(k) Plan). As a result of the merger, all participant account balances and assets were transferred to the Rithum Corporation 401(k) Plan, between the effective date of the merger and August 31, 2024.

Contributions

Plan participants could contribute up to 100% of total compensation as defined in the plan document, but participants could not exceed the statutory limit defined by the Internal Revenue Code ("IRC"). Participants who had attained the age of 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Plan participants were allowed to make Roth contributions to the Plan.

Plan participants could elect to make an in-Plan Roth transfer from the vested portion of their accounts. Loans could not be distributed as part of an in-Plan Roth transfer.

The Company could, at its sole discretion, make matching contributions or nonelective contributions to the Plan. The Company's discretionary matching contribution was 50% of the first 6% of eligible compensation. Participants had to have completed at least 1,000 hours of service and be employed as of the last day of the plan year in order to be eligible for nonelective contributions. There were no contributions after the effective date of the plan transfer.

Participants' Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. There were no participant accounts remaining in the Plan as of August 31, 2024.

Vesting

Participants were vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's matching contribution and any nonelective contributions plus actual earnings thereon was based on qualified years of service. The following schedule applied to employer matching contributions and nonelective contributions:

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loan term was up to five years for a general-purpose loan and up to 25 years for loans initiated through October 29, 2015, and 15 years for loans initiated thereafter for the purpose of purchasing a principal residence. Only one loan could be outstanding for a participant at a point in time. The loan was secured by the balance in the participant's account and bore interest at a rate equal to the Prime rate plus 2%. Principal and interest were paid ratably through monthly payroll deductions.

Payment of Benefits

Generally, the participant became eligible to receive benefits upon attaining normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. The participant or beneficiary could receive all of the participant's vested account balance in a lump-sum payment or installment payments. Participants were eligible to take in-service withdrawals once they attained age 59½. In the case of a qualified reservist called to active duty, a participant could withdraw all or part of his or her elective deferrals plus earnings. Upon approval by the plan administrator, a participant could withdraw all or part of his or her vested contributions for immediate and heavy financial need, in accordance with Internal Revenue Service ("IRS") regulations.

Participants could also roll over the vested interest in their accounts into individual retirement accounts or other qualified plans. There were no benefit payments during the eight-month period ended August 31, 2024.

Forfeited Accounts

Forfeitures represented nonvested Company discretionary matching contributions and nonelective contributions of participants who had terminated their employment with the Company. Forfeited balances were used to pay Plan administrative expenses or reduce future employer contributions. As of December 31, 2023 forfeited nonvested accounts totaled \$183,768. The entire forfeited nonvested account balance was transferred to the Rithum Corporation 401(k) Plan on the effective date of the transfer.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results could differ from those estimates.

Investment and Securities Transactions

The Plan's investments are stated at fair value. All Plan assets were transferred to the Rithum Corporation 401(K) Plan before close of business on August 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Trustee, custodian, recordkeeping, and investment management fees are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE C--FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Financial Accounting Standards Board ("FASB") guidance defines fair value and establishes a framework for measuring fair value and related disclosure requirements.

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in those active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair value of investments held in mutual funds and money market funds are based on the quoted net asset values of the investments held by the Plan at year-end. The fair value of common stocks is based on the closing price per the primary stock exchange on which they are traded. Unit investment trusts are valued at the daily closing price as reported by the trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

NOTE D--CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the financial statements, including investments held at August 31, 2024 and December 31, 2023, and the net depreciation in fair value of investments for the eight-month period ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC.

NOTE E--RELATED PARTY TRANSACTIONS

The Plan invested in shares of mutual funds managed by Empower prior to the transfer. Empower Trust Company, LLC is the Trustee and custodian of the Plan and Empower Annuity Insurance Company of America is the custodian of the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

NOTE G--TAX STATUS

The Internal Revenue Service ("IRS") has issued an opinion letter dated November 11, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan was designed, and was being operated, in compliance with applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has any uncertain position that more likely than not would not be sustained upon examination by the IRS or the U.S. Department of Labor.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of August 31, 2024 and December 31, 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by federal taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE I--SUBSEQUENT EVENTS

In accordance with U.S. GAAP, the Plan has evaluated for subsequent events between the statement of net assets available for benefits date of August 31, 2024, and June 13, 2025, the date the financial statements were available to be issued.
