## INDEPENDENT AUDITORS' REPORT

### **Opinion**

We have audited the accompanying financial statements of The Lee Company Group Life, Disability, Medical and Dental Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of plan benefit obligations of The Lee Company Group Life, Disability, Medical and Dental Plan as of August 31, 2024 and 2023, and the changes in its net assets available for benefits and of changes in plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTE #1 - PLAN DESCRIPTION

Description of Plan

The following description of The Lee Company Group Life, Disability, Medical and Dental Plan (the “Plan”) provides only general information. U.S. employees of The Lee Company should refer to the Plan agreement for a complete description of the provisions of the Plan sponsored by The Lee Company (the “Company”).

General

The effective date of the Plan is January 1, 1950, and the Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan provides medical, disability, accidental death and dismemberment, dental, vision and life insurance benefits covering substantially all hourly and salaried U.S. employees of the Company.

All medical and dental claims are processed and adjudicated, on behalf of the Plan, by Anthem Blue Cross & Blue Shield of Connecticut (“Anthem”). Once adjudicated, these claims are paid by Anthem via the Plan’s bank account, which is funded by the Company, under a self-insurance arrangement. Beginning in May 2024, all claims are now paid directly from the Company’s operating account. Vision benefits are provided by Anthem to participants under a fully insured arrangement. The Company self-insures its short-term disability benefits. Mutual of Omaha processes and adjudicates short-term disability claims, on behalf of the Plan, but such benefits are fully paid by the Plan. Effective January 1, 2022, the State of Connecticut enacted the Paid Family and Medical Leave Act (PFMLA) which is a program administered by the CT Paid Leave Authority that offers Connecticut employees access to paid time off for qualifying life events. Upon enactment, PFMLA became the primary and first payer of short-term disability claims with the Plan absorbing any excess costs. The Plan allows for a higher amount of weekly benefits and a longer duration of leave, thus the Plan pays claims exceeding PFMLA limits but within Plan limits. Life insurance, long-term disability and accidental death and dismemberment benefits are provided by Mutual of Omaha on a fully insured basis.

The Plan’s cash balances are held in non-interest bearing cash accounts.

Benefits

The Plan provides hospital, surgical, major medical, dental, life insurance, short-term and long-term disability, and accidental death and dismemberment benefits for eligible employees, their beneficiaries and their dependents. The Plan also offers eligible employees the opportunity to purchase vision coverage as a voluntary benefit. Such vision benefits are provided by Anthem under a fully insured arrangement, whereby employees who elect the coverage pay the full amount of the associated premium, through payroll deductions.

Current medical claims of participants and their beneficiaries and dependents are administered under group service contracts.

Plan obligations for health claims incurred but not reported, claims in process and related administration fees at year-end are estimated and are updated to reflect recent actual experience each year.

Contributions

The Plan pays actual medical claims as they are invoiced from Anthem. For the fiscal years ended August 31, 2024 and 2023, insurance coverage was provided by Anthem for claims above \$250,000 annually per participant. The cost of the stop loss coverage is funded through the premiums paid to Anthem. The Plan reports claim payments on the statements of changes in net assets available for benefits, net of recoveries from stop loss coverage. Recoveries from stop loss coverage were \$607,691 and \$2,192,137 for the fiscal years ended August 31, 2024 and 2023, respectively. The Company is required to make contributions to the Plan to fund the actual medical and dental claims as well as the administrative costs of processing such claims. These administrative costs are calculated by Anthem per the administrative services agreement and are based on the number of participating employees and the volume of claims.

The Lee Company also makes contributions to the Plan to fund premiums for life insurance, certain disability and accidental death and dismemberment benefits, which are insured by Mutual of Omaha. Short-term disability benefits are fully paid by the Plan, except for those covered by the Connecticut PFMLA as described previously.

Participants contribute specified amounts determined by the Plan's administrator for benefits offered by the Plan. Contributions are made by active employees on a pretax basis pursuant to Section 125 of the Internal Revenue Code. Participant contributions also include COBRA payments from former employees. Prior to January 1, 2023, active employees were required to make contributions toward their medical benefits. Effective January 1, 2023, such contributions by active employees for medical benefits were terminated. Participant contributions are still required for participants who elect COBRA coverage and participants who voluntarily elect to have vision coverage offered by the Plan.

NOTE #2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan have been prepared on the accrual basis of accounting.

The Plan's benefit obligations are comprised of claims in process, claims incurred but not reported and related unpaid administration fees as of plan year-end. Such claims are recognized in the plan year on an occurrence basis. The methodology for developing claim reserve liabilities assumes that patterns that have existed in the past, for the time between when health services are provided and when the related claims for these services are paid, will be repeated in the future.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Such estimates include the reserves for claims incurred but not reported and claim administration fees. Accordingly, actual results may differ from those estimates.

Administration fees charged by Anthem and Mutual of Omaha related to the maintenance and general administration of the Plan, are paid for by the Plan. All other expenses, including but not limited to legal and accounting fees, are paid by the Company.

Date of Management Evaluation

Management has evaluated subsequent events through June 2, 2025, the date on which the financial statements were available to be issued.

NOTE #3 - TAX STATUS

The Plan is a self-funded health and welfare plan. The Company has established a non-exempt trust as of April 1, 1988 to hold the assets of the Plan. The trust is qualified pursuant to section 419(e) of the Internal Revenue Code, as amended.

NOTE #4 - TERMINATION PRIORITIES

The Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. If terminated, the related assets will be held in trust in accordance with the requirements of ERISA.

For Form 5500 reporting purposes, claims in process, claims incurred but not reported, claim administration fee reserve, amounts due to claims processor, and premiums due to insurance carriers are recorded as liabilities. For financial statement purposes, such amounts are recorded as benefit obligations.

NOTE #6 – RISKS AND UNCERTAINTIES

Health claims incurred but not reported are determined using historical experience of claims reported as well as other timing factors, all of which are subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates in the near term could materially affect the amount reported and disclosed in the financial statements.

NOTE #7 – FIDUCIARY BOND

The Plan was covered by an ERISA fidelity bond of \$500,000 for plan years ending August 31, 2024 and 2023.

NOTE #8 – TRANSACTIONS WITH PARTIES IN INTEREST

Anthem and Mutual of Omaha provided certain administrative services and certain insurance coverages to the Plan, and the associated fees for these services and were paid by the Plan. Certain employees of the Company who participate in the Plan provide administrative services to the Plan, at no cost. The Company, as plan sponsor, also paid certain administrative fees on behalf of the Plan during 2024 and 2023, which included legal and accounting fees.
