NOTE 1 • DESCRIPTION OF THE PLAN

The following description of Miskelly's Furniture Warehouse, Inc. (hereafter referred to as the "Company") Employee Benefit Plan Trust (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is an employee benefit plan trust and is considered to be a defined benefit health and welfare plan. The Plan provides self-funded insurance benefits covering all full-time employees who have met the employment waiting period. The waiting period is complete for employees on the first of the month following a service period of sixty (60) consecutive days. The Plan and related trust were established on September 1, 1996. The Board of Trustees and Plan Administrator of the Company control and manage the operation and administration of the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Company is a private company established in 1996 and incorporated in Mississippi. Its primary business activity is retail sales of premier furniture. It operates in the State of Mississippi.

Contributions

The Plan is funded through contributions made by the Company, participating employees and the purchase of aggregate and specific excess loss insurance. In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. In no event is the Company required to make contributions to the Plan over the aggregate attachment point on all participants as described in the aggregate and specific excess loss insurance policy.

Benefits

The Plan provides payment of all or a portion of covered medical and prescription claim expenses as incurred by a Plan participant and their covered dependents for care of an injury or sickness while the person is covered for these benefits under the Plan. Each calendar year, benefits will be paid for the covered charges of a Plan participant. Payment will be made at the rate determined within the Plan's schedule of benefits. No benefits will be paid in excess of the lifetime maximum amount.

Effective January 1, 2024, medical claims processing for active participants and dependents changed from HealthSmart Benefit Solutions, Inc., to UMR, Inc. Prescription claims for active participants and dependents are currently processed by HealthSmart Benefit Solutions, Inc., but the responsibility for payments to participants and providers is retained by the Plan.

Benefits (continued)

The Plan utilized a pharmacy benefit manager ("PBM") which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Administrative Expenses

Administrative fees related to the management of the Plan and medical management services were absorbed by the Plan. All other administrative expenses of the Plan are absorbed by the Plan sponsor.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosures of contingent assets and liabilities as discussed in Note 3 and Note 8. Accordingly, actual results may differ from those estimates.

Cash

Cash includes operating funds on deposit at a local financial institution.

Contributions

Contributions from the employer and from participating active members and employees are recognized as additions to net assets on a monthly basis coinciding with the month of coverage.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims' processor. These payments are recorded as benefits paid in the accompanying statements of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are recognized when paid as deductions from net assets in the accompanying statements of changes in net assets available for benefits.

Postretirement Benefits

There is no post-retirement benefit obligation due to the nature of the Plan.

Subsequent Events

Subsequent events were evaluated by the Plan through June 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at August 31, 2024 and 2023, for health claims incurred, but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

NOTE 4 • BENEFIT OBLIGATIONS

The Plan's benefit obligations at August 31, 2024 and 2023, relate primarily to the claims payable and claims incurred and not reported as of year-end as included on the statements of benefit obligations. It is expected that the benefit obligations will be funded using plan assets.

NOTE 5 • EXCESS LOSS INSURANCE

In accordance with general practice with self-insurance, the Plan purchases excess loss insurance to cover risks in excess of what it is prepared to accept. The policy covers claims exceeding \$80,000 per individual with a maximum aggregate benefit of \$99,999,999. Excess loss insurance does not discharge the Plan from its primary liability to the covered participants. Consequently, the failure of the insurer to honor its obligation could result in additional claims to the Company.

NOTE 6 • PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan paid \$56,879 and \$65,179, respectively, in administrative expenses to parties-in-interest. These fees were based on customary and reasonable rates for such services.

During 2024 and 2023, the plan sponsor paid \$204,926 and \$227,663, respectively in excess loss insurance premium payments on behalf of the Plan. These fees were based on customary and reasonable rates for such services.

NOTE 7 • INCOME TAX STATUS

The Plan sponsor believes the Plan qualifies and operates in accordance with applicable provisions of the Internal Revenue Code. There were no uncertain tax positions identified related to the current year and the Plan has no unrecognized tax benefits at August 31, 2024 and 2023, for which liabilities have been established. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 8 • RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

NOTE 9 • SUBSEQUENT EVENTS

Effective September 1, 2024, Verus RX began processing prescription claims for all active participants and dependents.
