The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to the Financial Statements
December 31, 2024

1. Description of Plan

The following description of the Iroquois Industrial Group, LLC 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees who have 90 days of service of the Iroquois Industrial Group LLC (d/b/a T&D Metal Products), D&D Napa Inc., C&L Trucking and Maintenance LLC, Majac Steel & Processing LLC, Savannah Industrial Solutions LLC, Benda Conveyor Solutions LLC, Mod Interiors LLC, and SRCL Equity Holding LLC (collectively the Company), except collectively bargained employees and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was restated effective January 1, 2023. In February 2023, the Company acquired Mod Interiors LLC, and employees of this company became eligible to participate in the Plan.

On May 31, 2023, Majac Steel & Processing LLC was dissolved; all employees of that entity who were participants in the Plan became 100 percent vested in all their contributions.

Contributions – Each year, participants may elect to defer a portion of their annual compensation as defined by the Plan, on a pre-tax or post-tax (Roth) basis. Participants may also contribute amounts representing distributions from other qualified plans. The maximum contribution to the Plan in any year is determined by provisions in the Plan, the Internal Revenue Code (IRC), and Income Tax Regulations. Participants direct the investment of these contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offered various mutual funds and a common collective trust as investment options for participants.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 2 percent unless they affirmatively elect not to participate. The Plan also includes an automatic escalation provision whereby contribution rates for participants subject to the automatic enrollment feature are increased by 1 percent each year until a rate of 10 percent is reached, unless elected otherwise by participants.

The Company makes matching contributions equal to 25 percent of the employee's salary deferral amounts up to 5 percent of plan compensation. The Company may also make an additional profit-sharing contribution at the discretion of the Company's management. For the year ended December 31, 2024, the Company did not elect to make an additional profit-sharing contribution.

Participant Accounts – Each participant’s account is credited with the participant’s contribution, if any, and allocations of (a) the Company’s contribution, if any, (b) certain administrative expenses, as applicable, and (c) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their account plus earnings thereon is based on years of service, and a participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 (reduced by the excess, if any, of the participant’s highest outstanding note balance during the one-year period ending on the day before the date on which such note is made over the participant’s outstanding balance of notes on the date such note was made) or 50 percent of the participant’s vested balance. Note terms range from one to five years, except for the purchase of a primary residence, which is a longer term determined by the plan administrator. Participants may have only one outstanding loan at a time. The notes are secured by the vested balance in the participant’s account and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – On termination of service, for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan provides for an automatic lump-sum distribution of account balances of \$5,000 or less. In addition, in-service withdrawals of the participant’s vested interest are allowed for participants over age 59 ½. The Plan also allows for financial hardship withdrawals of all or part of the participant’s pre-tax deferral contributions and earnings thereon if the participant can prove financial hardship and is unable to meet their financial needs another way.

Forfeited Accounts – Forfeited amounts are allocated to pay plan expenses, reduce any Company contributions to be made for the plan year, or allocated to participant accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,034 and \$23,340, respectively. The Company utilized \$3,112 of forfeitures to pay administrative expenses during the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans that are fully collateralized but treated as deemed distributions under Form 5500 reporting rules are carried on the Plan’s books until a distributable event occurs based upon the terms of the plan document, at which time the loan is treated as a distribution.

Investment and Administrative Fees – The Plan’s expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain fees are charged to the Plan for services provided to the Plan. When applicable, these fees and fees charged by the Plan’s investment vehicles are netted with investment earnings.

Payment of Benefits – Benefits are recorded when paid for financial statement purposes.

Corrective Distributions – Corrections for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions.

Subsequent Events – The Plan has evaluated subsequent events through June 12, 2025, the date on which the financial statements were available to be issued.

3. Information Certified by Mid Atlantic Trust Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net depreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Mutual Funds*: Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

- *Common Collective Trust (CCT)*: The MetLife Stable Value Fund held by the Plan is a collective investment trust that invests in a fully benefit responsive group annuity contract with MetLife. The contract consists of the units of the MetLife separate accounts and an insurance wrapper that guarantees plan participants can transact at contract value in perpetuity. Withdrawals resulting from an employer or plan sponsor-initiated event (e.g. a decision to terminate the Plan's participation in the trust) could result in a payment less than the guaranteed value if the contract's market value is less than the guaranteed value.

Management has determined the CCT qualifies for the net asset value practical expedient under FASB ASC 820, and, as such, the CCT is not categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no unfunded commitments or redemption restrictions on the fund measured at net asset value per share using the practical expedient as of December 31, 2024 and 2023.

5. Administrative Expenses and Party-in-Interest Transactions

A transaction with a plan service provider or a participant of the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to Mid Atlantic Trust Company, the investment custodian, and Paychex, the third-party administrator and record keeper. Of these fees, \$22,375 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Additionally, certain plan investments are both held and managed by the custodian.

Notes receivable from participants are considered to be both a party-in-interest and a related-party transaction.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their Company contributions.

7. Tax Status

On August 31, 2020, the IRS stated that the pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the advisory letter. However, the plan administrator and the pre-approved plan provider believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no open audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the valuation techniques used for investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
