INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Road Carriers Local 707 Welfare Fund

Opinion

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Report on Supplemental Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedules of Benefits Paid, Schedules of Administrative Expenses, and Schedule of Assets Held at End of Year, together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year represent supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The supplemental information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

AUGUST 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

General

The following brief description of the Road Carriers Local 707 Welfare Fund (the Plan) provides only general information. Participants should refer to their Plan's applicable Summary Plan Description (SPD) for a more complete description of the Plan's provisions.

The Plan was adopted pursuant to the authority of the Board of Trustees granted under the agreement and declaration of trust entered into as of September 1, 1950. The Plan is a multi-employer health and welfare benefit plan covering employees of employers that have collective bargaining agreements between the Highway and Local Motor Freight Drivers, Dockmen and Helpers, Teamsters Local Union 707 (Union) affiliated with the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America and the various employers having collective bargaining agreements with the Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides hospitalization, medical, prescription drug, dental, death, and other benefits in accordance with the provisions of the rules and regulations of the Plan. The Plan maintains insurance contracts to provide HMO, life insurance and disability benefits. All other benefits are self-insured. Future benefits for retirees and their spouses are provided if the retiree meets the requirements in the SPD. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidation Omnibus Budget Reconciliation Act (COBRA).

Eligibility

An eligible employee is any individual who is employed by an employer and who is covered by a collective bargaining agreement between the employer and the Union that provides for contributions to the Plan. Under the monthly eligibility method, eligible employees who have contributions made to the Plan on their behalf by a contributing employer for a calendar month are eligible for coverage for the second calendar month following their first day of work. Under the quarterly eligibility method, eligible employees who complete fifty-two 8-hour days, or 416 hours, of covered employment with a contributing employer during three consecutive months ending one month before June 1, September 1, December 1 or March 1 (Quarterly Determination Date) are covered by the Plan for the four-month period that commences on the next Quarterly Determination Date. Future benefits for retirees and their spouses are provided if the retiree meets the requirements stated in the Summary Plan Description (SPD).

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition - Investments are carried at fair value which generally represents quoted market prices or net asset value of the fund as of the last business day of the fiscal year as provided by the custodian. Short-term investments are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions Receivable - Employer contributions due and not paid prior to year end are recorded as contributions receivable. Allowance for uncollectible accounts is considered unnecessary and is not provided.

Property and Equipment - Property and equipment are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation is computed over the estimated useful lives for furniture and computer equipment by the straight-line method. Depreciation expense totaled \$7,088 and \$2,446 for the years ended August 31, 2024 and 2023, respectively.

Securities Purchased or Sold and Not Settled - This represents the amounts due from or to the custodial bank for the sale or purchase of securities with trade dates prior to year end and settlement dates after year end.

Payment of Benefits - Benefit payments are recorded when paid.

Estimated Claims Incurred but not Reported - Estimated claims incurred but not reported at year end were estimated by the Plan's consultant based on historical claims experience.

Accumulated Eligibility Credits - The obligation for accumulated eligibility credits was estimated by the Plan's consultant.

Postretirement Benefits - The amount reported as the postretirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The actuarial present value of the expected postretirement benefit obligation is determined by the actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Medical and Prescription Refunds and Rebates - Refunds and rebates due from the Plan's medical benefit manager and pharmacy benefit manager are recorded when earned. Pharmacy rebates totaling \$1,072,713 and \$1,409,172 have been netted with benefits paid in the accompanying statements of changes in net assets available for benefits for the years ended August 31, 2024 and 2023, respectively.

Stop Loss - Premiums from stop loss insurance are included in benefits paid in the accompanying statements of changes in net assets available for benefits. Stop loss reimbursement totaling \$1,744,401 have been netted with the benefits paid in the accompanying statements of changes in net assets available for benefits for the year ended December 31, 2024.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. FUNDING POLICY

The Plan is financed by employer contributions, retiree contributions, and contributions from participants electing COBRA coverage. The employer contribution rates are specified in the collective bargaining agreements.

NOTE 4. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 5. TAX STATUS

The Plan obtained its latest exemption letter on September 8, 1997 in which the Internal Revenue Service stated that the Plan design was in compliance with the applicable requirements of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(c)(9). The Plan has been amended since receiving the determination letter. The Plan's Trustees and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended August 31, 2024 and 2023 there were no transfers in or out of levels 1, 2 or 3.

NOTE 7. CONCENTRATIONS

Financial instruments that potentially expose the Plan to concentrations of credit risk include cash and investments. The Plan maintains accounts at high quality financial institutions. While the Plan attempts to limit its financial exposure, deposit balances may, at times, exceed federally insured limits. The Plan has not experienced any losses on such accounts.

NOTE 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Identification of Related Organizations

The Plan has the following related entities with which it has transactions:

- Road Carriers Local 707 Pension Fund
- Teamsters Local Union 707 (Union)

All of the above entities qualify as tax-exempt organizations. The entities listed above share common Trustees or officers with this Plan.

Administrative Expenses

The Plan shares facilities and staff with related organizations. The Plan operates in a jointly administered office with the Road Carriers Local 707 Pension Fund (Pension Fund). Certain administrative expenses which are common to the Plan and Pension Fund are apportioned between them. Direct charges are made for expenses when totally applicable. Payroll expenses allocated to the Pension Fund for the years ended August 31, 2024 and 2023 were \$131,447 and \$138,752, respectively. The total amounts allocated to the Pension Fund for shared administrative expenses were \$270,231 and \$170,561 for the years ended August 31, 2024 and 2023, respectively. The Pension Fund owed the Plan \$102,566 and \$64,124 for shared expenses for the years ended August 31, 2024 and 2023, respectively.

The Plan and Pension Fund are parties to an agreement with the Union whereby the Union provides administrative services to both plans. The Plan reimbursed the Union in the amount of \$107,546 and \$107,471 for the years ended August 31, 2024 and 2023, respectively. The Plan owed the Union \$21,615 for administrative services for the year ended August 31, 2024

The Plan subleases office space from the Teamsters Local Union 707. The lease is considered an operating lease and is paid on a month-to-month basis. Rent expense totaled \$38,649 and \$38,443 for each of the years ended August 31, 2024 and 2023, respectively.

Certain Plan assets were invested in a common trust fund managed by the custodian of the Plan. These transactions are party in interest transactions under ERISA.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 10. POSTRETIREMENT BENEFIT OBLIGATIONS

The Plan provides certain health care coverage to eligible retirees and their dependents.

Accounting principles generally accepted in the United States of America require that the Plan include the actuarial present value of postretirement benefit obligations in the benefit obligations of the Plan.

NOTE 10. POSTRETIREMENT BENEFIT OBLIGATIONS (continued)

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

The actuarial valuations were made using the projected unit credit cost method. The following are significant assumptions used in the postretirement benefit obligation valuations as of August 31, 2024 and 2023:

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

From August 31, 2023 to August 31, 2024 total postretirement benefit obligation decreased by \$25,071. This was due to an experience gain of \$30,614, benefits paid during the year and changes in actuarial assumptions. These amounts were partially offset by benefits earned in the year of \$5,438, and an increase due to passage of time.

The Plan's excess of benefit obligations over net assets available for benefits at August 31, 2024 and 2023 relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreement. It is expected that the excess will be funded through future increases in the collectively bargained contribution rates and/or amendments to the benefits provided under the Plan.

The weighted average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point, it would increase the obligation by \$2,797 and \$5,166 as of August 31, 2024 and 2023, respectively.

NOTE 11. BENEFIT PLANS

Substantially all of the Plan's full-time employees are covered by a multiemployer welfare benefit plan and a multiemployer defined benefit pension plan.

NOTE 13. RISKS AND UNCERTAINTIES

The actuarial estimate of benefit obligations is reported based on historical claim's experience and certain assumptions pertaining to interest rates, health care inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 14. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through June 10, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
