## Independent Auditors' Report

### The Plan Administrator CAIPA MSO LLC 401(k) Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of CAIPA MSO LLC 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### *Opinion*

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **1. Description of Plan**

The following description of the CAIPA MSO LLC 401(k) Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of CAIPA MSO LLC (the "Employer" or "Company") and the following participating employer, Accord Medical Care PC. An employee will not be eligible if they are an employee in a unit covered by any collective bargaining agreement, nonresident alien or a part-time, temporary or seasonal employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Eligibility***

Employees become eligible to participate in the Plan upon completing three months of service and reaching the age of 21. Once these eligibility requirements are met, employees may enroll in the Plan on a semi-annual basis, with entry dates of January 1 and July 1.

#### ***Contributions***

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer will make a safe harbor matching contribution to the plan. The safe harbor contribution formula used is 100% of elective deferral contributions that are not over 6% of compensation.

The Employer may make a discretionary contribution. For the 2024 plan year, no discretionary contributions were made to the Plan.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of Plan (*continued*)

#### ***Vesting***

A participant is 100% vested in their contributions plus allocated earnings thereon at all times. Participants hired before January 31, 2024, are 100% vested in employer contributions plus allocated earnings thereon. Participants hired on or after January 31, 2024, vested in the employer contribution according to the following schedule:

#### ***Payment of Benefits***

Benefits are paid upon retirement, death, or other termination of employment. Upon termination of service, a participant's balance will be paid in a lump-sum amount equal to the participant's account balance. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. A participant may request an in-service withdrawal upon reaching age 59 ½. Upon termination if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan follows U.S. GAAP guidance which removed the requirement to categorize within the fair value hierarchy investments whose fair value is measured using net asset value ("NAV").

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value since it is fully benefit-responsive. The common/collective trusts are valued at the NAV of units held by the Plan. The NAVs, as provided by the trustees, are used as a practical expedient to estimate fair value. The NAVs are based on the fair value of the underlying investments held by the funds less their liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The group annuity contract is valued at contract value, which represents contributions, plus earnings, less participant withdrawals and administrative expenses. The mutual funds and money market fund held by the Plan are valued at fair value based on the daily closing price as reported by the funds. The funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payments of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is June 4, 2025.

### 5. Common/Collective Trusts

The Plan offers various common/collective trusts called the Principal LifeTime Hybrid CIT Z55 Funds (“Funds”). These Funds include: The Principal LifeTime Hybrid 2015 CIT Z55 Fund; the Principal LifeTime Hybrid 2020 CIT Z55 Fund; the Principal LifeTime Hybrid 2025 CIT Z55 Fund; the Principal LifeTime Hybrid 2030 CIT Z55 Fund; the Principal LifeTime Hybrid 2035 CIT Z55 Fund; the Principal LifeTime Hybrid 2040 CIT Z55 Fund; the Principal LifeTime Hybrid 2045 CIT Z55 Fund; the Principal LifeTime Hybrid 2050 CIT Z55 Fund; the Principal LifeTime Hybrid 2055 CIT Z55 Fund; the Principal LifeTime Hybrid 2060 CIT Z55 Fund; the Principal LifeTime Hybrid 2065 CIT Z55 Fund and the Principal LifeTime Hybrid 2070 CIT Z55 Fund. The unit value of each of these Funds is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. These Funds have no restrictions on withdrawals and have no unfunded commitments.

### 6. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the “PFIGO”) is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. The PFIGO guarantees principal and provides a stated crediting rate backed by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions, plus earnings, less participant withdrawals and administrative expenses.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant’s account balances. The rate is reset on a semiannual basis.

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. An employer level liquidation or employer initiated transfer of the Plan’s interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Employer chooses. Notification of a Plan’s intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charges will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan’s interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan’s interest in the contract. If this scenario occurs, the surrender charge will be billed to the Employer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (A1 as of March 2024), S&P Global (A+ as of April 2024), A.M. Best Company (A+ as of March 2024), and Fitch Ratings (AA- as of June 2024).

### 7. Party-in-Interest Transactions

Some of the Plan's investments are managed by Principal Life Insurance Company and Principal Trust Company, the trustees of the Plan, or an affiliate of the trustees of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

### 8. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 9. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### 10. Non-exempt Party-in-Interest Transactions

For the 2023 Plan period, the Employer failed to transmit to the Plan, contributions for participants totaling \$42,707 within the period prescribed by Department of Labor regulations. The employer made the necessary corrections on May 9, 2024.

### 11. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
