## REPORT OF INDEPENDENT AUDITORS

To the Retirement Plan Committee  
Four Rivers Combined 401(k) Plan  
Paducah, Kentucky

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Four Rivers Combined 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 6, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended August 6, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of August 6, 2024 and December 31, 2023, and for the period ended August 6, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## 1. DESCRIPTION OF THE PLAN

The following brief description of the Four Rivers Combined 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering substantially all employees of Western Kentucky Regional Mental Health Mental Retardation Advisors Board, Inc. (the "Plan Sponsor") and adopting related employers, Four Rivers Behavioral Health ("Four Rivers") and OmniPath (collectively the "Organization" or "Employer"), that includes salary deferral features of Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is intended to meet the requirements of a qualified plan under section 401(a) of the IRC. The Plan provides for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

All employees are eligible upon the completion of 666 hours of service in an initial 8-month period, or if not completed, 1,000 hours of service during the first 12 months of employment (or each plan year thereafter). Participants enter the Plan on the first day of the first or seventh month of the Plan year after the eligibility requirements are met.

### Plan Merger

Effective January 1, 2024, the Plan Sponsor merged with Communicare, Inc. As a result, the Plan merged into the Communicare, Inc. 401(k) Plan (renamed the Inlet Health 401(k) Plan) effective August 6, 2024, and participant balances were transferred as of such date. See Note 9.

### Contributions

The Plan permits eligible employees through a salary reduction deferral election to make annual Roth and pre-tax contributions up to the current Internal Revenue Service ("IRS") deferral limits. Employee rollover contributions are also permitted. The salary reduction deferrals of only OmniPath employees are eligible for discretionary Employer matching contributions. For the period ended August 6, 2024, employees of OmniPath received an Employer match of up to 5% of compensation. Employees of Four Rivers are not eligible for the Employer match. Additional profit sharing amounts may also be contributed at the discretion of the Employer; however, no profit sharing contributions were made for the period ended August 6, 2024.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of: (a) the Organization's contributions, (b) plan earnings, and (c) plan expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Prior to January 1, 2024, the Plan was subject to a vesting schedule for employer contributions and earnings thereon. Under a plan restatement in 2024, vesting provisions were modified, and all employees of the Plan Sponsor hired on or after January 1, 2024 are now 100% vested immediately upon entry to the Plan. Participants with at least three years of service as of December 31, 2023 are also considered fully vested. Participants with less than three years of service as of such date are subject to the previous vesting schedule below.

## Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants can elect to receive a lump-sum amount equal to the value of their accounts. Upon reaching the age of 59 ½, a participant whose account is fully vested is entitled to receive a lump-sum payment equal to the value of the participant's account. A participant can make a hardship withdrawal, as defined in the plan agreement, from their elective deferral account prior to age 59 ½. Participants may also roll over their money into a qualified governmental plan prior to age 59 ½.

## Forfeited Accounts

At August 6, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$4,550, respectively. The Plan allows for forfeitures to be used to reduce Employer contributions or pay administrative expenses of the Plan. During the period ended August 6, 2024, forfeiture balances were used to reduce employer contributions.

## Administrative Expenses

Administrative expenses could be paid by the Organization or the Plan at the Organization's discretion. The Organization provides significant administrative services at no expense to the Plan.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The financial statements of the Plan have been prepared on an accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Plan Tax Status

The Plan is based on a preapproved plan document sponsored by CCH Incorporated DBA ftwilliam.com, which has received a favorable opinion letter dated June 30, 2020 from the IRS that the plan document was in compliance with the applicable requirements of the IRC and therefore exempt from federal income taxes. The Plan has not separately applied for an opinion letter from the IRS. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has concluded that as of

August 6, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, as of the date the financial statements were available to be issued, there were no audits for any tax periods in progress.

## Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the Statement of Net Assets Available for Benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements are available to be issued, which is May 9, 2025.

### **3. INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("RTC") (through June 30, 2024), Transamerica Trust Company (effective July 1, 2024) and Transamerica Life Insurance Company, Inc. ("Transamerica"), the custodians, have certified to the completeness and accuracy of all investments reflected in the accompanying Statements of Net Assets Available for Benefits as of August 6, 2024 and December 31, 2023, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the period ended August 6, 2024.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 6, 2024 and December 31, 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the hierarchy, the Plan's assets measured at fair value on a recurring basis at December 31, 2023:

### 5. INVESTMENT CONTRACT

The traditional investment contract held by the Plan is a guaranteed investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of this traditional investment contract held by the Plan was \$87,309 at December 31, 2023.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The guaranteed investment contract may be terminated by the issuer with 30 days advance written notice to the Organization for reasonable cause, which includes the Organization's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$20,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by the issuer, a market value adjustment may apply. The Organization does not foresee any of the above criteria occurring with the Plan that would permit the termination of the contract by the issuer in the immediate future.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 7. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Organization and certain others. Professional fees and certain other administration expenses of the Plan were paid by the Organization.

Transamerica Retirement Solutions, LLC is the recordkeeper of the Plan. Transamerica Life Insurance Company, is the issuer of the investment contract held by the Plan. Strategic Retirement Partners provide investment advisory and consulting services to the Plan. Effective January 1, 2024, Creative Retirement Solutions, Inc. is the third-party administrator of the Plan; prior to this date, ANEW 401k TPA, LLC served as the third-party administrator of the Plan. Payment for services to these providers were paid by the Plan directly or through a revenue-sharing arrangement. Blue & Co., LLC is the independent auditor of the Plan and receives payment from either the Plan or Plan Sponsor for this service.

## 8. PLAN TERMINATION

Effective August 6, 2024, the Plan merged with the Communicare, Inc. 401(k) Plan (subsequently renamed the Inlet Health 401(k) Plan). As of August 6, 2024, assets related to the Plan had been liquidated by the Trustee and were in transit to the custodian of the Inlet Health 401(k) Plan. This transfer amount is recorded as "Transfer Out" on the accompanying Statement of Changes in Net Assets Available for Benefits.
