**Independent Auditor's Report**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of New Horizons Employee Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) according to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in **NOTE 3** to the financial statements, is complete and accurate.

**Opinion**

#### **NOTE 1: PLAN DESCRIPTION**

The following description of the New Horizons Employee Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan was established on July 1, 1996, under the provisions of the Internal Revenue Service Code Section 401(a) for the benefit of employees of New Horizons Ranch & Center, Inc. (the "Organization"). The Plan allows eligible employees to accumulate funds for retirement, death, and disability benefits, subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### Plan Amendments

The Plan was restated effective September 1, 2021, as required by the IRS Cycle 3 Mandate. The restatement did not significantly impact the Plan's operations. It was most recently amended, effective January 1, 2024, to allow participants to make Roth contributions.

##### Plan Administration

The Plan is administered by the Plan Administrator, who is appointed by the Organization's Board of Directors. The Plan's custodian, John Hancock Life Insurance Company (the "Custodian"), is responsible for the custody of the Plan's assets.

##### Eligibility to Participate

Employees are eligible to participate in the Plan if they have completed two consecutive months of service and are at least 21 years old. Employees are eligible to receive employer contributions when they have completed one year of service and are at least 21 years old. Employees may enter the Plan on the first day of the first month and the seventh month of the Plan year following the date the requirements were met.

##### Employee Contributions

Participants may contribute to the Plan using either pre-tax compensation as salary deferrals or after-tax compensation as Roth 401(k) contributions. Participants may elect to contribute up to 100% of eligible compensation, not to exceed an annual dollar limit established by the Internal Revenue Service (IRS).

Participants may roll over amounts representing distributions from other qualified defined contribution plans.

##### Employer Contributions

The Organization may make matching contributions equal to a discretionary percentage of the participant's elective deferrals, determined by the Organization. If the Organization elects to make a matching contribution, it must be contributed to the Plan by the last day immediately following the Plan year quarter. The Organization shall have the right to make an additional discretionary contribution, which shall be allocated to each eligible participant in proportion to his or her compensation as a percentage of the compensation of all eligible participants. The discretionary contribution and the allocation thereof shall be unrelated to any employee contributions. Forfeitures may be used to pay the Plan's administrative expenses or to reduce any Organization contributions.

As required by the Internal Revenue Code, the Plan includes special rules in years that the Plan is determined to be a "Top Heavy Plan". The Plan becomes a "Top Heavy Plan" when it allocates more than sixty percent (60%) of the contributions or benefits to "Key Employees". "Key Employees" are owners, officers, shareholders, or highly compensated individuals. If the Plan becomes top-heavy in any year, the

Organization may be required to make an additional contribution with a special vesting schedule to non-key employees.

#### Participant Investment Options

Participants may direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. They can also direct their salary deferral contributions to any investments traded by the Custodian. Participants may change their investment options anytime throughout the year via direct phone access, fax, or the Internet.

#### Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and the Organization's discretionary contribution, as well as the participant's share of the Plan's income and any related administrative expense. Allocations of income and expenses are based upon the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their fund accounts up to a maximum of the lesser of one-half (1/2) of their vested balance or \$50,000. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and expensed when incurred. No allowance for credit losses has been recorded as of August 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

#### Forfeiture Accounts

As of August 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,054 and \$26,550, respectively. These accounts will reduce future employer contributions and/or offset plan expenses. During the year ended August 31, 2024 plan expenses were reduced by \$27,897 from forfeited non-vested accounts.

#### Payment of Benefits

Participants may elect to receive a lump sum equal to the value of their vested interest upon retirement, termination of service, death, or disability. The Plan may automatically pay out a terminated employee with a balance of less than \$1,000 upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election before termination upon attainment of age 65 or hardship as defined in the Plan document.

#### Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. To share in the allocation of matching contributions, a participant must be employed by the Organization on the last day of the Plan year.

#### Plan Termination

Although it has not expressed intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to fully terminate the Plan, subject to the provisions of ERISA. In the event of full Plan termination, participants will become one hundred percent (100%) vested in their accounts.

#### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The Plan's financial statements are prepared using the accrual method of accounting.

##### Investment Valuation and Income Recognition

Registered investment companies (mutual funds) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines valuation policies utilizing information from the investment advisor and custodian. See **NOTE 4** for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are accrued on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought, sold, and held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the Plan document's terms.

##### Payment of Benefits

Benefit payments to participants are recorded upon distribution. No amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid were payable on August 31, 2024, or 2023.

##### Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Administrative functions are performed by officers or employees of the Organization, but receive no compensation from the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in the fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

##### Use of Estimates

Preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Recent Accounting Pronouncements

The Plan has adopted all recent accounting pronouncements issued by the FASB (including its Emerging Issues Task Force) and the American Institute of Certified Public Accountants that management believes will have a material impact on the Plan's present or future financial statements.

**NOTE 3: INFORMATION CERTIFIED BY JOHN HANCOCK LIFE INSURANCE COMPANY,  
UNAUDITED**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at August 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended August 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan. The Plan's independent auditors did not perform any auditing procedures concerning this information except for comparing such information with the related information included in the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level of an asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following describes valuation methodologies used for assets at fair value. As of August 31, 2024, there have been no changes in the methodologies used.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at the closing price reported on an active market.

The methods above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with market participants, using different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

**NOTE 5: PARTIES-IN-INTEREST**

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company, the custodian as defined by the Plan. These transactions, therefore, qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$82,352 for the year ended August 31, 2024. Additional investment fees paid to parties-in-interest are netted against investment returns.

**NOTE 6: INCOME TAX MATTERS**

Effective September 1, 2021, the Plan adopted a non-standardized form of a prototype plan sponsored by CCH Incorporated. The prototype plan has received an opinion letter from the Internal Revenue Service (the “IRS”) as to the prototype plan’s qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain position that would more likely than not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with specific investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8: NON-EXEMPT TRANSACTIONS**

During the year ended August 31, 2024, the Plan sponsor inadvertently failed to deposit \$11,600 of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan sponsor will reimburse the Plan for lost interest of approximately \$11.

**NOTE 9: SUBSEQUENT EVENTS**

The Plan Administrator has evaluated subsequent events through June 13, 2025, the date the financial statements were available to be issued.
