## INDEPENDENT AUDITORS' REPORT

Members of the Board of Directors, Plan Administrator and Participants of  
Midland Christian School Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the Midland Christian School Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Midland Christian School Retirement Plan (the “Plan”) provides only general information. The Plan is sponsored by Midland Christian School, Inc. (the “School”). Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective December 1, 1995. The Plan was restated effective January 15, 2022. The Plan is a defined contribution Plan covering substantially all of the employees of the School. Employees are eligible to participate in employer matching contributions when they have completed 1 year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Substitute teachers and employees that normally worked fewer than 20 hours per week are excluded from employer matching contributions. Students are excluded from all types of contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may make pre-tax or Roth contributions up to 100% of eligible compensation, as defined by the Plan, subject to limitations as to amount under the provisions of the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

The School makes discretionary matching contributions up to 6% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participants contributions and rollovers, an allocations of a) the School's matching contributions and b) Plan earnings. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the option to invest in various mutual funds and money market funds. All investments are participant-directed.

Vesting

Participants are vested immediately in their participant contributions plus actual earnings thereon. Vesting in the School's matching contributions to their accounts occurs after completion of three years of service.

Payment of Benefits

At the time of death, disability, termination of service, retirement or upon attainment of age 59 ½, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. The participant's contributions may also be withdrawn for certain hardship situations.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate equal to prime rate plus 1%. Interest rates range from 4.25% to 9.50% on all notes receivable outstanding at August 31, 2024. Principal and interest payments occur ratably through regular payroll deductions over a period not to exceed five years unless the notes receivable were used to purchase a primary residence in which case the note receivable repayment terms may be longer.

Expenses

The Plan expenses are paid by either the Plan or the School, as provided by the Plan document. Expenses that are paid by the School are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board ("FASB"). The FASB sets accounting principles generally accepted in the United States of America ("GAAP").

Contributions

Contributions from Plan participants and the matching contributions from the School are recorded in the year in which the employee contributions are withheld from compensation.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the "exit price").

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

At August 31, 2024 and 2023, one investment represented approximately 21% and 19% of the Plan's total investments, respectively.

**NOTE 3 – INVESTMENTS (Unaudited)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab has provided certification that the financial information included in the financial statements and supplemental schedule as of August 31, 2024 and 2023, and for the year ended August 31, 2024, provided to the Plan is complete and accurate. The information as to investment assets and transactions therein, and investment income included in the accompanying financial statements and supplemental schedule as of August 31, 2024 and 2023, and for the year ended August 31, 2024, is covered by such certification, and has not been audited by independent auditors.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

*Level 1* – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* – Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Money Market Fund

Money market funds are valued using the amortized cost or penny rounding method as permitted by Rule 2a-7 under the Investment Company Act of 1940, which approximates their fair value.

Mutual Funds

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund’s underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (“NAV”) as of August 31, 2024 and 2023. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares sold.

**NOTE 5 – INCOME TAX STATUS**

The Plan is based on the Volume Submitter 403(b) Plan sponsored by FIS Business Systems LLC, which received a favorable opinion letter from the IRS dated March 31, 2017, stating that the Volume Submitter was designed in accordance with the provisions of the IRC. Accordingly, the trust’s net investment income was exempt from income taxes. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

**NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These parties include recordkeeping services.

Certain Plan investments are managed by Schwab. Schwab is the certifying entity of the Plan and, therefore, these transactions qualify as party in interest transactions. Notes receivable from participants are also defined by ERISA as party-in-interest transactions.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their accounts.

**NOTE 8 – SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions become effective subsequent to the Plan year end. Accordingly, there is no material impact to the Plan's 2024 financial statements.

**NOTE 9 – SUBSEQUENT EVENTS**

Management has reviewed subsequent events through June 9, 2025, which is the date the financial statements were ready to be issued.

Effective September 1, 2024, the School changed recordkeepers from Tri-Ad Benefit Plan Administration to Alliance Pension Consultants. The adoption agreement was restated and effective as of September 1, 2024, as a result. Updated Plan provisions include the change to a Safe Harbor Plan and state that employees who normally work less than 20 hours per week will now be eligible for Safe Harbor Match.
