We have performed an audit of the financial statements of ASA Electronics, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended November 30, 2024, and the related notes to the financial statements.

#### Note 1. Plan Description

The following description of ASA Electronics, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of ASA Electronics, LLC (the Company) who have completed six months of service or part-time employees with 1,000 hours of service (as defined). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute a percentage of pre-tax annual compensation as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct these contributions into various investment options offered by the Plan. Participants are automatically enrolled in the Plan at 6% of compensation with an annual 1% increase up to 10%, unless participant has elected otherwise.

The Company may elect to make a discretionary matching contribution based on a percentage of the participant compensation for all participants who have become eligible for deferral elections and were employed at year-end. Discretionary matching contributions were subject to a limit of \$8,000 per participant. For the year ended November 30, 2024, the Company made a matching contribution of approximately \$417,000.

The Company may elect to make a profit-sharing contribution for all participants who have become eligible for deferral elections and were employed at year-end. Discretionary profit-sharing contributions were subject to a limit of \$5,000 per participant. There were no profit-sharing contributions during the year ended November 30, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. A participant's account is charged an administrative fee for processing benefit payments as defined by the plan document. The benefit to which a participant, or beneficiary, is entitled is the vested benefit that can be provided from the participant's account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon, if any, is based on years of continuous service. A participant is 100% vested in matching and discretionary contributions after five years of credited service.

**Payment of benefits:** Upon termination of service, a participant may elect to receive a lump-sum amount or installments equal to the participant's vested interest in the account. In-service withdrawals are not permitted unless the participant has met certain hardship conditions or have reached retirement age. Under the Plan, participants, or their beneficiaries, are entitled to 100% of their account balance upon death or disability. Benefit payments are recorded when paid.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Plan Sponsor and, therefore, are not reflected in the Plan's financial statements.

**Forfeitures:** The nonvested portion of terminated participants' accounts plus earnings thereon is forfeited and will be used to reduce the employers' matching contributions or pay administrative expenses. During the year ended November 30, 2024, approximately \$3,300 of forfeited participant accounts were used to pay for Plan expenses. At November 30, 2024 and 2023, approximately \$8,200 and \$12,300, respectively, of forfeitures were available for future use.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Contributions:** Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Fair value measurements:** Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Shares of registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common collective trusts:** Valued at a daily net asset value (NAV) per unit held by the Plan as quoted by the funds. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is the basis for current transactions. Participant transactions may occur daily. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through May 30, 2025, the date the financial statements were available to be issued.

#### Note 5. Plan Termination

Although they have not expressed any intent to do so, the Company has the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination participants will become 100% vested in their accounts.

#### Note 6. Income Tax Status and Uncertain Tax Position

The Plan is an adopter of a non-standardized prototype plan by Fidelity. As such, no individual determination letter is available. The Internal Revenue Service has determined that the prototype plan was designed in accordance with applicable sections of the Internal Revenue Code (Code). The Plan has been amended since that determination. However, the Plan Administrator believes that the Plan is designed and is being operated in compliance with applicable requirements of the Code.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2020.

#### Note 7. Related-Party Transactions

Certain plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee amounted to approximately \$12,000 for the year ended November 30, 2024.

#### Note 1. Plan Description

The following description of ASA Electronics, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of ASA Electronics, LLC (the Company) who have completed six months of service or part-time employees with 1,000 hours of service (as defined). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute a percentage of pre-tax annual compensation as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct these contributions into various investment options offered by the Plan. Participants are automatically enrolled in the Plan at 6% of compensation with an annual 1% increase up to 10%, unless participant has elected otherwise.

The Company may elect to make a discretionary matching contribution based on a percentage of the participant compensation for all participants who have become eligible for deferral elections and were employed at year-end. Discretionary matching contributions were subject to a limit of \$8,000 per participant. For the year ended November 30, 2024, the Company made a matching contribution of approximately \$417,000.

The Company may elect to make a profit-sharing contribution for all participants who have become eligible for deferral elections and were employed at year-end. Discretionary profit-sharing contributions were subject to a limit of \$5,000 per participant. There were no profit-sharing contributions during the year ended November 30, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. A participant's account is charged an administrative fee for processing benefit payments as defined by the plan document. The benefit to which a participant, or beneficiary, is entitled is the vested benefit that can be provided from the participant's account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon, if any, is based on years of continuous service. A participant is 100% vested in matching and discretionary contributions after five years of credited service.

**Payment of benefits:** Upon termination of service, a participant may elect to receive a lump-sum amount or installments equal to the participant's vested interest in the account. In-service withdrawals are not permitted unless the participant has met certain hardship conditions or have reached retirement age. Under the Plan, participants, or their beneficiaries, are entitled to 100% of their account balance upon death or disability. Benefit payments are recorded when paid.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Plan Sponsor and, therefore, are not reflected in the Plan's financial statements.

**Forfeitures:** The nonvested portion of terminated participants' accounts plus earnings thereon is forfeited and will be used to reduce the employers' matching contributions or pay administrative expenses. During the year ended November 30, 2024, approximately \$3,300 of forfeited participant accounts were used to pay for Plan expenses. At November 30, 2024 and 2023, approximately \$8,200 and \$12,300, respectively, of forfeitures were available for future use.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Contributions:** Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Fair value measurements:** Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Shares of registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common collective trusts:** Valued at a daily net asset value (NAV) per unit held by the Plan as quoted by the funds. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is the basis for current transactions. Participant transactions may occur daily. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through May 30, 2025, the date the financial statements were available to be issued.
