INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the
State Employees Credit Union of New Mexico
Cash Balance Defined Benefit Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the State Employees Credit Union of New Mexico Cash Balance Defined Benefit Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the statement of accumulated plan benefits as of August 31, 2023, and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of August 31, 2024, and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for the purpose of additional analysis and are not a required part of the financial statements, but are supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS AUGUST 31, 2024 AND 2023

Note 1 – Description of the Plan

General

State Employees Credit Union of New Mexico Cash Balance Defined Benefit Plan and Trust (the Plan) was established by State Employees Credit Union of New Mexico (the Credit Union) on September 1, 1973. The Plan is a defined benefit pension plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

Administration

The Credit Union is the Plan Sponsor and named Plan Administrator. The Plan Administrator is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and fees, and reports to the Board of Directors. The Plan's Investment Custodian is Matrix Trust Company. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. The Plan's Trustees are certain members of executive management. The Company has also retained CUNA Mutual Financial Group Inc. (CMFG) to provide participant recordkeeping and administration services.

Eligibility

The Plan covers substantially all employees of the Credit Union. Employees are eligible to participate in the Plan after they have completed six months of credited service and have attained the age of 20.

Benefits:

Normal Retirement Benefits: Employees with five or more years of service with employment that began prior to January 1, 2012, and considered a "grandfathered participant" are entitled to annual pension benefits beginning at normal retirement age (65) equal to 55% of their final sixty months highest cumulative average annual compensation with a prorated reduction for service less than 16 years. The Plan permits early retirement at age 55 with at least 5 years of service.

If the employee is not a "grandfathered participant," the normal retirement benefit will be equal to the actuarial equivalent of their "hypothetical account." All hypothetical allocations will be taken into account through the determination date, and all interest credits will be taken into account through their normal retirement age.

A participant's hypothetical account is the sum of the following amount under (a) and (b) below as of the date of determination:

- a) For each Plan year, the eligible employee will have their hypothetical account credited for that Plan year with a hypothetical allocation equal to 5% of Plan year compensation. The employee must complete at least one (1) year of service during the Plan year to be eligible to receive the hypothetical allocation described above. For purposes of determining employee eligibility to receive a hypothetical allocation, a year of service means a Plan year during which the employee completes 1,000 hours of service.

b) For each month during the determination period, a participant's hypothetical account shall be credited, whether or not the participant remains an employee, with hypothetical interest credit determined by multiplying the dollar amount representing the balance of the hypothetical account as of the beginning of the Plan year, including all previous hypothetical allocations and interest credits, plus hypothetical allocation for such Plan year minus any distributions made during the Plan year, by 1/12 of the applicable interest rate (annual rate of interest on 30-year treasury securities, as reported by the Internal Revenue Service (IRS) and determined as of the second calendar month preceding the first day of the Plan year). No interest will be credited for any period after payment of the employee's accrued benefit commences.

Participants' hypothetical accounts also receive investment credits at the end of every month. The amount of the investment credit is tied to the average of the annual yields on 30-year treasury securities and is adjusted annually as described in the plan document. For the plan years ended August 31, 2024 and 2023, the interest rate used was 3.27% and 3.10%, respectively.

Employees may elect to receive the value of their accumulated benefits by one of several options (lump-sum, life annuity, life annuity with certain terms, and joint and survivor annuity). For each employee electing a life annuity, payments will not be less than the greater of (a) the employee's accumulated contributions plus interest or (b) an annuity for five years. If employees terminate, they forfeit the amount that is not vested.

Early Retirement Benefits: Early retirement benefits are equal to the participant's vested accrued benefit reduced by 5/9 of 1% for each of the first 60 complete calendar months, and 5/18 of 1% for each complete calendar month in excess of 60 months that the early retirement date precedes the normal retirement date, except that if benefits commence prior to age 55, early retirement benefit shall equal the actuarial equivalent of the vested accrued benefit.

Death and Disability Benefits: The death benefit is the "actuarial equivalent of the vested accrued benefit" as defined in the Plan document. Unmarried participants may designate a beneficiary on a form provided by the Plan Administrator. The disability benefits are equal to the early retirement benefit without regard to age and service requirements. Disability shall be determined under the Social Security Act.

Vesting: Participants that terminate employment prior to their normal retirement age for reasons other than death, disability, or early retirement are entitled to a percentage of their accrued benefits as defined in the vesting schedule below. However, participants are 100% vested as a result of death, disability, or if employed on or after their early or normal retirement age as defined by the Plan document. A participant is 100% vested after seven years of service and three for a non-grandfathered participant. "Grandfathered Participant" means any employee whose continuous employment began prior to January 1, 2012, and who is not rehired on or after January 1, 2012.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 6 for discussion of fair value measurements.

The purchase and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated Plan benefits are those future periodic payments that are attributable under the Plan's provisions to the service participants have rendered. Accumulated Plan benefits include benefits expected to be paid to: (i) retired or terminated vested participants or their beneficiaries, (ii) beneficiaries of participants eligible to retire who have died, and (iii) present participants or their beneficiaries. Benefits payable under all circumstances (retirement, death, and termination of employment) are included in the computation to the extent they are considered attributable to employee service rendered at the valuation date.

The actuarial present value of accumulated Plan benefits is determined by an actuary from CUNA Mutual Group and is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment resulting from death, disability, withdrawal, or retirement between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of and for the year ended August 31, 2023 were (i) investment return of 4.00% per annum, (ii) Mortality; RP-2014 combined tables projected to 2023 by Scale MP 2021, (iii) salary increases 4.50%, and (iv) withdrawal rates based on T7 turnover table.

Actuarial assumptions are based on the presumption that the Plan will continue indefinitely. If the Plan were terminated, different actuarial assumptions might be applicable in determining the actuarial present value of accumulated Plan benefits. The computations of the actuarial present value of accumulated Plan benefits were made as of September 1, 2023. Had the valuation been performed as of August 31, 2023, there would be no material differences.

Payment of Benefits

Benefits payments to participants and beneficiaries are recorded at the time of distribution.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including June 10, 2025, which is the date the financial statements were available to be issued.

Effective September 1, 2024, the Plan was restated to have no adjustments to base compensation. In addition, effective March 1, 2025, the Plan approved an amendment to exclude leased and part-time and seasonal employees from participating on the Plan.

Note 3 – Unaudited Information Certified by the Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Matrix Trust Company, the custodian of the Plan, as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying Statements of Net Assets Available for Benefits as of August 31, 2024 and 2023,
2. All investment activity reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended August 31, 2024 and 2023,
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of August 31, 2024.

Note 4 – Funding Policy and Administrative Fees

The Plan is funded by contributions made by the Credit Union. The Credit Union's funding policy is to, at a minimum, make contributions to the Plan sufficient to meet the minimum funding requirements of ERISA, plus such additional amounts, if any, as actuarially determined. No minimum contribution was required for the years ended August 31, 2024 or 2023 as recommended by the Plan's actuary. There were no contributions made to the Plan for the year ended August 31, 2024. The Credit Union made a contribution of \$2,000,000 to the Plan for the year ended August 31, 2023.

The Plan's expenses are paid either by the Plan or the Credit Union, as provided by the Plan document. Expenses that are paid directly by the Credit Union are excluded from these financial statements. Certain expenses, if any, incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation/(depreciation) of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

Although it has not expressed any intention to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Note 5 – Plan Termination

In the event the Plan terminates, the rights of all participants to benefits accrued to the date of such termination or discontinuance, to the extent funded, shall be nonforfeitable. Accordingly, the net assets of the Plan will be allocated in accordance with the Plan document and as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Benefits to former participants who have retired under the Plan prior to its termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for the accumulated benefit obligation and may also depend on the financial condition of the Credit Union and the level of benefit guaranteed by the PBGC.

Note 6 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of August 31, 2024 and 2023.

Registered investment companies: Valued at the quoted market price available on an active market at year end.

Guaranteed account: A general account insurance contract with interest and principal guaranteed by CMFG and backed by all the general account assets of CMFG. CMFG provides contractual protection against a change in the participant's account value due to interest rate volatility.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Investment Contract

The Plan has a deposit administration group annuity contract with CMFG, where the underlying investment is a guaranteed account. CMFG maintained the contributions in an unallocated fund to which it added interest at 1.95% and 1.90% during the years ended August 31, 2024 and 2023, respectively. Participant withdrawals and administrative expenses are reduced from the account. The interest rate is guaranteed for each specific year and is subject to change each preceding year.

Note 8 – Plan Amendment and Tax Status

The Plan utilizes a volume submitter Plan, which has been filed with the IRS and has received a determination letter dated February 28, 2023, that the Plan and the related trust are designed with applicable requirements of the Internal Revenue Code (IRC). The Credit Union has elected not to apply for an individual IRS determination letter upon adoption of the Plan nor on any subsequent amendments. The Plan Administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

Effective September 1, 2019 the Plan was restated to add a bifurcated distributions option. Effective November 1, 2022, the plan was amended to update the post-retirement interest for the actuarial assumptions.

The Plan permitted provisions of SECURE Act 2.0 during the year ended August 31, 2024. Written amendments to the Plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidelines.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the Department of Labor (DOL) or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Party-in-Interest Transactions

Plan investments consist of a collective investment trust managed by CMFG. CMFG is the sponsor of the collective investment trust and the record keeper of the Plan as defined by the Plan; therefore, transactions in this investment qualify as party-in-interest transactions as defined by ERISA. Fees paid by the Plan for certain administrative expenses were approximately \$96,000 and \$91,000 for the years ended August 31, 2024 and 2023, respectively.

Note 10 – Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits. Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
