We have performed an audit of the accompanying financial statements of North Fork Holdings, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation available for benefits as of May 24, 2024, and the related statement of changes in net assets in liquidation available for benefits for the period from January 1, 2024 to May 24, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of May 24, 2024 and the period from January 1, 2024 to May 24, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

As discussed in Note 3 to the financial statements, the Trustees of North Fork Holdings, Inc. 401(k) Retirement Plan approved a plan of liquidation in November 2023, and management determined liquidation is imminent. As a result, the Plan's financial statements are prepared under the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS
MAY 24, 2024 AND DECEMBER 31, 2023

(1) DESCRIPTION OF PLAN:

The following description of North Fork Holdings, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The financial statements were available to be issued on May 28, 2025, with subsequent events being evaluated through this date.

General -

The Plan is a defined contribution plan established January 1, 2010, that covers substantially all employees of North Fork Holdings, Inc. dba The Shelby Group (the Company). All employees of the Company are eligible to participate, except those covered by a collective bargaining agreement and nonresident aliens.

The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In November 2023, the Company was acquired by Accenture and the Plan was terminated prior to close. All plan assets were liquidated from the terminated Plan as elected distributions to participants or rollovers to the Accenture retirement plan by May 2024.

Contributions -

Participants may contribute up to 100 percent of their compensation as defined by the Plan, limited to the maximum amount allowable under the IRS. Some or all of a participant's contribution may be designated as a Roth contribution. Roth contributions are made on an after-tax basis; however, such contributions will not be taxed at the time of distribution. All participants who were eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the Plan year were eligible for catch-up contributions. Participants may also make rollover contributions from other qualified plans.

Company matching contributions are defined as 25% of the first 6% of a participant's pre-tax and post-tax contributions as defined by the Plan document. Contributions are allocated to a participant's account based on the participant's investment elections.

The Company may make a discretionary contribution to the Plan for a profit-sharing contribution. The participant's share of the profit-sharing contribution, if any, will be allocated to the participant's account based on the ratio that the participant's plan compensation bears to the total plan compensation of all participants eligible for a share of the contribution. For the period from January 1, 2024 to May 24, 2024, no profit-sharing contribution was approved by the Company.

(1) DESCRIPTION OF PLAN: (Continued)

Participants' Accounts -

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily. Contributions are subject to certain limitations.

Each participant's account is credited with the participant's contribution and with an allocation of the Company's contributions and Plan earnings. Plan earnings allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

As a result of the decision to terminate the Plan during 2023, all participants became fully vested in their account balances.

Participant Loans -

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits -

On termination of service due to death, disability, or retirement, a participant will become fully vested in their account. For termination of service for other reasons, a participant is entitled to receive the value of the vested interest in his or her account. If the participant's vested account balance has never been more than \$1,000, payment is made in a lump sum distribution. In-service withdrawals are available to participants who meet certain hardship requirements or attain age 59-1/2.

Forfeited Accounts -

Forfeited balances of terminated participants' non-vested accounts are used to reduce employer contributions or expenses. Forfeited non-vested accounts totaled \$-0- at May 24, 2024 and December 31, 2023. No forfeitures were used to reduce employer contributions or expenses during the period from January 1, 2024 to May 24, 2024.

(2) SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the Plan are prepared under the liquidation method of accounting.

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income -

Investments are reported at fair value. Shares of registered investment companies are valued based on the quoted market prices of the shares held by the Plan at year end. Gain or loss recognized from the disposition of an investment held at the beginning of the year is equal to the difference between the market value of the disposed asset at the beginning of the year and the proceeds from disposition. Gain or loss realized from the disposition of an investment acquired during the year is equal to the difference between the cost and the proceeds from disposition. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation or depreciation in the market value of an investment held both at the beginning and end of the year is equal to the difference between the market value at the beginning and end of the year. Appreciation or depreciation in the market value of an investment acquired during the year and held at the end of the year is equal to the difference between the cost and the market value of the investment at the end of the year.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balances plus accrued interest, if any.

Payment of Benefits -

Benefits are recorded when paid.

Administrative Expenses -

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid by the Company. Administrative expenses of \$27,552 were paid by the Plan during the period from January 1, 2024 to May 24, 2024.

(3) PLAN TERMINATION:

In November 2023, management approved the termination of the Plan. As noted in Note 1, all plan assets were liquidated from the Plan as distributions to participants or direct rollovers into the Accenture Retirement Plan with an effective date in May 2024.

(4) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) FAIR VALUE MEASUREMENTS: (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) INCOME TAXES:

The Plan has adopted the Ascensus LLC mass-submitter form of a prototype plan. The Plan has received a favorable opinion from the Internal Revenue Service (IRS), dated January 1, 2018, which states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 24, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(6) CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at May 24, 2024, and net appreciation/depreciation in fair value of investments, interest and dividends for the period from January 1, 2024 to May 24, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC (the trustee of the Plan).

(7) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are funds managed by Ascensus, LLC. Ascensus, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Participants covered under the Plan are considered to be parties-in-interest. Participant loans in the amount of \$-0- and \$16,716 at May 24, 2024 and December 31, 2023, respectively, are considered to be party-in-interest investments.

The Company is the Plan Sponsor and pays certain expenses on behalf of the Plan. In addition, certain employees of the Company are responsible for the administration of the Plan. These employees do not receive compensation for their services. Fees for plan administrative services rendered during the year and paid by the Company are based on customary and reasonable rates for such services.


