INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
BlueRidge Fiber Solutions Employee Health Benefit Plan

Opinion

We have audited the accompanying financial statements of BlueRidge Fiber Solutions Employee Health Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits (modified cash basis) as of August 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of BlueRidge Fiber Solutions Employee Health Benefit Plan (modified cash basis) as of August 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the years then ended, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BlueRidge Fiber Solutions Employee Health Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of BlueRidge Fiber Solutions Employee Health Benefit Plan (Plan) provides only general information. Participants and others should refer to the plan document and summary plan description (SPD) for a more complete description of the Plan's provision.

General - The Plan provides health and other benefits to employees, and their dependents, of BlueRidge Fiber Solutions, LLC (Plan sponsor) who participate. The name of the plan sponsor and the related name of the Plan was changed effectively August 1, 2024 and on March 1, 2022 prior to that. The former sponsor name was Superior Fibers LLC and the Plan was Superior Fibers LLC Employee Health Benefit Plan. The Plan was established September 1, 2009 and is self-funded for most claims. A stop loss insurance policy is maintained which reimburses the Plan in the event claims exceed \$160,000 per person with a corridor option of \$95,000. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Contributions are made by participants at rates determined by the Plan Administrator for the benefits desired. Contributions are also received by eligible, inactive employees under the COBRA provisions of Federal law. The Plan sponsor contributes the amount necessary, in excess of the participants' contributions, to timely fund all claims as they are presented for payment.

Benefits - The Plan provides health benefits (medical, hospital, surgical, major medical, etc.), dental, vision and prescription drug benefits to employees (and eligible dependents) who work at least 30 hours per week and retirees who are age 62 at retirement date and have 5 years vested service and are not part of any Medicare program. The Plan also provides benefits to participants during periods of disability and layoff as described further in the SPD. The Plan also provides life insurance and long-term disability benefits to employees by purchasing insurance contracts. These contracts are purchased annually (June) and contain experience rating pricing. Accordingly, these contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium, surplus or deficit.

Administration - The Plan sponsor provides and pays for management and administrative personnel who perform various functions for the Plan.

NOTE 2 - ACCOUNTING POLICIES

Basis of Accounting

These financial statements have been prepared using the modified cash basis of accounting. Under the modified cash basis contributions and other revenues are recognized when received and claims and other expenses are recognized when paid. Amounts incurred but not yet paid at year-end are reflected as benefit obligations payable.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts in the financial statements and related footnotes. Actual results could differ from those estimates.

NOTE 2 - ACCOUNTING POLICIES (Continued)

Experience-rated contracts

For experience-rated contracts, premium surpluses (if any) are recorded as a receivable from the insurance company. If the insurance company requires payment of additional premiums due to a premium deficit, an obligation for the additional premiums is included in benefit obligations.

NOTE 3 - BENEFIT OBLIGATIONS

Benefit obligations are determined and recorded with assistance from the Third Party Administrator. The obligations for benefits reported are based on obligations incurred but not yet paid at year-end.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 was passed into law and affects Plans providing prescription drug benefits to retirees. The Plan does not offer benefits to retirees and therefore is not affected by these provisions.

NOTE 4 - PARTY IN INTEREST

The Plan receives contributions from the Plan sponsor as discussed in Note 1. All funds contributed were used to maintain the plan and provide benefits for participants in the Plan in accordance with the provisions of the Plan Document.

NOTE 5 - PLAN TERMINATION

Although the Plan sponsor expects the Plan to be continued indefinitely, it reserves the right to terminate the Plan at any time by action of the Plan sponsor's Board. If such termination occurs, it will be done in accordance with rules and regulations as promulgated under the Employee Retirement Income Security Act of 1974, as amended.

NOTE 6 - TAX STATUS

The Plan is not qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and, as such, is not exempt from income taxes. However, the Plan is operated in a manner whereby any tax effects are borne by the Plan Sponsor, therefore no tax provision is required.

The Plan does not believe there are currently any tax positions which have a reasonable possibility of change from taxing authorities. Accrued interest and penalties with uncertain tax positions, if any, are recognized as part of administrative expenses. There were no taxes or accrued interest or penalties related to the income tax position of the Plan as of August 31, 2024.

The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements reflect information required by *FASB Accounting Standards Codification 965-30, Plan Benefit Obligations*, and were prepared using the modified cash basis of accounting. However, the Plan continues to utilize the cash method of reporting for their 5500 filing. Accordingly, the effects of benefit obligations are not included in the Form 5500.

NOTE 8 - AMENDMENTS & SUBSEQUENT EVENTS

The former plan sponsor was acquired by BlueRidge Fiber Solutions, LLC who became the new plan sponsor. Accordingly, the plan was amended to change the name of the Plan to BlueRidge Fiber Solutions Employee Health Benefit Plan as well as the related plan documents and summary plan descriptions. The change was effective August 1, 2024. This change did not substantially modify the terms and benefits available through the Plan.

Subsequent events were evaluated through June 2, 2025, which is the date the financial statements were available to be issued.
